## TENTATIVE FORECAST OF THE PROGRAMME OF WORK OF THE SECURITY COUNCIL FOR THE MONTH OF OCTOBER 2010

#### For information only/not an official document

This tentative forecast of the programme of work of the Security Council has been prepared by the Secretariat for the President of the Council. The forecast covers in particular those matters that may be taken up during the month pursuant to earlier decisions of the Council. The fact that a matter is or is not included in the forecast carries no implication that it will or will not be taken up during the month: the actual programme of work will be determined by developments and the views of members of the Council.

## TENTATIVE FORECAST OF THE PROGRAMME OF WORK OF THE SECURITY COUNCIL FOR THE MONTH OF OCTOBER 2010

## AFRICA

#### Chad, the Central African Republic and the subregion – MINURCAT Resolution 1923 (2010) of 25 May 2010

Para. 25: requests the Secretary-General to continue to keep the Security Council regularly informed and requests him to provide a report <u>by 15 October 2010</u> on the security and humanitarian situation, including movements of refugees and internally displaced persons in eastern Chad and the north-eastern Central African Republic, on the progress in the implementation of the relevant agreements, on the progress towards the fulfilment by the Government of Chad of the tasks and benchmarks set out in paragraphs 2 and 3 of this resolution, including on the measures adopted in response to possible shortcomings identified by the joint high-level Working Group referred to in paragraph 4 of this resolution, and on the implementation of the mandate of the United Nations Mission in the Central African Republic and Chad (MINURCAT), and stresses that the Security Council will monitor closely the relevance of the mandate of MINURCAT and review it if necessary.

The report of the Secretary-General is expected to be issued by 15 October 2010.

## Côte d'Ivoire – UNOCI

#### Resolution 1933 (2010) of 30 June 2010

Para. 28: requests the Secretary-General to inform the Security Council of the publication of the final voters list and to provide to it a midterm report <u>no later than 22 October 2010</u> on the situation on the ground, the implementation of this resolution, and on the revised benchmarks referred to in paragraph 26 of the resolution and which includes possible adjustments in the structure and strength of the United Nations Operation in Côte d'Ivoire (UNOCI).

Para. 22: requests the Secretary-General to continue to include in his reports relevant information on progress on the promotion and protection of human rights and international humanitarian law as well as on the strengthening of the rule of law, including on ending impunity in Côte d'Ivoire, with special attention to violence committed against children and women, and on progress on gender mainstreaming throughout UNOCI and all other aspects relating to the situation of women and girls, especially in relation to the need to protect them from sexual and gender-based violence.

Para. 25: underscores the importance that the military and police concepts of operations and the rules of engagement be brought fully in line with the provisions of this resolution and requests the Secretary-General to report on them to the Security Council and to troop- and police-contributing countries.

The report of the Secretary-General is expected to be issued by 22 October 2010.

#### Côte d'Ivoire – sanctions

Resolution 1893 (2009) of 29 October 2009

Para. 1: decides to renew <u>until 31 October 2010</u> the measures on arms and the financial and travel measures imposed by paragraphs 7 to 12 of resolution 1572 (2004) and the measures preventing the importation by any State of all rough diamonds from Côte d'Ivoire imposed by paragraph 6 of resolution 1643 (2005).

The arms embargo and other measures will expire on 31 October 2010.

Para. 2: decides to review the measures renewed in paragraph 1 of the resolution in light of the progress achieved in the implementation of the key steps of the peace process and of the progress of the electoral process by the end of the period mentioned in paragraph 1.

The Security Council is expected to review the sanctions and arms embargo by <u>31 October 2010</u>.

## Côte d'Ivoire – Group of Experts

Resolution 1893 (2009) of 29 October 2009

Para. 12: requests the Group of Experts to provide a final written report to the Security Council, through the Committee established pursuant to resolution 1572 (2004), <u>15 days</u> <u>before the end of its mandated period</u>, on the implementation of the measures imposed by paragraphs 7, 9 and 11 of resolution 1572 (2004) and paragraph 6 of resolution 1643 (2005), as well as recommendations in this regard, and to include in its report specific information on persons who deny it access to weapons, ammunition and related materiel.

The report of the Group of Experts is expected to be issued by 15 October 2010.

Para. 10: decides to extend the mandate of the Group of Experts until 31 October 2010.

The mandate of the Group of Experts will expire on 31 October 2010.

## Democratic Republic of the Congo - MONUSCO

Resolution 1925 (2010) of 28 May 2010

Para. 7: decides to keep under continuous review the strength of the United Nations Organization Stabilization Mission in the Democratic Republic of the Congo (MONUSCO) on the basis of assessments from the Secretary-General and the Government of the Democratic Republic of the Congo as provided to the Secretary-General on progress towards the implementation of the objectives presented in paragraph 6 of this resolution and to that end requests the Secretary-General to report regularly on these assessments to the Security Council, through the reports mentioned in paragraph 20 below, to enable the Council to make informed decisions and seize opportunities for reconfiguration.

Para. 20: requests the Secretary-General to report <u>by 11 October 2010</u> on the progress on the ground, in particular in light of the assessment discussions with the Congolese authorities mentioned in paragraph 7 above, and on the implementation of this resolution with a view to progressively adapting the United Nations presence in the Democratic Republic of the Congo, and recalling the statement of its President of 5 August 2009 (PRST/2009/24), requests the Secretary-General to provide in his reports an indication of progress towards achieving a coordinated United Nations approach in-country, and in particular on critical gaps to achieving peacebuilding objectives alongside the mission.

Para. 22: requests the Secretary-General to elaborate the concept of operation and rules of engagement of MONUSCO in line with the provisions of this resolution and to report on this to the Security Council and troop-contributing countries.

The report of the Secretary-General is expected to be issued by 11 October 2010.

## Democratic Republic of the Congo – protection of civilians

S/PRST/2010/17 of 17 September 2010

The Security Council expresses its support for the work of the Special Representative of the Secretary-General on Sexual Violence in Conflict, and encourages her to regularly interact with MONUSCO's Sexual Violence Unit to coordinate United Nations response and monitor the implementation of the United Nations Comprehensive Strategy to Combat Sexual Violence in the Democratic Republic of the Congo. The Security Council states that it looks forward to her trip to the country and requests a briefing upon her return.

The Security Council is expected to hear a briefing from the SRSG on Sexual Violence in Conflict <u>during October 2010</u>.

The Security Council takes note with interest of the recommendations made by the Department of Peacekeeping Operations (DPKO) to enhance efforts to protect and defend civilians and improve MONUSCO's impact in the Democratic Republic of the Congo.

At consultations of the whole held on 7 September 2010, members of the Council agreed that after receiving recommendations from DPKO for enhancing efforts to protect and defend civilians, the Council would meet to consider these recommendations.

The Security Council is expected to meet to consider the DPKO recommendations <u>during</u> <u>October 2010</u>.

## Democratic Republic of the Congo – sanctions

Resolution 1896 (2009) of 7 December 2009

Para. 6: requests the Group of Experts to report to the Security Council in writing, through the Committee established pursuant to resolution 1533 (2004), <u>before 20 October 2010</u>.

The report of the Group of Experts is expected to be submitted by 20 October 2010.

## Guinea-Bissau – UNIOGBIS

Resolution 1876 (2009) of 26 June 2009

Para. 6: requests the Secretary-General to develop a strategic workplan with appropriate benchmarks to measure and track progress on the implementation of the mandate, described in paragraph 3 of the resolution, of the United Nations Integrated Peacebuilding Office in Guinea-Bissau (UNIOGBIS), and to report on its implementation in accordance with paragraph 14 of the resolution.

Para. 14: requests the Secretary-General to keep the Security Council regularly informed <u>every 4 months</u> on the implementation of this resolution.

The report of the Secretary-General is expected to be issued by 31 October 2010.

### S/PRST/2010/15 of 22 July 2010

Last para.: requests the Secretary-General to brief the Security Council, as appropriate, on progress made in addressing these issues as well as what further action may be required to support their continued implementation.

#### Somalia – support to AMISOM

#### Resolution 1910 (2010) of 28 January 2010

Para 3: requests the African Union Mission to Somalia (AMISOM) to continue to assist the Transitional Federal Government in the development of the Somali Police Force and the National Security Force, and to assist the integration of Somali units trained by other Member States or organizations inside and outside Somalia.

Para. 4: requests the Secretary-General to continue to provide a logistical support package for AMISOM called for by resolution 1863 (2009), comprising equipment and services, including public information support, but not including the transfer of funds, as described in the Secretary-General's letter (S/2009/60) to the Security Council until 31 January 2011, ensuring the accountability and transparency of expenditure of United Nations funds.

Para. 5: encourages Member States to support AMISOM and the Somali Security Sector Institutions through the provision of appropriate and necessary equipment.

Para. 7: requests the Secretary-General to continue to provide technical and expert advice to the African Union in the planning and deployment of AMISOM through the existing United Nations planning team in Addis Ababa.

The Security Council is expected to review support to AMISOM during October 2010.

#### Somalia – piracy at sea

#### Resolution 1897 (2009) of 30 November 2009

Para. 17: requests the Secretary-General to report to the Security Council <u>within 11 months</u> of adoption of this resolution on the implementation of this resolution and on the situation with respect to piracy and armed robbery at sea off the coast of Somalia.

The report of the Secretary-General is expected to be issued by 31 October 2010.

#### The Sudan – UNMIS

#### Resolution 1919 (2010) of 29 April 2010

Para. 2: requests the Secretary-General to continue reporting to the Security Council <u>every</u> <u>3 months</u> on the mandate implementation of the United Nations Mission in the Sudan (UNMIS), implementation progress of the Comprehensive Peace Agreement (CPA), and respect for the ceasefire.

Para. 3: requests the Secretary General to provide in his <u>quarterly reports</u> information including (1) a detailed plan of measures UNMIS is taking to support the referenda and popular consultation processes, consistent with paragraph 7 of this resolution, including lessons learned from the 2010 elections, (2) the status of United Nations engagement with the parties to the CPA and the parties' progress concerning the critical tasks that will need to be accomplished post-referendum and, as appropriate, information on (3) UNMIS' planning in

consultation with the parties concerning the United Nations presence in the Sudan post Interim period.

Para. 5: requests the Secretary General to include in his UNMIS <u>quarterly reports</u>, information on cooperation between United Nations missions in dealing with the threats of the Lord's Resistance Army (LRA).

Para. 22: requests the Secretary-General to report on and assess the progress in meeting benchmarks in each <u>quarterly report</u>, as well as any consequent recommendations regarding UNMIS' configuration.

Para. 23: requests the Secretary-General to report on progress against the concepts and rules to the Security Council and troop-contributing countries in <u>each quarterly report</u>, and to provide the Security Council in the same report specific updates on the security situation in the Mission's area of responsibility.

The report of the Secretary-General is expected to be issued during October 2010.

#### The Sudan – UNAMID

#### Resolution 1935 (2010) of 30 July 2010

Para. 8: requests the Secretary-General to continue reporting to the Security Council <u>every</u> <u>90 days</u> on progress made towards implementing the mandate of the African Union-United Nations Hybrid Operation in Darfur (UNAMID) across Darfur, including on progress towards and obstacles to the implementation of the strategy referred to in paragraph 4 above, also including an assessment of progress against the benchmarks set out in Annex II of the report of the Secretary-General of 16 November 2009 as well as on progress on the political process, the security and humanitarian situation, including in the IDP sites and refugee camps, and early recovery and all parties compliance with their international obligations.

Para. 20: requests the Secretary-General periodically to review and update the concept of operations and rules of engagement of UNAMID in line with the mission's mandate under relevant Security Council resolutions and to report, as part of the reports referred to in paragraph 8 above, on this to the Security Council and troop-contributing countries.

The report of the Secretary-General is expected to be issued during October 2010.

## The Sudan – Panel of Experts

Resolution 1891 (2009) of 13 October 2009

Para.1: decides to extend <u>until 15 October 2010</u> the mandate of the Panel of Experts.

The mandate of the Panel of Experts will expire on 15 October 2010.

Para. 2: requests the Panel of Experts to provide to the Security Council a final report with its findings and recommendations <u>no later than 30 days prior to termination of its mandate</u>.

Para. 3: requests the Panel of Experts to assess in its final report progress towards reducing violations by all parties of the measures imposed by paragraphs 7 and 8 of resolution 1556 (2004) and paragraph 7 of resolution 1591 (2005), and progress towards removing impediments

to the political process, threats to stability in Darfur and the region and other violations of the above-mentioned resolutions.

The report of the Panel of Experts is expected to be before the Security Council <u>during October</u> <u>2010</u>.

#### Security Council mission to Africa

The Security Council is expected to hold a briefing on its mission to Africa <u>during</u> October 2010.

## Peace and security in Africa – support for AU peacekeeping

<u>S/PRST/2009/26 of 26 October 2009</u> Last para.: requests the Secretary-General to submit a progress report <u>no later than</u> 26 October 2010.

The report of the Secretary-General is expected to be issued by 26 October 2010.

#### AMERICAS

#### Haiti – MINUSTAH

#### Resolution 1892 (2009) of 13 October 2009

Para. 25: requests the Secretary-General to report to the Security Council on the implementation of the mandate of the United Nations Stabilization Mission in Haiti (MINUSTAH) not later than 45 days prior to its expiration.

#### Resolution 1927 (2010) of 4 June 2010

Para. 2: requests the Secretary-General to include <u>in his upcoming report</u> to the Council an assessment of the implementation of resolution 1908 and the present resolution.

Para. 6: Underscores the importance that the planning documents for the military and police components, such as the concept of operations and rules of engagement, be regularly updated, as appropriate, and be in line with the provisions of all relevant resolutions of the Security Council, and requests the Secretary-General to report on them to the Security Council and troop- and police-contributing countries

The report of the Secretary-General dated 1 September 2010 (S/2010/446) is before the Security Council.

#### Resolution 1892 (2009) of 13 October 2009

Para. 1: decides to extend the mandate of MINUSTAH <u>until 15 October 2010</u>, with the intention of further renewal.

The MINUSTAH mandate will expire on 15 October 2010.

## ASIA

## Afghanistan – ISAF

<u>Resolution 1890 (2009) of 8 October 2009</u> Para. 1: decides to extend the authorization of the International Security Assistance Force (ISAF) for a period of 12 months beyond 13 October 2009.

The authorization of ISAF will expire on 13 October 2010.

## Middle East (Lebanon) - resolution 1559 (2004)

S/PRST/2004/36 of 19 October 2004

Requests the Secretary-General to report to the Security Council <u>every 6 months</u> on the implementation by the parties of resolution 1559 (2004).

The Secretary-General's report is expected to be issued during October 2010.

## Middle East – Lebanon (resolution 1701 (2006))

Resolution 1937 (2010) of 30 August 2010

Para. 10: requests the Secretary-General to continue to report to the Security Council on the implementation of resolution 1701 (2006) <u>every 4 months</u>, or at any time as he deems appropriate.

The report of the Secretary-General is expected to be issued by 31 October 2010.

#### The situation in the Middle East, including the Palestinian question Resolution 1322 (2000) of 7 October 2000

Para. 7: invites the Secretary-General to continue to follow the situation and to keep the Security Council informed.

## Letter dated 22 November 2006 from the Secretary-General – UNMIN

Resolution 1939 (2010) of 15 September 2010

Para. 7: requests the Secretary-General to report to the Security Council by 15 October 2010, following high level discussions between the UN and the caretaker Government of Nepal and the political parties, on the implementation of the 13 September agreement between the caretaker Government of Nepal and the political parties.

The Secretary-General is expected to report to the Security Council by 15 October 2010.

## Timor-Leste – UNMIT

Resolution 1912 (2010) of 26 February 2010

Para. 6: endorses the Secretary-General's intention to reconfigure the police component of the United Nations Integrated Mission in Timor-Leste (UNMIT), including its drawdown, in accordance with the phased resumption process of policing responsibilities by the Polícia Nacional de Timor-Leste (PNTL), and requests the Secretary-General to include in his next report his review of this process.

Para. 17: requests the Secretary-General to keep the Security Council regularly informed of the developments on the ground and on the implementation of this resolution and to submit to the Security Council, <u>no later than 15 October 2010</u>, a report which includes elements requested in paragraph 6 of this resolution.

The report of the Secretary-General is expected to be issued by 15 October 2010.

## EUROPE

# Resolutions 1160 (1998), 1199 (1998), 1203 (1998), 1239 (1999) and 1244 (1999) – UNMIK

Resolution 1244 (1999) of 10 June 1999

Para. 20: requests the Secretary-General to report to the Security Council <u>at regular</u> <u>intervals</u> on the implementation of the resolution.

The report of the Secretary-General is expected to be issued by 31 October 2010.

## OTHER

#### Post-conflict peacebuilding

S/PRST/2009/23 of 22 July 2009

Last para.: invites the Secretary-General to report <u>within 12 months</u> to the Security Council and the General Assembly on progress achieved in fulfilling his agenda for action to improve the United Nations' peacebuilding efforts, taking into consideration the views of the Peacebuilding Commission.

The report of the Secretary-General dated 16 July 2010 (S/2010/386) is before the Security Council.

## Resolution 1889 (2009) of 5 October 2009

Para. 19: requests the Secretary-General to submit a report to the Security Council, <u>within</u> <u>12 months</u>, on addressing women's participation and inclusion in peacebuilding and planning in the aftermath of conflict, taking into consideration the views of the Peacebuilding Commission, and to include: a) analysis on the particular needs of women and girls in postconflict situations; b) challenges to women's participation in conflict resolution and peacebuilding and gender mainstreaming in all early post-conflict planning, financing and recovery processes; c) measures to support national capacity in planning for and financing responses to the needs of women and girls in post-conflict situations; and d) recommendations for improving international and national response to the needs of women and girls in post-conflict situations.

The report of the Secretary-General (S/2010/466) is expected to be issued in October 2010.

## Resolution 1645 (2005) of 20 December 2005

Para. 1: decides, acting concurrently with the General Assembly, in accordance with Articles 7, 22 and 29 of the Charter of the United Nations, with a view to operationalizing the decision by the World Summit, to establish the Peacebuilding Commission (PBC) as an intergovernmental advisory body.

Para. 27: decides that the arrangements set out above will be reviewed <u>5 years after the</u> <u>adoption of the present resolution</u> to ensure that they are appropriate to fulfil the agreed functions of the Commission and that such a review and any changes as a result thereof will be decided following the same procedure as set out in paragraph 1 above. <u>Identical letters dated 19 July 2010 from the Permanent Representatives of Ireland, Mexico and</u> <u>South Africa to the General Assembly President and the Security Council President (S/2010/393)</u> Transmits the report of the co-facilitators of the 5-year Peacebuilding Commission review.

#### S/PRST/2010/18 of 23 September 2010

The Security Council reiterates its support for the work of the PBC and looks forward to considering the facilitators' report of the 2010 Review of the PBC.

The report on the 5-year PBC review by the co-facilitators is before the General Assembly and the Security Council.

#### Women and peace and security – implementation of resolution 1325 (2000) S/PRST/2007/40 of 24 October 2007

Requests the Secretary-General to prepare a follow-up report on the full implementation of resolution 1325 (2000), incorporating information on the impact of armed conflicts on women and girls in situations that are on the agenda of the Council, and also information on their protection and on the enhancement of their role in peace processes.

## Resolution 1889 (2009) of 5 October 2009

Para. 18: requests the Secretary-General, within the report requested in S/PRST/2007/40, to also include a review of progress in the implementation of Security Council resolution 1325 (2000); an assessment of the processes by which the Council receives, analyses and takes action on information pertinent to resolution 1325 (2000); recommendations on further measures to improve coordination across the United Nations system, and with Member States and civil society, to deliver implementation; and data on women's participation in United Nations missions.

## S/PRST/2010/8 of 27 April 2010

Requests the Secretary-General to continue to consult with the Security Council, taking into account views expressed by other relevant stakeholders, including broader UN membership, taking into account the need to further develop indicators contained in his report (S/2010/173) and the parallel ongoing work regarding resolution 1888 (2009), in order to include a comprehensive set of indicators in his next report on the implementation of resolution 1325 (2000) to be submitted to the Security Council <u>in October 2010</u>, as well as a programme of work containing roles and responsibilities vis-à-vis the indicators within the UN system and a timeframe to render the indicators operational.

The report of the Secretary-General is expected to be issued by mid-October 2010.

## Resolution 1889 (2009) of 5 October 2009

Para. 19: requests the Secretary-General to submit a report to the Security Council, <u>within</u> <u>12 months</u>, on addressing women's participation and inclusion in peacebuilding and planning in the aftermath of conflict, taking into consideration the views of the Peacebuilding Commission, and to include: a) analysis on the particular needs of women and girls in postconflict situations; b) challenges to women's participation in conflict resolution and peacebuilding and gender mainstreaming in all early post-conflict planning, financing and recovery processes; c) measures to support national capacity in planning for and financing responses to the needs of women and girls in post-conflict situations; and d) recommendations for improving international and national response to the needs of women and girls in post-conflict situations.

The report of the Secretary-General (S/2010/466) is expected to be issued in October 2010.

## S/PRST/2010/8 of 27 April 2010

Expresses the intention of the Security Council to take action on a comprehensive set of indicators on the occasion of the 10th anniversary of its resolution 1325 (2000) in <u>October 2010</u>, for use at the global level to track implementation of resolution 1325 (2000).

Reiterates the desire of the Security Council to commemorate the 10th anniversary of its resolution 1325 (2000).

#### S/PRST/2010/18 of 23 September 2010

The Security Council recognizes that a concerted and determined approach that addresses the root causes of conflicts also requires a systematic and comprehensive approach to women and peace and security issues, and in this regard, looks forward to marking the 10th Anniversary of resolution 1325 (2000) by taking action on a comprehensive set of indicators on the basis of recommendations of the Secretary-General.

The Security Council is expected to meet on the occasion of the 10th anniversary of its resolution 1325 (2000) <u>during October 2010</u>.

## Election of non-permanent members of the Security Council

The election in the General Assembly is scheduled for the morning of <u>12 October 2010.</u>

## Security Council Annual Report

The Security Council is expected to adopt its Annual Report for the period 1 August 2009 to 31 July 2010 at a formal meeting <u>during October 2010</u>.
