SECURITY COUNCIL FOR THE MONTH OF OCTOBER 2009**

This tentative forecast of the programme of work of the Security Council has been prepared by the Secretariat for the President of the Council. The forecast covers in particular those matters that may be taken up during the month pursuant to earlier decisions of the Council. The fact that a matter is or is not included in the forecast carries no implication that it will or will not be taken up during the month: the actual programme of work will be determined by developments and the views of members of the Council.

**TENTATIVE FORECAST OF THE PROGRAMME OF WORK OF THE

AFRICA

Chad, the Central African Republic and the subregion – MINURCAT

Resolution 1861 (2009) of 14 January 2009

Para. 28: requests the Secretary-General to continue to report at least every 3 months on the security and humanitarian situation, on progress in the implementation of the relevant agreements, on progress towards the fulfillment of the benchmarks set out in paragraphs 25 and 26 of the resolution, on the implementation of the mandate of the United Nations Mission in the Central African Republic and Chad (MINURCAT), and on the military situation.

Para. 29: requests the Secretary-General to inform the Security Council in his upcoming reports on the development of a strategic workplan containing indicative timelines to measure and track progress on the implementation of the benchmarks in paragraphs 25 and 26 of the resolution.

The report of the Secretary-General is expected to be issued in mid-October 2009.

Côte d'Ivoire – UNOCI and French forces

Resolution 1880 (2009) of 30 July 2009

Para. 21: requests the Secretary-General to continue to monitor progress on the achievement of the benchmarks referred to in annex 1 of his report dated 7 July 2009 (S/2009/344), encourages him to continue to refine and update them and to report to the Security Council.

Para. 25: requests the Secretary-General to report to the Security Council and troop-contributing countries before 30 September 2009 on updating the military concept of operations and rules of engagement of the United Nations Operation in Côte d'Ivoire (UNOCI).

Para. 31: requests the Secretary-General to provide a mid-term report by the end of September 2009 on the situation on the ground and of the preparation of the electoral process.

The report of the Secretary-General dated 29 September 2009 (S/2009/495) is before the Security Council.

Para. 21: expresses the intention of the Security Council to review in full the benchmarks referred to in annex 1 of the report of the Secretary-General dated 7 July 2009, as refined and updated, before 15 October 2009, taking into account in particular the progress of the electoral process.

The Security Council is expected to review the benchmarks by 15 October 2009.

S/PRST/2009/25 of 29 September 2009

Penult. para.: states that the Security Council will review the situation by 15 October 2009 and expresses the intention of the Council to react as appropriate, consistent with its resolution 1880 (2009), towards those who would block the progress of the electoral process.

Last para.: expresses the intention of the Council to start considering the future direction of UNOCI by reviewing by 15 October 2009 its mandate and the benchmarks for a possible drawdown of the operation, in particular in light of the progress of the electoral process.

Côte d'Ivoire – sanctions

Resolution 1842 (2008) of 29 October 2008

Para. 1: decides to renew until 31 October 2009 the measures on arms and the financial and travel measures imposed by paragraphs 7 to 12 of resolution 1572 (2004) and the measures preventing the importation by any State of all rough diamonds from Côte d'Ivoire imposed by paragraph 6 of resolution 1643 (2005).

The arms embargo and other measures will expire on 31 October 2009.

Para. 2: Decides to review the measures renewed in paragraph 1 of the resolution in light of the progress achieved in the implementation of the key steps of the peace process and of the progress of the electoral process by the end of the period mentioned in paragraph 1.

The Security Council is expected to review the sanctions and arms embargo by 31 October 2009.

Côte d'Ivoire – Group of Experts

Resolution 1842 (2008) of 29 October 2008

Para. 11: requests the Group of Experts to provide a final written report to the Security Council, through the Committee established pursuant to resolution 1572 (2004), 15 days before the end of its mandated period, on the implementation of the measures imposed by paragraphs 7, 9 and 11 of resolution 1572 (2004) and paragraph 6 of resolution 1643 (2005), as well as recommendations in this regard.

The report of the Group of Experts is expected to be issued by 15 October 2009.

Para. 10: decides to extend the mandate of the Group of Experts until 31 October 2009.

The mandate of the Group of Experts will expire on 31 October 2009.

Democratic Republic of the Congo – MONUC

Resolution 1856 (2008) of 22 December 2008

Para. 9: requests the Secretary-General to continue to report regularly, and at least every 3 months, on the situation in the Democratic Republic of the Congo and on the activities of the United Nations Organization Mission in the Democratic Republic of the Congo (MONUC), and to provide to the Security Council, with the same regularity, a specific update on the military situation.

The report of the Secretary-General dated 18 September 2009 (S/2009/472) is before the Security Council.

Guinea-Bissau – UNOGBIS / UNIOGBIS

Resolution 1876 (2009) of 26 June 2009

Para. 6: requests the Secretary-General to develop a strategic workplan with appropriate benchmarks to measure and track progress on the implementation of the mandate, described in paragraph 3 of the resolution, of the United Nations Integrated Peacebuilding office in Guinea-Bissau (UNIOGBIS), to succeed the United Nations Peacebuilding Support Office in Guinea-Bissau (UNOGBIS) on 1 January 2010, and to report on its implementation in accordance with paragraph 14 of the resolution.

Para. 14: requests the Secretary-General to keep the Security Council regularly informed every 4 months on progress with establishing UNIOGBIS, with the first report due by 31 October 2009.

The report of the Secretary-General is expected to be issued by 31 October 2009.

Somalia – peacebuilding and peacekeeping

S/PRST/2001/30 of 31 October 2001

Penultimate para: requests the Secretary-General to submit reports, at least every 4 months, on the situation in Somalia and the efforts to promote the peace process.

Resolution 1872 (2009) of 29 May 2009

Para. 3: requests the Secretary-General to include in his next report recommendations on ways to strengthen the Djibouti peace process.

Para. 17: requests the Secretary-General to include in the reports requested in paragraph 13 an update on the deployment of a logistical support package for the African Union Mission in Somalia (AMISOM).

Para. 13: requests the Secretary-General to take the steps identified in paragraphs 82 to 86 of his report of 16 April 2009 (S/2009/210), subject to the conditions in his report, and to report on progress by 30 September 2009.

The report of the Secretary-General is expected to be issued in early October 2009.

The Sudan – UNMIS

Resolution 1870 (2009) of 30 April 2009

Para. 2: requests the Secretary-General to report to the Security Council every 3 months on the implementation of the mandate of the United Nations Mission in the Sudan (UNMIS), progress on implementation of the Comprehensive Peace Agreement (CPA), and respect for the ceasefire, and to provide an assessment and recommendations on measures UNMIS might take to further support elections and advance the peace process.

Para. 27: requests the Secretary-General to report on the military concept of operations and rules of engagement, which are to be regularly updated and fully in line with the provisions of the UNMIS mandate under relevant Council resolutions, with the same regularity as referred to in paragraph 2, with a specific update on the security situation.

The report of the Secretary-General is expected to be issued during October 2009.

The Sudan – UNAMID

Resolution 1881 (2009) of 30 July 2009

Para. 6 (a), (b) and (c): requests the Secretary-General to report to the Council every 90 days on progress made towards implementing the mandate of the African Union-United Nations Hybrid Operation in Darfur (UNAMID) and to submit, for the Security Council's consideration, a strategic workplan containing benchmarks to measure and track progress being made by UNAMID in implementing its mandate, and to include in his next report an assessment of progress made against these benchmarks, as well as consequent recommendations regarding UNAMID's mandate and configuration.

The report of the Secretary-General is expected to be issued by 31 October 2009.

The Sudan – Panel of Experts

Resolution 1841 (2008) of 15 October 2008

Para. 2: requests the Panel of Experts to provide to the Security Council a final report with its findings and recommendations no later than 30 days prior to termination of its mandate.

Para. 3: further requests the Panel to assess in its final report progress towards reducing violations by all parties of the measures imposed by paragraphs 7 and 8 of resolution 1556 (2004) and paragraph 7 of resolution 1591 (2005), and progress towards reducing impediments to the political process, threats to stability in Darfur and the region and other violations of the above-mentioned resolutions.

The report of the Panel of Experts is expected to be before the Security Council in early October 2009.

Para.1: decides to extend until 15 October 2009 the mandate of the Panel of Experts.

The mandate of the Panel of Experts will expire on 15 October 2009.

Peace and security in Africa – Djibouti / Eritrea

Resolution 1862 (2009) of 14 January 2009

Para. 6: demands that Eritrea comply immediately with paragraph 5 of the resolution and, in any case, no later than 5 weeks after the adoption of the resolution.

Para. 7: requests the Secretary-General to provide to the Security Council a report on the evolution of the situation, on the compliance by both parties with their obligations, and on his contacts with both parties and, as appropriate, with the African Union and other relevant regional organizations, no later than 6 weeks after the adoption of the resolution.

Para. 8: decides to review the situation on the basis of the report of the Secretary-General requested by paragraph 7 above, with a view to taking, as appropriate, a further decision.

The report of the Secretary-General dated 30 March 2009 (S/2009/163) is before the Security Council.

Peace and security in Africa – support for AU peacekeeping

S/PRST/2009/3 of 18 March 2009

Para. 8: requests the Secretary-General to submit a report, no later than 18 September 2009, on practical ways to provide effective support for the African Union (AU) when it undertakes peacekeeping operations authorized by the United Nations, that includes a detailed assessment of the recommendations contained in the Report of the African Union-United Nations Panel (S/2008/813), in particular those on financing, as well as on the establishment of a joint African Union-United Nations team, and lessons-learned from past and current AU peacekeeping efforts.

The report of the Secretary-General is expected to be issued by 18 September 2009.

Para. 12: expresses the intention of the Security Council to further consider this issue following the report of the Secretary-General.

The report of the Secretary-General dated 18 September 2009 (S/2009/470) is before the Security Council.

AMERICAS

Haiti – MINUSTAH

Resolution 1840 (2008) of 14 October 2008

Para. 27: requests the Secretary-General to report to the Security Council on the implementation of the mandate of the United Nations Stabilization Mission in Haiti (MINUSTAH) semi-annually and not later than 45 days prior to its expiration.

The report of the Secretary-General dated 1 September 2009 (S/2009/439) is before the Security Council.

Para. 1: decides to extend the mandate of MINUSTAH until 15 October 2009.

The MINUSTAH mandate will expire on 15 October 2009.

ASIA

Afghanistan – ISAF

Resolution 1833 (2008) of 22 September 2008

Para. 1: decides to extend the authorization of the International Security Assistance Force (ISAF) for a period of 12 months beyond 13 October 2008.

The authorization of ISAF will expire on 13 October 2009.

Iraq/Kuwait – missing persons and return of property

Resolution 1284 (1999) dated 17 December 1999

Para. 14: requests the Secretary-General to report to the Security Council every 4 months on compliance by Iraq with its obligations regarding the repatriation or return of all Kuwaiti and third country nationals or their remains, and requests the Secretary-General to report to the Council every 6 months on the return of all Kuwaiti property.

Letter from the President of the Security Council dated 30 June 2006 (S/2006/469)

Takes note of the intention of the Secretary-General in his letter dated 28 June 2006 (S/2006/468) to report on compliance by Iraq with its obligations regarding the repatriation or return of all Kuwaiti and third-country nationals or their remains and on the return of all Kuwaiti property every 6 months.

The report of the Secretary-General is expected to be submitted by mid-October 2009.

Statement by the President of the Security Council to the press of 16 April 2009 (SC/9637)

Para. 5: states that the members of the Security Council agreed to finance the continuation of the activities of the High-Level Coordinator for a period of 6 months, and with a possibility of a further extension of the financing of the High-Level Coordinator's mandate.

The financial arrangements for the activities of the High-level Coordinator will expire on 31 October 2009.

Middle East (Lebanon) – resolution 1559 (2004)

S/PRST/2004/36 of 19 October 2004

Requests the Secretary-General to report to the Security Council every 6 months on the implementation by the parties of resolution 1559 (2004).

The Secretary-General's report is expected to be issued by 20 October 2009.

Middle East – Lebanon (resolution 1701 (2006))

Resolution 1884 (2009) of 27 August 2009

Para. 6: requests the Secretary-General to continue to report to the Council on the implementation of resolution 1701 (2006) every 4 months, or at any time as he deems appropriate.

The report of the Secretary-General is expected to be issued by 31 October 2009.

The situation in the Middle East, including the Palestinian Question

Resolution 1322 (2000) of 7 October 2000

Para. 7: invites the Secretary-General to continue to follow the situation and to keep the Security Council informed.

Letter dated 22 November 2006 from the Secretary-General – UNMIN

Resolution 1879 (2009) of 23 July 2009

Para. 4: requests the Secretary-General to report to the Security Council by 30 October 2009 on the implementation of this resolution, and progress in creating the conditions conducive to completion of the activities of the United Nations Mission in Nepal (UNMIN) by the end of the current mandate, including the implementation of commitments made in the Government of Nepal's letter of 7 July 2009 (S/2009/360).

The report of the Secretary-General is expected to be issued by 30 October 2009.

Timor-Leste – UNMIT

Resolution 1867 (2009) of 26 February 2009

Para. 17: requests the Secretary-General to keep the Security Council regularly informed of the developments on the ground and on the implementation of the resolution, and to the submit to the Council, no later than 30 September 2009, a report reviewing the transfer of policing responsibilities from the United Nations Integrated Mission in Timor-Leste (UNMIT) to the Policia Nacional de Timor-Leste (PNTL).

The report of the Secretary-General is expected to be issued in early October.

EUROPE

Resolutions 1160 (1998), 1199 (1998), 1203 (1998), 1239 (1999) and 1244 (1999) – UNMIK

Resolution 1244 (1999) of 10 June 1999

Para. 20: requests the Secretary-General to report to the Security Council at regular intervals on the implementation of the resolution.

The report of the Secretary-General dated 30 September 2009 (S/2009/XXX) is before the Security Council.

OTHER

Women and peace and security

S/PRST/2008/39 of 29 October 2008

Last para.: requests the Secretary-General to provide a report on the implementation of resolution 1325 (2000) over the coming year, including information on the impact of armed conflict on women and girls in situations of which the Security Council is seized; on the obstacles and challenges to strengthening women's participation in conflict prevention, conflict resolution and peacebuilding; and recommendations to address those issues, to be submitted to the Security Council by October 2009.

The report of the Secretary-General dated 16 September 2009 (S/2009/465) is before the Security Council.

Election of non-permanent members of the Security Council

The election in the General Assembly is scheduled for the morning of 15 October 2009.

Security Council Annual Report

The Security Council is expected to adopt its Annual Report for the period 1 August 2008 to 31 July 2009 at a formal meeting during October 2009.

Iraq (UNAMI)	By mid-November 2009	Resolution 1883 (2009) of 7 August 2009	“Requests the Secretary-General to report to the Council on a quarterly basis on the progress made towards the fulfilment of all UNAMI’s responsibilities” (para. 6).
