TENTATIVE FORECAST OF THE PROGRAMME OF WORK OF THE SECURITY COUNCIL FOR THE MONTH OF NOVEMBER 2010

This tentative forecast of the programme of work of the Security Council has been prepared by the Secretariat for the President of the Council. The forecast covers in particular those matters that may be taken up during the month pursuant to earlier decisions of the Council. The fact that a matter is or is not included in the forecast carries no implication that it will or will not be taken up during the month: the actual programme of work will be determined by developments and the views of members of the Council.

TENTATIVE FORECAST OF THE PROGRAMME OF WORK OF THE SECURITY COUNCIL FOR THE MONTH OF NOVEMBER 2010

AFRICA

Burundi – BINUB

Resolution 1902 (2009) of 17 December 2009

Para. 22: requests the Secretary-General to provide to the Security Council a full report on the implementation of the mandate of the United Nations Integrated Office in Burundi (BINUB) in November 2010, and requests the Secretary-General to incorporate in this report a detailed review of the extent to which the benchmarks set in the 14 August 2006 Addendum (S/2006/429/Add.1) to his report of 21 June 2006 (S/2006/429) have been met, and, following consultations with the Government of Burundi, to provide recommendations on what changes need to be made to the direction and composition of the UN presence in Burundi, including recommendations on a revised time frame for the transition to a more development-focused presence.

The report of the Secretary-General is expected to be issued during November 2010.

Côte d'Ivoire – UNOCI

Resolution 1933 (2010) of 30 June 2010

Para. 28: requests the Secretary-General to inform the Security Council of the publication of the final voters list and to provide to it a midterm report <u>no later than 22 October 2010</u> and a full report <u>no later than 30 November 2010</u> on the situation on the ground, the implementation of this resolution, and on the revised benchmarks referred to in paragraph 26 of the resolution and which includes possible adjustments in the structure and strength of the United Nations Operation in Côte d'Ivoire (UNOCI) and requests further the Secretary-General to submit to it recommendations in this regard as appropriate.

Para. 22: requests the Secretary-General to continue to include in his reports relevant information on progress on the promotion and protection of human rights and international humanitarian law as well as on the strengthening of the rule of law, including on ending impunity in Côte d'Ivoire, with special attention to violence committed against children and women, and on progress on gender mainstreaming throughout UNOCI and all other aspects relating to the situation of women and girls, especially in relation to the need to protect them from sexual and gender-based violence.

Para. 25: underscores the importance that the military and police concepts of operations and the rules of engagement be brought fully in line with the provisions of this resolution and requests the Secretary-General to report on them to the Security Council and to troop- and police-contributing countries.

The <u>midterm report</u> of the Secretary-General dated 18 October 2010 (S/2010/537) is before the Security Council.

The <u>full report</u> of the Secretary-General is expected to be issued by 30 November 2010.

Democratic Republic of the Congo – sanctions

Resolution 1896 (2009) of 7 December 2009

Decides to extend <u>until 30 November 2010</u> the measures relating to arms (para. 1), transport (para. 2) and finance and travel (para. 3) imposed by previous resolutions.

The sanctions measures will expire on 30 November 2010.

Para. 21: decides that, when appropriate and no later than <u>30 November 2010</u>, the Security Council shall review the measures set forth in this resolution, with a view to adjusting them, as appropriate, in the light of consolidation of the security situation in the Democratic Republic of the Congo.

The Security Council is expected to review the sanctions measures by 30 November 2010.

Democratic Republic of the Congo – Group of Experts

Resolution 1896 (2009) of 7 December 2009

Para. 6: requests the Group of Experts to report to the Security Council in writing, through the Committee established pursuant to resolution 1533 (2004), <u>before 20 October 2010</u>.

The report of the Group of Experts is expected to be before the Security Council <u>during</u> <u>November 2010</u>.

Para. 6: requests the Secretary-General to extend the Group of Experts for a period expiring on 30 November 2010.

The mandate of the Group of Experts will expire on 30 November 2010.

Guinea-Bissau – UNIOGBIS

Resolution 1876 (2009) of 26 June 2009

Para. 6: requests the Secretary-General to develop a strategic workplan with appropriate benchmarks to measure and track progress on the implementation of the mandate, described in paragraph 3 of the resolution, of the United Nations Integrated Peacebuilding Office in Guinea-Bissau (UNIOGBIS), and to report on its implementation in accordance with paragraph 14 of the resolution.

Para. 14: requests the Secretary-General to keep the Security Council regularly informed <u>every 4 months</u> on the implementation of this resolution.

The report of the Secretary-General is expected to be before the Security Council <u>during</u> November 2010.

Para. 3: requests the Secretary-General to establish a United Nations Integrated Peacebuilding Office in Guinea-Bissau (UNIOGBIS) to succeed UNOGBIS for an initial <u>period of 12 months</u>, beginning on 1 January 2010.

The mandate of UNIOGBIS will expire on 31 December 2010.

Somalia – piracy at sea

Resolution 1897 (2009) of 30 November 2009

Para. 17: requests the Secretary-General to report to the Security Council <u>within 11 months</u> of adoption of this resolution on the implementation of this resolution and on the situation with respect to piracy and armed robbery at sea off the coast of Somalia.

The report of the Secretary-General dated 27 October 2010 (S/2010/556) is before the Security Council.

Para. 7: decides, for <u>a period of 12 months</u> from the date of this resolution, to renew the authorization as set out in paragraph 10 of resolution 1846 (2008) and paragraph 6 of resolution 1851 (2008) granted to States and regional organizations cooperating with the Transitional Federal Government (TFG) of Somalia in the fight against piracy and armed robbery at sea off the coast of Somalia, for which advance notification has been provided by the TFG to the Secretary-General.

The authorization set out in paragraph 10 of resolution 1846 (2008) and paragraph 6 of resolution 1851 (2008) will expire <u>on 30 November 2010</u>.

Para. 19: expresses the intention of the Security Council to review the situation and consider, as appropriate, renewing the authorizations provided in paragraph 7 of the resolution for additional periods upon the request of the TFG.

The Security Council is expected to conduct its review of the situation by 30 November 2010.

Somalia / Eritrea – sanctions

Resolution 1844 (2008) of 20 November 2008

Para. 11(g): decides that the Security Council Committee established pursuant to resolution 751(1992) shall report at least <u>every 120 days</u> to the Council on its work and on the implementation of resolution 1844 (2008), with its observations and recommendations, in particular on ways to strengthen the effectiveness of the measures imposed by paragraphs 1, 3 and 7 of the resolution.

The Chairman of the 751/1907 Committee is expected to report to the Security Council <u>during</u> <u>November 2010</u>.

Resolution 1916 (2010) of 19 March 2010

Para. 11: requests the United Nations Humanitarian Aid Coordinator for Somalia to report <u>every</u> <u>120 days</u> to the Security Council on the implementation of paragraphs 4 and 5 of the resolution and on any impediments to the delivery of humanitarian assistance in Somalia, and requests relevant United Nations agencies and humanitarian organizations having observer status with the United Nations General Assembly that provide humanitarian assistance to assist the United Nations Humanitarian Aid Coordinator for Somalia in the preparation of such report by providing information relevant to paragraphs 4 and 5 of the resolution.

The UN Humanitarian Aid Coordinator for Somalia is expected to report to the Security Council <u>during November 2010</u>.

The Sudan – referenda preparations

In informal consultations of the whole on 29 July 2010, Council members requested that the Secretariat provide regular briefings on referenda preparations <u>during the period leading up to the 2011 referenda</u>.

The Secretariat is expected to provide a briefing on the referenda preparations <u>during November</u> <u>2010</u>.

ASIA

Iraq – UNAMI

Resolution 1936 (2010) of 5 August 2010

Para. 6: requests the Secretary-General to report to the Security Council <u>every 4 months</u> on the progress made towards the fulfilment of all of the responsibilities of the United Nations Assistance Mission for Iraq (UNAMI).

The report of the Secretary-General is expected to be issued by 30 November 2010.

Iraq – DFI / IAMB

Resolution 1905 (2009) of 21 December 2009

Para. 3: requests the Secretary-General to provide written reports to the Security Council <u>on</u> <u>a quarterly basis</u>, to include details on progress made in strengthening financial and administrative oversight of the current Development Fund for Iraq (DFI), as well as the legal issues and options to be considered to implement successor arrangements and an assessment of the Government of Iraq's progress in preparing for the successor arrangements for the DFI.

The consolidated 3rd and 4th quarter report of the Secretary-General is expected to be issued <u>during November 2010</u>.

Para. 5: requests the Government of Iraq through the head of the Committee of Financial Experts (COFE) to report to the Security Council <u>on a quarterly basis</u> to provide an assessment of progress against the action plan for the transition from the Development Fund for Iraq and oversight improvements.

The consolidated 3rd and 4th quarter report of the Government of Iraq is expected to be transmitted <u>during November 2010</u>.

The situation in the Middle East, including the Palestinian question Resolution 1322 (2000) of 7 October 2000

Para. 7: invites the Secretary-General to continue to follow the situation and to keep the Security Council informed.

International Day of Solidarity with the Palestinian People

The International Day of Solidarity with the Palestinian People will be commemorated on 29 November 2010.

Middle East – Lebanon (resolution 1701 (2006))

Resolution 1937 (2010) of 30 August 2010

Para. 10: requests the Secretary-General to continue to report to the Security Council on the implementation of resolution 1701 (2006) every 4 months, or at any time as he deems appropriate.

The report of the Secretary-General is expected to be before the Security Council <u>during</u> November 2010.

EUROPE

Bosnia and Herzegovina – report of the High Representative Resolution 1895 (2009) of 18 November 2009

Para. 21: requests the Secretary-General to <u>continue to submit to the Security Council</u> reports from the High Representative, in accordance with Annex 10 of the Peace Agreement and the conclusions of the Peace Implementation Conference held in London on 4 and 5 December 1996 (S/1996/1012) and later Peace Implementation Conferences, on the implementation of the Peace Agreement.

The report of the High Representative is expected to be issued by mid-November 2010.

Bosnia and Herzegovina – EUFOR

Resolution 1895 (2009) of 18 November 2009

Para. 18: requests the Member States acting through or in cooperation with the European Union (EU) and the Member States acting through or in cooperation with NATO to report to the Security Council on the activity of the EU multinational stabilization force (EUFOR) and of the NATO Headquarters presence respectively, at least at three-monthly intervals.

The reports on the activity of EUFOR and on the NATO Headquarters presence are expected to be issued <u>during November 2010</u>.

Para. 10: authorizes the Member States acting through or in cooperation with the European Union to establish <u>for a further period of 12 months</u>, starting from the date of the adoption of the resolution, a multinational stabilization force (EUFOR).

The authorization of EUFOR will expire on 18 November 2010.

Resolutions 1160 (1998), 1199 (1998), 1203 (1998), 1239 (1999) and 1244 (1999) – UNMIK Resolution 1244 (1999) of 10 June 1999

Para. 20: requests the Secretary-General to report to the Security Council <u>at regular intervals</u> on the implementation of the resolution.

The report of the Secretary-General is expected to be before the Security Council <u>during</u> <u>November 2010</u>.

OTHER

United Nations peacekeeping operations

S/PRST/2010/2 of 12 February 2010

Last para.: states that the Security Council remains committed to improving further the overall effectiveness of United Nations peacekeeping, including through the recognition and enhancement of linkages with wider peacebuilding efforts, and will conduct a further review of progress in this regard in late 2010.

The Security Council is expected to conduct its review during November 2010.

Protection of civilians in armed conflict

<u>Resolution 1894 (2009) of 11 November 2009</u> Para. 35: requests the Secretary-General to submit his next report on the protection of civilians in armed conflict <u>by November 2010</u>.

The report of the Secretary-General is expected to be issued during November 2010.

S/PRST/2002/41 of 20 December 2002

Last para.: welcomes the oral briefings to be given to the Security Council every 6 months.

The next oral briefing is expected to be given during November 2010.

Non-proliferation / DPRK

Resolution 1928 (2010) of 7 June 2010 Para. 2: requests the Panel of Experts to provide to the Security Council <u>no later than</u> <u>12 November 2010</u> a midterm report on its work.

The report of the Panel of Experts is expected to be submitted to the Security Council by <u>12 November 2010</u>.

Resolution 1718 (2006) of 14 October 2006

Para. 12(g): decides that the Committee established pursuant to resolution 1718 (2006) shall report <u>at least every 90 days</u> to the Security Council on its work, with its observations and recommendations, in particular on ways to strengthen the effectiveness of the measures imposed by paragraph 8 of the resolution.

The Chairman of the 1718 Committee is expected to report to the Security Council <u>during</u> <u>November 2010</u>.

Coordinated briefing by Chairmen of counter- terrorism committees

S/PRST/2005/34 of 20 July 2005

Last para.: invites the Committee established pursuant to resolution 1267 (1999) concerning Al-Qaida and the Taliban and Associated Individuals and Entities, the Committee established pursuant to resolution 1373 (2001) concerning counter-terrorism (CTC), and the Committee established pursuant to resolution 1540 (2004) to continue reporting on their activities <u>at regular</u> <u>intervals</u> and, where appropriate, <u>in a coordinated manner</u>.

Resolution 1904 (2009) of 17 December 2009

Para. 46: requests the Committee established pursuant to resolution 1267 (1999) concerning Al-Qaida and the Taliban and associated individuals and entities to report orally, through its Chairman, to the Security Council <u>at least every 180 days</u> on the state of the overall work of the Committee and the Analytical Support and Sanctions Monitoring Team and, as appropriate, <u>in conjunction with the reports by the Chairmen of the CTC and of the Committee established pursuant to resolution 1540 (2004)</u>.

Resolution 1805 (2008) of 20 March 2008

Para. 9: requests the Committee established pursuant to resolution 1373 (2001) concerning counter-terrorism to report orally, through its Chairman, at least <u>every 180 days</u> to the Security Council on the overall work of the Committee and the Counter-Terrorism Committee Executive Directorate (CTED) and, as appropriate, in conjunction with the reports by the Chairmen of the Committee established pursuant to resolution 1267 (1999) and the Committee established pursuant to resolution 1540 (2004).

The Chairmen of the Committees established pursuant to resolutions 1267 (1999), 1373 (2001) and 1540 (2004) are expected to give a coordinated briefing to the Security Council <u>during</u> November 2010.

Annual Report of the Security Council to the General Assembly

The President of the Security Council for the month of November is expected to introduce the Security Council Annual Report (A/65/2) in the General Assembly <u>on 11 November 2010</u>, when the Assembly will also take up the agenda items of the Notification by the Secretary-General under Article 12(2) of the United Nations Charter (A/65/300) and the "Question of equitable representation on and increase in the membership of the Security Council and related matters".

Workshop for newly-elected Council members

The Workshop, sponsored by the Finnish Government, will take place <u>18 and 19 November</u> <u>2010</u>.
