**AFRICA**

**Chad, the Central African Republic and the subregion – MINURCAT**

Resolution 1778 (2007) of 25 September 2007

Para. 20: requests the Secretary-General to submit to the Security Council a report on the security and humanitarian situation, on progress towards the objective of helping to create the security conditions conducive to a voluntary, secure and sustainable return of refugees and displaced persons, and on the implementation of the mandate of the multinational presence in Chad and the Central African Republic (MINURCAT) every 3 months.

The report of the Secretary-General is expected to be issued by 25 June 2008.

**Central African Republic – BONUCA**

S/PRST/2001/25 of 26 September 2001

Last para.: requests the Secretary-General to continue to keep the Council regularly informed of the activities of the United Nations Peacebuilding Support Office in the Central African Republic (BONUCA) and the situation in the Central African Republic.

The report of the Secretary-General is expected to be issued by 23 June 2008.

**Democratic Republic of the Congo – MONUC**

Resolution 1794 (2007) of 21 December 2007

Para. 21: requests the Secretary-General to continue to report regularly, and at least every 3 months, on the situation in the Democratic Republic of the Congo and on the activities of the United Nations Organization Mission in the Democratic Republic of the Congo (MONUC).

The report of the Secretary-General is expected to be issued by 30 June 2008.

**Guinea-Bissau – UNOGBIS**

Resolution 1580 (2004) of 22 December 2004

Para. 11: requests the Secretary-General to submit a report every 3 months from the date of adoption of the resolution.

The report of the Secretary-General is expected to be issued by 22 June 2008.

**Liberia – Panel of Experts**Resolution 1792 (2007) of 19 December 2007

Para. 5(e): decides that the Panel of Experts shall report to the Security Council, through the Committee established pursuant to resolution 1521 (2003), by 1 June 2008, on all the issues contained in paragraph 5 of the resolution, and especially on progress in the timber and diamond sectors since the lifting of the relevant paragraphs of resolution 1521 (2003).

The Panel of Experts is expected to submit its report by 1 June 2008.

Para 5: decides to extend the mandate of the current Panel of Experts appointed pursuant to paragraph 1 of resolution 1760 (2007) for a further period until 20 June 2008.

The mandate of the Panel of Experts will expire on 20 June 2008.

**Sierra Leone – UNIOSIL**Resolution 1793 (2007) of 21 December 2007

Para. 2: requests that the completion strategy submitted by the Secretary-General to the Security Council in January 2008 include a continued mission at 80 per cent of the current strength of the United Nations Integrated Office in Sierra Leone (UNIOSIL) until 30 June 2008.

The strength of UNIOSIL is to be maintained at 80 per cent of the strength pertaining in December 2007 until 30 June 2008.

**The Sudan – International Criminal Court**Resolution 1593 (2005) of 31 March 2005

Para. 8: invites the Prosecutor of the International Criminal Court to address the Security Council every 6 months on actions taken pursuant to the resolution.

The ICC Prosecutor is expected to brief the Security Council in early June 2008.

**The Sudan – UNAMID combined 30-day and 90-day report**Resolution 1769 (2007) of 31 July 2007

Para. 6: requests the Secretary-General to report to the Security Council every 30 days on the status of implementation by the African Union-United Nations Hybrid Operation in Darfur (UNAMID) of the steps specified in paragraph 5 of the resolution, including on the status of financial, logistical and administrative arrangements for UNAMID and on the extent of UNAMID's progress toward achieving full operational capability.

S/PRST/2007/41 of 24 October 2007

Last para.: requests the Secretary-General, in his regular 30-day reports to the Security Council on UNAMID, to report also on progress being made on, and any obstacles to, the political process and the situation on the ground.

Resolution 1769 (2007) of 31 July 2007

Para. 21: requests the Secretary-General to report to the Council for its consideration no later than every 90 days after the adoption of the resolution on progress being made on the implementation of the Light and Heavy Support Packages and UNAMID; the implementation of the Joint Communiqué between the Government of the Sudan and the United Nations on Facilitation of Humanitarian Activities in Darfur; the political process; the implementation of the Darfur Peace Agreement and the parties' compliance with their international obligations and

their commitments under relevant agreements; and the ceasefire and the situation on the ground in Darfur.

The combined 30-day and 90-day report of the Secretary-General is expected to be issued by 30 June 2008.

#### **The Sudan – 1591 Sanctions Committee**

Resolution 1591 (2005) of 29 March 2005

Para. 3(a)(iv): decides that the Security Council Committee established pursuant to resolution 1591 (2005) shall report at least every 90 days to the Council on its work.

The Chairman of the 1591 Committee is expected to brief the Security Council during mid-June 2008.

## **ASIA**

#### **Iraq – multinational force**

Resolution 1790 (2007) of 18 December 2007

Para. 2: decides that the mandate for the multinational force (MNF) shall be reviewed at the request of the Government of Iraq or no later than 15 June 2008.

The review of the MNF mandate is expected to take place by 15 June 2008.

#### **Iraq – DFI/IAMB**

Resolution 1790 (2007) of 18 December 2007

Para. 4: decides that the provisions in paragraph 3 of the resolution for the deposit of proceeds into the Development Fund for Iraq (DFI) and for the role of the International Advisory and Monitoring Board (IAMB), as well as the provisions of paragraph 22 of resolution 1483 (2003), shall be reviewed at the request of the Government of Iraq or no later than 15 June 2008.

The review of the DFI/IAMB arrangements and the immunity provisions is expected to take place by 15 June 2008.

#### **Iraq – UNMOVIC**

Letter from the Security Council President of 21 November 2007 (S/2007/680)

Requests monthly updates concerning the closing down of the archives and other property of the United Nations Monitoring, Verification and Inspection Commission (UNMOVIC) in a manner consistent with resolution 1762 (2007); requests a briefing on what steps the Secretariat is planning to provide for the enhanced physical security of the archives, in particular those containing sensitive proliferation information; and requests an update each quarter on relevant spending by the United Nations in the context of the requirement of resolution 1762 (2007) that the Secretary-General transfer all unencumbered funds not used for payment of outstanding bills or for the costs associated with archiving and property disposition to the Development Fund for Iraq.

The report of the Secretary-General is expected to be issued in early June 2008.

**Iraq/Kuwait – missing persons and return of property**Resolution 1284 (1999) dated 17 December 1999

Para. 14: requests the Secretary-General to report to the Security Council on compliance by Iraq with its obligations regarding the repatriation or return of all Kuwaiti and third country nationals or their remains and on the return of all Kuwaiti property.

Letter from the Security Council President of 30 June 2006 (S/2006/469)

Takes note of the intention of the Secretary-General in his letter dated 28 June 2006 (S/2006/468) that the frequency of reports on compliance by Iraq with its obligations regarding the repatriation or return of all Kuwaiti and third-country nationals or their remains shall be every 6 months.

The consolidated report is expected to be submitted during mid-June 2008.

**The situation in the Middle East, including the Palestinian Question**Resolution 1322 (2000) of 7 October 2000

Para. 7: invites the Secretary-General to continue to follow the situation and to keep the Security Council informed.

**Middle East – Lebanon (resolution 1701 (2006))**Resolution 1773 (2007) of 24 August 2007

Para. 8: requests the Secretary-General to continue to report to the Security Council on the implementation of resolution 1701 (2006) every 4 months, or at any time as he deems appropriate.

The report of the Secretary-General is expected to be issued by 30 June 2008.

**Middle East – UNDOF**Resolution 1788 (2007) of 14 December 2007

Para. 3: decides to renew the mandate of the United Nations Disengagement Observer Force (UNDOF) until 30 June 2008.

The UNDOF mandate will expire on 30 June 2008.

Para. 4: requests the Secretary-General to submit at the end of this period a report on developments in the situation and the measures taken to implement resolution 338 (1973).

The report of the Secretary-General report is expected to be issued by 23 June 2008.

A meeting between the Security Council and the troop-contributing countries will take place after the issuance of the report of the Secretary-General.

## EUROPE

### **Cyprus – UNFICYP**

Resolution 1789 (2007) of 14 December 2007

Para. 8: requests the Secretary-General to submit a report on implementation of this resolution by 1 June 2008.

The report of the Secretary-General is expected to be issued in early June 2008.

Para. 5: decides to extend the mandate of the United Nations Peacekeeping Force in Cyprus (UNFICYP) for a further period ending 15 June 2008.

The UNFICYP mandate will expire on 15 June 2008.

A meeting between the Security Council and the troop-contributing countries will take place prior to the expiration of the UNFICYP mandate.

### **Resolutions 1160 (1998), 1199 (1998), 1203 (1998), 1239 (1999) and 1244 (1999) – UNMIK**

Resolution 1244 (1999) of 10 June 1999

Para. 20: requests the Secretary-General to report to the Security Council at regular intervals on the implementation of the resolution.

The report of the Secretary-General on the United Nations Interim Administration Mission in Kosovo (UNMIK) is expected to be issued by 30 June 2008.

## OTHER

### **Non-proliferation (Iran) – IAEA report**

Resolution 1803 (2008) of 3 March 2008

Para. 18: requests within 90 days a further report from the Director General of the International Atomic Energy Agency (IAEA) on whether Iran has established full and sustained suspension of all activities mentioned in resolution 1737 (2006), as well as on the process of Iranian compliance with all the steps required by the IAEA Board of Governors and with the other provisions of resolution 1737 (2006), resolution 1747 (2007) and of this resolution, to the IAEA Board of Governors and in parallel to the Security Council for its consideration.

The report of the IAEA Director General dated 27 May 2008 (S/2008/338, Annex) is before the Security Council.

**Non-proliferation (Iran) – sanctions**

Resolution 1737 (2006) of 23 December 2006

Para. 18(h): decides that the Security Council Committee established pursuant to resolution 1737 (2006) shall report at least every 90 days to the Council on its work and on the implementation of the resolution.

The Chairman of the 1737 Committee is expected to report to the Security Council during June 2008.

**Counter-terrorism – Al-Qaida / Taliban sanctions**

Resolution 1735 (2006) of 22 December 2006

Para. 32: decides to extend the mandate of the Analytical Support and Sanctions Monitoring Team for a further period of 18 months.

The mandate of the Monitoring Team will expire on 30 June 2008.

**ICTY / ICTR – completion strategies**

Resolution 1534 (2004) of 26 March 2004

Para. 6: requests the International Tribunal for the Former Yugoslavia (ICTY) and the International Criminal Tribunal for Rwanda (ICTR) to provide to the Security Council every 6 months assessments by each President and Prosecutor with respect to implementation of the Completion Strategy of the Tribunals, and expresses the intention of the Security Council to meet with the President and Prosecutor of each Tribunal to discuss these assessments.

The Security Council is expected to consider the ICTY completion strategy assessment (S/2008/326) and the ICTR completion strategy assessment (S/2008/322) in early June 2008.

**Security Council mission to Africa**

An oral briefing by the heads of the Security Council mission to Africa (31 May to 10 June 2008) is expected after the return of the mission.
