## TENTATIVE FORECAST OF THE PROGRAMME OF WORK OF THE SECURITY COUNCIL FOR THE MONTH OF JULY 2008

#### For information only/not an official document

This tentative forecast of the programme of work of the Security Council has been prepared by the Secretariat for the President of the Council. The forecast covers in particular those matters that may be taken up during the month pursuant to earlier decisions of the Council. The fact that a matter is or is not included in the forecast carries no implication that it will or will not be taken up during the month: the actual programme of work will be determined by developments and the views of members of the Council.

# TENTATIVE FORECAST OF THE PROGRAMME OF WORK OF THE SECURITY COUNCIL FOR THE MONTH OF JULY 2008

#### **AFRICA**

# Chad, the Central African Republic and the subregion – MINURCAT Resolution 1778 (2007) of 25 September 2007

Para. 20: requests the Secretary-General to submit to the Security Council a report on the security and humanitarian situation, on progress towards the objective of helping to create the security conditions conducive to a voluntary, secure and sustainable return of refugees and displaced persons, and on the implementation of the mandate of the multinational presence in Chad and the Central African Republic (MINURCAT) every 3 months.

The report of the Secretary-General is expected to be issued in early July 2008.

#### **Côte d'Ivoire – mandates of UNOCI and French forces**

Resolution 1795 (2008) of 15 January 2008

Para. 8: expresses the intention of the Security Council to review by 30 July 2008 the mandates of the United Nations Operation in Côte d'Ivoire (UNOCI) and of the French forces which support it, as well as the level of troops of UNOCI, in the light of the progress achieved in the implementation of the key steps of the peace process, and requests the Secretary-General to provide to the Council a report on these key steps 3 weeks before this date.

The report of the Secretary-General is expected to be issued by 10 July 2008.

#### S/PRST/2008/11 of 29 April 2008

Restates that the Security Council will review <u>by 30 July 2008</u> the mandates of UNOCI and the French forces which support it, as well as the level of troops of UNOCI, in accordance with paragraph 8 of resolution 1795 (2008).

The review of the mandates of UNOCI and of the French forces supporting it is expected to take place by 30 July 2008.

#### Resolution 1795 (2008) of 15 January 2008

Para. 4: decides to renew the mandates of UNOCI and of the French forces which support it until 30 July 2008.

The mandates of UNOCI and of the French forces supporting it shall expire on 30 July 2008.

A meeting between the Security Council and the troop-contributing countries will take place prior to the expiration of the UNOCI mandate.

#### **Democratic Republic of the Congo – MONUC**

Resolution 1794 (2007) of 21 December 2007

Para. 21: requests the Secretary-General to continue to report regularly, and <u>at least every</u> 3 months, on the situation in the Democratic Republic of the Congo and on the activities of the United Nations Organization Mission in the Democratic Republic of the Congo (MONUC).

The report of the Secretary-General is expected to be issued in early July 2008.

#### Eritrea / Ethiopia – UNMEE

S/PRST/2008/12 of 30 April 2008

Para. 3: states that the Security Council will, in the light of consultations with the parties, decide on the terms of a future United Nations engagement and on the future of the United Nations Mission in Ethiopia and Eritrea (UNMEE).

<u>Letter from the Secretary-General to the Council President of 5 June 2008 (S/2008/368)</u> Proposes that UNMEE military personnel temporarily relocated from Eritrea to their home countries now be considered as repatriated.

#### Resolution 1798 (2008) of 30 January 2008

Para. 1: decides to extend the UNMEE mandate for a period of six months, until 31 July 2008.

The UNMEE mandate will expire on 31 July 2008.

#### Somalia – sanctions

Resolution 1814 (2008) of 15 May 2008

Para. 6: recalls the intention of the Security Council to take measures against those who seek to prevent or block a peaceful political process, or those who threaten Somalia's Transitional Federal Institutions (TFIs) or the African Union Mission in Somalia (AMISOM) by force, or take action that undermines stability in Somalia or the region, and therefore requests the Committee established pursuant to resolution 751 (1992) to provide, within 60 days from the adoption of this resolution, recommendations on specific targeted measures to be imposed against such individuals or entities.

Para. 7: recalls the intention of the Security Council to strengthen the effectiveness of the United Nations arms embargo on Somalia; states its intention to take measures against those who breach the arms embargo and those who support them in doing so; and therefore requests the 751 Committee to provide, within 60 days from the adoption of this resolution, recommendations on specific targeted measures to be imposed against such individuals or entities.

The Chairman of the 751 Committee is expected to report to the Security Council <u>by</u> 15 July 2008.

#### Somalia – UN Strategy and UNPOS

#### Resolution 1814 (2008) of 15 May 2008

Para. 2: requests the Secretary-General to submit, <u>within 60 days</u> from the adoption of the resolution, an updated comprehensive, integrated United Nations Strategy for peace and stability in Somalia, and to include an assessment of the capacity of the United Nations Political Office for Somalia (UNPOS) to implement the Strategy.

Para. 4: requests that the Secretary-General, when submitting the Strategy referred to in paragraph 2, also update the Security Council on his recommendation to relocate UNPOS and the country team headquarters from Nairobi to Mogadishu or an interim location in Somalia and on the necessary security arrangements for such a relocation.

Para. 5: requests that the Secretary-General also report within 60 days on progress by UNPOS and the United Nations country team in enhancing their support to the Transitional Federal Institutions (TFIs) with the aim of developing a constitution and holding a constitutional referendum and free and democratic elections in 2009, and in facilitating coordination of the international community's support to these efforts.

Para. 8: requests that in the report referred to above, the Secretary-General also update on progress in his contingency planning for the possible deployment of a United Nations peacekeeping operation in Somalia to succeed the African Union Mission in Somalia (AMISOM), including possible additional scenarios.

Para. 9: requests that in the report referred to above, the Secretary-General also update on his undertaking to provide additional United Nations technical advisers to the African Union's Strategic Plans and Management Unit in Addis Ababa and on ways and means to strengthen United Nations logistical, political and technical support for the African Union, to build the AU's institutional capacity to carry out its commitments in addressing the challenges it faces in supporting AMISOM, and to assist AMISOM's full deployment, to the extent possible.

Para. 13: requests that in the report referred to above, the Secretary-General report on progress in strengthening ongoing efforts for establish a United Nations-led mechanism for bringing together and facilitating consultations between humanitarian organizations operating in Somalia, the Transitional Federal Government, donors and other relevant parties in order to help resolve issues of access, security and provision of humanitarian relief throughout Somalia.

Para. 14: requests that in the report referred to above, the Secretary-General report on progress in establishing an effective capacity within UNPOS to monitor and enhance the protection of human rights in Somalia, and in ensuring coordination, as appropriate, between UNPOS, the Office of the High Commissioner for Human Rights and the Human Rights Council Independent Expert.

#### S/PRST/2001/30 of 31 October 2001

Penultimate para: requests the Secretary-General to submit reports, at least <u>every 4 months</u>, on the situation in Somalia and the efforts to promote the peace process.

The report of the Secretary-General is expected to be issued by 15 July 2008.

#### The Sudan – UNAMID (combined 30-day and 90-day report)

#### Resolution 1769 (2007) of 31 July 2007

Para. 6: requests the Secretary-General to report to the Security Council <u>every 30 days</u> on the status of implementation by the African Union-United Nations Hybrid Operation in Darfur (UNAMID) of the steps specified in paragraph 5 of the resolution, including on the status of financial, logistical and administrative arrangements for UNAMID and on the extent of UNAMID's progress toward achieving full operational capability.

#### S/PRST/2007/41 of 24 October 2007

Last para.: requests the Secretary-General, in his regular 30-day reports to the Security Council on UNAMID, to report also on progress being made on, and any obstacles to, the political process and the situation on the ground.

#### Resolution 1769 (2007) of 31 July 2007

Para. 21: requests the Secretary-General to report to the Council for its consideration no later than every 90 days on progress being made on the implementation of the Light and Heavy Support Packages and UNAMID; the implementation of the Joint Communiqué between the Government of the Sudan and the United Nations on Facilitation of Humanitarian Activities in Darfur; the political process; the implementation of the Darfur Peace Agreement and the parties' compliance with their international obligations and their commitments under relevant agreements; and the ceasefire and the situation on the ground in Darfur.

The combined 30-day and 90-day report of the Secretary-General is expected to be issued in early July 2008.

#### The Sudan - UNAMID mandate

#### Resolution 1769 (2007) of 31 July 2007

Para 1: decides to authorise and mandate the establishment, <u>for an initial period of 12</u> months, of an African Union-United Nations Hybrid operation in Darfur (UNAMID).

The UNAMID mandate will expire on 31 July 2008.

A meeting between the Security Council and the troop-contributing countries will take place prior to the expiration of the UNAMID mandate.

#### The Sudan – UNAMID (30-day report)

#### Resolution 1769 (2007) of 31 July 2007

Para. 6: requests the Secretary-General to report to the Security Council <u>every 30 days</u> on the status of implementation by the African Union-United Nations Hybrid Operation in Darfur (UNAMID) of the steps specified in paragraph 5 of the resolution, including on the status of financial, logistical and administrative arrangements for UNAMID and on the extent of UNAMID's progress toward achieving full operational capability.

#### S/PRST/2007/41 of 24 October 2007

Last para.: requests the Secretary-General, in his regular 30-day reports to the Security Council on UNAMID, to report also on progress being made on, and any obstacles to, the political process and the situation on the ground.

The 30-day report of the Secretary-General is expected to be issued by 31 July 2008.

#### The Sudan - UNMIS

#### Resolution 1812 (2008) of 30 April 2008

Para. 2: requests the Secretary-General to report to the Security Council <u>every 3 months</u> on the implementation of the mandate of the United Nations Mission in the Sudan (UNMIS), progress on implementation of the Comprehensive Peace Agreement (CPA), and respect for the ceasefire, and to provide an assessment and recommendations on measures UNMIS might take to further support elections, and to advance the peace process.

The report of the Secretary-General is expected to be issued by 31 July 2008.

#### **United Nations Office for West Africa (UNOWA)**

<u>Letter from the Council President to the Secretary-General of 21 December 2007 (S/2007/754)</u> Requests that the Secretary-General report to the Security Council <u>every 6 months</u> on the fulfilment by UNOWA of its revised mandate.

The report of the Secretary-General is expected to be issued by 9 July 2008.

#### Peace and Security in Africa

<u>Letter dated 11 June 2008 from the Permanent Representative of Djibouti to the United Nations addressed to the President of the Security Council (S/2008/387)</u>

#### Security Council Press Statement (SC/9376) of 25 June 2008

Para 6: Requests the Secretary-General to send a fact finding mission to the border between Djibouti and Eritrea.

Last para: Requests the Secretary-General to brief the Security Council on the situation, if possible under two weeks.

#### Peace and Security in Africa

<u>Letter dated 18 June 2008 from the Permanent Representative of Belgium to the United Nations addressed to the President of the Security Council (S/2008/407))</u>

#### S/PRST/2008/23 of 23 June 2008

Last para: Requests the Secretary-General to report on ongoing regional and international efforts to resolve the crisis.

#### ASIA

#### **Afghanistan**

Resolution 1806 (2008) of 20 March 2008

Para. 10: requests the Secretary-General to report to the Security Council on the outcome of the international conference, held in Paris in June 2008, to review progress on the implementation of the Afghanistan Compact and to include in this report, if necessary, further recommendations concerning the mandate of the United Nations Assistance Mission in Afghanistan (UNAMA).

The report of the Secretary-General is expected to be issued by mid-July 2008.

#### Iraq - UNAMI

Resolution 1770 (2007) of 10 August 2007

Para. 6: requests the Secretary-General to report to the Council <u>on a quarterly basis</u> on the progress made towards the fulfilment of all the responsibilities of the United Nations Assistance Mission for Iraq (UNAMI).

The report of the Secretary-General is expected to be issued by 31 July 2008.

#### Iraq – Oil-for-food programme

Letter from the Council President to the Secretary-General of 23 May 2008 (S/2008/341) Requests that the Working Group reconvene at a convenient time during June 2008, with a view to receiving from the Secretary-General an update report as soon as possible in July 2008.

The report of the Secretary-General is expected to be issued by 31 July 2008.

### The situation in the Middle East, including the Palestinian Question

Resolution 1322 (2000) of 7 October 2000

Para. 7: invites the Secretary-General to continue to follow the situation and <u>to keep the</u> Security Council informed.

#### Middle East – Lebanon (resolution 1701 (2006))

Resolution 1773 (2007) of 24 August 2007

Para. 8: requests the Secretary-General to continue to report to the Security Council on the implementation of resolution 1701 (2006) every 4 months, or at any time as he deems appropriate.

The report of the Secretary-General dated 27 June 2008 (S/2008/425) is before the Security Council.

## Letter dated 22 November 2006 from the Secretary-General – UNMIN

Resolution 1796 (2008) of 23 January 2008

Para. 4: requests the Secretary-General to keep the Security Council <u>regularly informed</u> of progress in implementing this resolution.

The report of the Secretary-General is expected to be issued by mid-July 2008.

Para. 1: decides to renew the mandate of the United Nations Mission in Nepal (UNMIN) <u>until</u> 23 July 2008.

The UNMIN mandate will expire on 23 July 2008.

#### Timor-Leste - UNMIT

Resolution 1802 (2008) of 25 February 2008

Para. 16: requests the Secretary-General to submit to the Security Council <u>no later than 1 August 2008</u> a report which includes adjustments in the mandate and strength of the United Nations Integrated Mission in Timor-Leste (UNMIT).

The report of the Secretary-General is expected to be issued by 1 August 2008.

#### **EUROPE**

#### Georgia – UNOMIG

Resolution 1808 (2008) of 15 April 2008

Para. 17: requests the Secretary-General, in his next report on the situation in Abkhazia, to inform the Security Council on progress made in encouraging and supporting the parties in implementing measures to build confidence and to establish an intensive and meaningful dialogue, with a view to achieve a lasting and comprehensive settlement.

The report of the Secretary-General is expected to be issued by 25 July 2008.

Resolutions 1160 (1998), 1199 (1998), 1203 (1998), 1239 (1999) and 1244 (1999) – UNMIK Resolution 1244 (1999) of 10 June 1999

Para. 20: requests the Secretary-General to report to the Security Council <u>at regular intervals</u> on the implementation of the resolution.

The report of the Secretary-General is expected to be issued in early July 2008.

#### OTHER

#### Non-proliferation / Democratic People's Republic of Korea

Resolution 1718 (2006) of 14 October 2006

Para. 12(g): requests the Security Council Committee established pursuant to resolution 1718 (2006) to report <u>at least every 90 days</u> to the Security Council on its work, with its observations and recommendations, in particular on ways to strengthen the effectiveness of the measures imposed by paragraph 8 above.

The Chairman of the 1718 Committee is expected to report to the Security Council is expected to be issued in early July 2008.

#### Committee established pursuant to resolution 1540 (2004)

Resolution 1810 (2008) of 25 April 2008

Para. 7: requests the Committee established pursuant to resolution 1540 (2004) to complete its report as set out in paragraph 6 of resolution 1673 (2006), and to submit it to the Security Council as soon as possible but no later than 31 July 2008.

The report of the 1540 Committee is expected to be submitted to the Security Council <u>by 31 July</u> 2008.

#### Children and armed conflict

Resolution 1612 (2005) of 26 July 2005

Para. 8(a): decides that the Security Council Working Group on Children and Armed Conflict shall make recommendations to the Council on possible measures to promote the protection of children affected by armed conflict, including through recommendations on appropriate mandates for peacekeeping missions and recommendations with respect to the parties to the conflict.

The Chairman of the Working Group on Children and Armed Conflict is expected to report to the Security Council <u>during July 2008</u>.

#### **Security Council Annual Report**

Note by the President of the Security Council of 19 December 2007 (S/2007/749)

Para. 8: A draft introduction to the Annual Report of the Security Council to the General Assembly should continue to be prepared under the leadership and responsibility of the President of the Council for the month of July of each calendar year.
