SECURITY COUNCIL FOR THE MONTH OF SEPTEMBER 2009**

This tentative forecast of the programme of work of the Security Council has been prepared by the Secretariat for the President of the Council. The forecast covers in particular those matters that may be taken up during the month pursuant to earlier decisions of the Council. The fact that a matter is or is not included in the forecast carries no implication that it will or will not be taken up during the month: the actual programme of work will be determined by developments and the views of members of the Council.

AFRICA

Côte d'Ivoire – UNOCI and French forces

Resolution 1880 (2009) of 30 July 2009

Para. 31: requests the Secretary-General to inform the Security Council in early September 2009 of the publication of the provisional electoral list.

The Secretary-General is expected to report to the Security Council on the publication of the provisional electoral list in early September 2009.

Para. 21: requests the Secretary-General to continue to monitor progress on the achievement of the benchmarks referred to in annex 1 of his report dated 7 July 2009 (S/2009/344), encourages him to continue to refine and update them and to report to the Security Council.

Para. 25: requests the Secretary-General to report to the Security Council and troop-contributing countries before 30 September 2009 on updating the military concept of operations and rules of engagement of the United Nations Operation in Côte d'Ivoire (UNOCI).

Para. 31: requests the Secretary-General to provide a mid-term report by the end of September 2009 on the situation on the ground and of the preparation of the electoral process.

The report of the Secretary-General is expected to be issued by 30 September 2009.

Democratic Republic of the Congo – MONUC

Resolution 1856 (2008) of 22 December 2008

Para. 9: requests the Secretary-General to continue to report regularly, and at least every 3 months, on the situation in the Democratic Republic of the Congo and on the activities of the United Nations Organization Mission in the Democratic Republic of the Congo (MONUC), and to provide to the Security Council, with the same regularity, a specific update on the military situation.

The report of the Secretary-General is expected to be issued by 30 September 2009.

Liberia – UNMIL

Report of the Secretary-General of 10 February 2009 (S/2009/86)

Para. 68: states that a comprehensive technical assessment mission led by the Department of Peacekeeping Operations will need to be deployed to Liberia before the end of the current mandate period to develop more precise details regarding the next phase of the drawdown of the United Nations Mission in Liberia (UNMIL), and that based on the findings of the assessment mission, the Secretary-General intends to provide further recommendations on the third phase of the UNMIL drawdown in his next report.

The special report of the Secretary-General dated 10 June 2009 (S/2009/299) is before the Security Council.

Resolution 1836 (2008) of 29 September 2008

Para. 8: requests the Secretary-General to provide by 15 August 2009 a report covering progress made on the issues addressed in paragraphs 5 and 6 of the resolution during the period February 2009-August 2009.

Para. 5: requests the Secretary-General to report to the Security Council on progress on the core benchmarks detailed in his reports of 8 August 2007 (S/2007/479) and 19 March 2008 (S/2008/183), and any subsequent refinements of the benchmarks, and to include in his report, in consultation with the Government of Liberia, long-range scenarios for a phased drawdown and withdrawal of the troop contingent of the United Nations Mission in Liberia (UNMIL), as the situation permits and without compromising the security of Liberia.

Para. 6: requests the Secretary-General to include in his report a comprehensive assessment both of the progress made towards building the capacity of the Liberian National Police and of the contribution of UNMIL towards that goal, and to make recommendations on possible adjustments needed to UNMIL police training or concept of operations as appropriate.

The regular report of the Secretary-General dated 10 August 2009 (S/2009/411) is before the Security Council.

The UNMIL mandate will expire on 30 September 2009.

A meeting between the Security Council and the troop-contributing countries will take place before the expiry of the UNMIL mandate.

Sierra Leone – UNIPSIL

Resolution 1829 (2008) of 4 August 2008

Para. 9: requests that the Secretary-General keep the Security Council informed every 4 months on the implementation of the mandate of the United Nations Integrated Peacebuilding Office in Sierra Leone (UNIPSIL), and the present resolution.

The report of the Secretary-General is expected to be issued by mid-September 2009.

Para. 1: requests the Secretary-General to establish UNIPSIL for a period of 12 months.

The UNIPSIL mandate will expire on 1 October 2009.

Somalia – peacebuilding and peacekeeping

S/PRST/2001/30 of 31 October 2001

Penultimate para: requests the Secretary-General to submit reports, at least every 4 months, on the situation in Somalia and the efforts to promote the peace process.

Resolution 1872 (2009) of 26 May 2009

Para. 3: requests the Secretary-General to include in his next report recommendations on ways to strengthen the Djibouti peace process.

Para. 17: requests the Secretary-General to include in the reports requested in paragraph 13 an update on the deployment of a logistical support package for the African Union Mission in Somalia (AMISOM).

Para. 13: requests the Secretary-General to take the steps identified in paragraphs 82 to 86 of his report of 16 April 2009 (S/2009/210), subject to the conditions in his report, and to report on progress by 30 September 2009.

The report of the Secretary-General is expected to be issued by 30 September 2009.

The Sudan – Sanctions Committee

Resolution 1591 (2005) of 29 March 2005

Para. 3(a)(iv): decides that the Security Council Committee established pursuant to resolution 1591 (2005) shall report at least every 90 days to the Security Council on its work.

The Chairman of the 1591 Committee is expected to report to the Security Council during September 2009.

The Sudan – Panel of Experts

Resolution 1841 (2008) of 15 October 2008

Para. 2: requests the Panel of Experts to provide to the Security Council, no later than 30 days prior to termination of its mandate, a final report with its findings and recommendations.

Para. 1: decides to extend until 15 October 2009 the mandate of the Panel of Experts.

The final report of the Panel of Experts is expected to be submitted by 15 September 2009.

Peace and security in Africa – support for AU peacekeeping

S/PRST/2009/3 of 18 March 2009

Para. 8: requests the Secretary-General to submit a report, no later than 18 September 2009, on practical ways to provide effective support for the African Union (AU) when it undertakes peacekeeping operations authorized by the United Nations, that includes a detailed assessment of the recommendations contained in the Report of the African Union-United Nations Panel (S/2008/813), in particular those on financing, as well as on the establishment of a joint African Union-United Nations team, and lessons-learned from past and current AU peacekeeping efforts.

The report of the Secretary-General is expected to be issued by 18 September 2009.

Para. 12: expresses the intention of the Security Council to further consider this issue following the report of the Secretary-General.

AMERICAS

Haiti – MINUSTAH

Resolution 1840 (2008) of 14 October 2008

Para. 27: requests the Secretary-General to report to the Security Council on the implementation of the mandate of the United Nations Stabilization Mission in Haiti (MINUSTAH) semi-annually and not later than 45 days prior to its expiration.

The report of the Secretary-General is expected to be issued during September 2009.

ASIA

Afghanistan – UNAMA

Resolution 1868 (2009) of 23 March 2009

Para. 36: requests the Secretary-General to report to the Security Council every 3 months on developments in Afghanistan.

S/PRST/2009/21 of 15 July 2009

Last para.: expresses the hope of the Security Council that finalized benchmarks for measuring and tracking progress in the implementation of the mandate and priorities of the United Nations Assistance Mission in Afghanistan (UNAMA) will be included in the next report of the Secretary-General.

The report of the Secretary-General is expected to be issued during September 2009.

Iraq – report on relevant resolutions

Resolution 1859 (2008) of 22 December 2008

Para. 5: decides to review resolutions pertaining specifically to Iraq, beginning with the adoption of resolution 661 (1990), and in that regard, requests the Secretary-General to report, after consultations with Iraq, on facts relevant to consideration by the Security Council of actions necessary for Iraq to achieve international standing equal to that which it held prior to the adoption of such resolutions.

The report of the Secretary-General dated 27 July 2009 (S/2009/385) is before the Security Council.

The situation in the Middle East, including the Palestinian question

Resolution 1322 (2000) of 7 October 2000

Para. 7: invites the Secretary-General to continue to follow the situation and to keep the Security Council informed.

Timor-Leste – UNMIT

Resolution 1867 (2009) of 26 February 2009

Para. 17: requests the Secretary-General to keep the Security Council regularly informed of the developments on the ground and on the implementation of the resolution, and to submit to the Council, no later than 30 September 2009, a report reviewing the transfer of policing responsibilities from the United Nations Integrated Mission in Timor-Leste (UNMIT) to the Policia Nacional de Timor-Leste (PNTL).

The report of the Secretary-General is expected to be issued by 30 September 2009.

EUROPE

Resolutions 1160 (1998), 1199 (1998), 1203 (1998), 1239 (1999) and 1244 (1999) – UNMIK

Resolution 1244 (1999) of 10 June 1999

Para. 20: requests the Secretary-General to report to the Security Council at regular intervals on the implementation of the resolution.

The report of the Secretary-General is expected to be issued by 30 September 2009.

OTHER

Non-proliferation – Iran

Resolution 1737 (2006) of 23 December 2006

Para. 18(h) decides that the Committee established pursuant to resolution 1737 (2006) shall report at least every 90 days to the Security Council on its work and on the implementation of this resolution, with its observations and recommendations.

The Chairman of the 1737 Committee is expected to report to the Security Council during September 2009.

Non-proliferation / DPRK

Resolution 1874 (2009) of 12 June 2009

Para. 26: requests the Secretary-General to create for an initial period of one year, in consultation with the Committee, a group of up to seven experts ("Panel of Experts"), acting under the direction of the Committee established pursuant to resolution 1718 (2006) to carry out tasks including to provide an interim report on its work to the Council no later than 90 days after adoption of this resolution.

The interim report of the Panel of Experts is expected to be submitted by 12 September 2009.

Women and peace and security

S/PRST/2008/39 of 29 October 2008

Last para.: requests the Secretary-General to provide a report on the implementation of resolution 1325 (2000) over the coming year, including information on the impact of armed conflict on women and girls in situations of which the Security Council is seized; on the obstacles and challenges to strengthening women's participation in conflict prevention, conflict resolution and peacebuilding; and recommendations to address those issues, to be submitted to the Security Council by October 2009.

The regular report of the Secretary-General is expected to be issued by 30 September 2009.

Security Council Annual Report

Note by the President of the Security Council of 19 December 2007 (S/2007/749)

Para. 8: A draft introduction to the Annual Report of the Security Council to the General Assembly should continue to be prepared under the leadership and responsibility of the President of the Council for the month of July of each calendar year.

The drafting of the introduction to the Annual Report is expected to continue during September 2009.
