I have the honour to refer to the final report of the Group of Experts on the Democratic Republic of the Congo (S/2009/603) and to convey, in the enclosure annexed herewith, supplementary information on members of FDLR or RUD-Urunana who were cited in the report of the Group of Experts, for the future consideration of the Security Council Committee established pursuant to resolution 1533 (2004).

Let me take this opportunity to underline that my Government requests the Committee's action, pursuant to paragraph 19 of resolution 1896 (2009), and I would welcome an opportunity to further brief the Committee on this subject, pursuant to paragraph 4 (c) of resolution 1896 (2009), should the Committee so deem necessary and appropriate.

In this connection, I wish to recall that on 15 May 2008, Rwanda conveyed to the Committee a list of 19 individuals for targeted sanctions, of whom the Committee listed four individuals. Let me take this opportunity to reiterate my Government's keen interest that the Committee consider imposing targeted sanctions on the remaining 15 individuals.

Let me also take this opportunity to recall recommendation No. 1 in the final report of the Group of Experts (see S/2009/603, para. 378), by which the Group called upon Member States to adopt a coordinated and consistent approach in their efforts to dismantle the FDLR support networks using their territories as a rear base. My Government looks forward to the Committee's support in this regard.

**SUPPLEMENTARY INFORMATION REGARDING MEMBERS OF
THE FDLR, RUD-URUNANA AND OTHER INDIVIDUALS CITED
IN THE FINAL REPORT OF THE GROUP OF EXPERTS**
(S/2009/603)

1. Lt. Col. NIZEYIMANA Wenceslas (*Paragraph 66, page 18 of the Group's final report*)



Lt. Col. Nizeyimana Wenceslas is the Deputy military Commander of RUD-Urunana. He is personally responsible for crimes committed by RUD troops under his command including killings, abductions, rape, lootings, recruitment of child soldiers, sexual abuses, illegal trade, mining and taxation, arms proliferation and other crimes.

According to paragraph 66 of the Group's report, Col Nizeyimana was instrumental in organizing the visit of FDLR president, Ignace Murwanashyaka, to Uganda in 2006, in violation of the latter's travel ban imposed in November 2005. During this well documented visit, Mr. Murwanashyaka had subsequently been transported from the DRC-Uganda border at Kasindi to areas around Kasugho.

Through the Group's consultations with active officers and demobilized RUD-URUNANA elements, it emerged that hundreds of recruits have been sourced by RUD-URUNANA and FDLR networks since January 2009 from refugee camps in Uganda, near the border with DRC, in particular the camps of Nyakivale and Cyaka. Information received by the Group cites waves of recruitment in May, June, September and October 2009. Col. Wenceslas Nizeyimana, alias Peter Kabasha – Bahati Patrick, a former FDLR liaison officer in Kampala is one of the key organizers of these recruitments.

 - In 2001, he was named the deputy commander of the brigade known as Roquette which was under the command of Musare. This brigade operated in North Kivu, especially in Rutchuru and Walikale.
 - In March 2004, he was appointed as RUD-Urunana's liaison officer based in Kampala with the rank of Major.
 - He is implicated in the death of the Belgian UN soldiers killed in camp Kigali where he was based then.

2. **Maj. Willy Guillaume Simba** (*paragraphs 348 and 349 of the Group's final report*)

Maj. Willy Guillaume Simba is known in FDLR rank and file as Capt. Pierre-Celestin RURAKABIJE alias Simba Guillaume. He commands FOCA 1st Company of 3Bn/Reserve Bde which is commanded by Lt. Col. Deo NIYTEGEKA alias Gerard Rutebuka/Rubura Rugwa. This Bn operates in Ramba/Bunyakiri general area along Masisi-Kalehe border.

In addition to Maj. Willy Guillaume Simba whom the UN Group of experts on DRC proposed for sanctioning, Lt. Cols. Lucien NZABANITA, *alias Karume Andre* and Deo NIYTEGEKA *alias Gerard Rutebuka/Rubura Rugwa* Comdrs of FOCA Reserve Bde and 3Bn/Reserve respectively should also be included on the proposed sanctions list since they are his immediate superior Comdrs. As a

Company Comdr, Guillaume Willy receives orders and executes tasks from his Bn Comdr, which are orders from the Reserve Bde Comdr.

3. Lt. Col. Deo Niyitegeka alias Gerard Rutebuka/Rubura Rugwa

Lt. Col. Niyitegeka served in different capacities in FOCA. Prior to his appointment as the Comdr of FDLR 3Bn/Reserve Bde in 2007, he commanded a company of FOCA Military Police operating in South Kivu Province. He is a senior planner for FDLR 3Bn/Reserve Bde activities, and a propagandist, responsible for crimes committed by all troops under his command including killings, abductions, rape, lootings, recruitment of child soldiers, sexual abuses, illegal trade, mining and taxation, arms proliferation and other crimes committed in the area under his control.

Known biometric data

He was born in 1964 in former commune Rambura currently Nyabihu District, Western Province. He is married to Nyirinjeneri Jacqueline who currently lives in Zambia with their children. He fled to DRC in July 1994 at a rank of 2Lt.

4. Lt Col Lucien Nzabanita (*Paragraph 54, page 15 of the Group's final report*)

Lt. Col Lucien Nzabanita is the commander of the FDLR's notorious Reserve Brigade. He is a senior planner for FDLR activities and a propagandist responsible for crimes committed by all troops under his command including killings, abductions, rape, lootings, recruitment of child soldiers, sexual abuses, illegal trade, mining and taxation, arms proliferation and other crimes committed in the area under his control.

5. **Juan CARRERO** (*Paragraphs 112, 114 and 115, pages 29 & 30 of the Group's final report*)

Juan Carrero is a Spanish citizen, who runs an organization called Fundació S'Olivar. Fundació S'Olivar and Inshuti have been supporting FDLR, through regular financial, logistical and political support. These organizations run by Juan Carrero host a link to FDLR website enabling the FDLR political propaganda. These organizations also provide support to FDLR linked organizations in Kigoma and Uvira. Mr. Carrero has taken part in political activities with Felicien Kanyambwa, now the USA based Executive Secretary of RUD-URUNANA.

Documents show that Fundació S'Olivar received 198,000 euros between 2001 and 2008 from the Fons Mallorquí de Solidaritat i Cooperació, a trust established by various mayoral offices in the Islas Baleares, in order to sustain the prosecution of officials of the Rwandan Patriotic Front (RPF) through the Spanish courts, which funds have ended in supporting FDLR through the local NGOs in Kigoma and Uvira.
