AFRICA

CAR: Sanctions: Secretariat to provide options for elaboration of benchmarks to assess arms embargo and information on recommended working group

Resolution 2339 (2017) of 27 January 2017

Para. 29: Requests the Secretariat to provide to the Security Council, by 30 May 2017, options for the elaboration of benchmarks, in coordination with EUTM and other active partners in the field of SSR and in consultation with the CAR Authorities, to assess the arms embargo measures according to the progress of the SSR, including FACA and Internal Security Forces and their needs, as well as additional information on the Panel of Experts' recommended arms embargo working group to be potentially established within MINUSCA by the Security Council, including on the composition, tasks, functioning, resource requirements and implication with regards the implementation of MINUSCA's mandate, of such a working group, with reference to previous similar experiences in other UN Peacekeeping Missions;

The Secretariat is expected to provide options by 30 May 2017.

Central African region: SG reports on UNOCA

S/PRST/2015/12 of 11 June 2015

Last para.: The Security Council requests that the Secretary-General keep it informed through a report on the situation in Central Africa and UNOCA's activities to be submitted before 30 November 2015 and every six months thereafter, on the activities of UNOCA, progress made in conducting assessments of the LRA's evolving area of operations and logistical and support networks, and the efforts being undertaken respectively by missions in the region and relevant United Nations agencies to implement the UN's Regional Strategy.

The report of the Secretary-General is expected to be issued in May 2017.

DRC: SG to update SC in writing on implementation of the 31 December 2016 agreement

Resolution 2348 (2017) of 31 March 2017

Para. 53: Requests the Secretary-General to update the Security Council in writing every 45 days on political and technical progress and obstacles to the implementation of the 31 December 2016 agreement, when no regular reports are due;

The report of the Secretary-General is expected in May 2017.

Libya: ICC Prosecutor briefing

Resolution 1970 (2011) of 26 February 2011

Para.7: Invites the Prosecutor to address the Security Council within two months of the adoption of this resolution and every six months thereafter on actions taken pursuant to this resolution.

The ICC Prosecutor is expected to brief in May 2017.

Somalia: UNSOM: SG reports on the implementation of resolution 2275 (2016)

Resolution 2275 (2016) of 24 March 2016

Para.22: Requests the Secretary-General to keep the Security Council regularly informed on the implementation of this resolution, including through oral updates and no fewer than three written reports, with the first written report by 12 May 2016 and every 120 days thereafter;

The report of the Secretary-General is expected to be issued in May 2017.

Somalia: AMISOM: SG reports on the implementation of resolution 2297 (2016)

Resolution 2297 (2016) of 7 July 2016

Para.44: Requests the Secretary-General to keep the Security Council regularly informed on the implementation of this resolution, including through oral updates and no fewer than three written reports, with the first written report by 12 September 2016, and every 120 days thereafter;

The report of the Secretary-General is expected to be issued in May 2017.

Somalia: AMISOM mandate

Resolution 2297 (2016) of 7 July 2016

Para.4: Decides to authorize the Member States of the AU to maintain the deployment of AMISOM up to a maximum level of 22,126 uniformed personnel until 31 May 2017, and further decides that AMISOM shall be authorized to take all necessary measures, in full compliance with participating States' obligations under international humanitarian law and international human rights law, and in full respect of the sovereignty, territorial integrity, political independence and unity of Somalia, to carry out its mandate;

The mandate will expire on 31 May 2017.

Somalia: AU oral updates and written reports on implementation of AMISOM mandate

Resolution 2297 (2016) of 7 July 2016

Para.18: Requests the AU to keep the Security Council regularly informed, through the Secretary-General, on the implementation of AMISOM's mandate, and report to the Council, through the provision of oral updates and no fewer than three written reports, every 120 days with the first written report no later than 12 September 2016;

South Sudan: SG to provide detailed information on UNMISS force, impediments and obstructions

Resolution 2327 (2016) of 16 December 2016

Para.31: Requests that the Secretary-General provide detailed information within 30 days on force generation, restructuring of the UNMISS force, logistical support and enablers, and civilian personnel to implement the mandate, as well as whether the TGNU has maintained its consent in principle to deployment of the RPF and not imposed any political or operational impediments to operationalizing the RPF or obstructed UNMISS in the performance of its mandate, and requests the Secretary-General to review needs on the ground, and provide an updated assessment of the RPF's operations, deployment, and future requirements, as well as any political or operational impediments to operationalizing the RPF

and obstructions to UNMISS in performance of its mandate, within 30 days after the adoption of this resolution, and every 30 days thereafter;

The report of the Secretary-General is expected in May 2017.

Sudan/South Sudan: UNISFA mandate

Resolution 2318 (2016) of 15 November 2016

Para.1: Decides to extend until 15 May 2017 the mandate of the United Nations Interim Security Force for Abyei (UNISFA) as set out in paragraph 2 of resolution 1990 (2011) and modified by resolution 2024 (2011) and paragraph 1 of resolution 2075 (2012), and acting under Chapter VII of the Charter of the United Nations, further decides to extend until 15 May 2017 the tasks of UNISFA as set out in paragraph 3 of resolution 1990 (2011), and determines that for the purposes of paragraph 1 of resolution 2024 (2011), support to the operational activities of the JBVMM shall include support to the Ad Hoc Committees, as appropriate when so requested by consensual decisions of these mechanisms, within UNISFA's operational area and existing capabilities;

The mandate will expire on 15 May 2017.

South Sudan: Sanctions: Travel ban and assets freeze

Resolution 2290 (2016) of 31 May 2016

Para.7: Decides to renew until 31 May 2017 the travel and financial measures imposed by paragraphs 9 and 12 of resolution 2206 (2015), and reaffirms the provisions of paragraphs 10, 11, 13, 14 and 15 of resolution 2206 (2015);

The measures on travel ban and asset freeze will expire on 31 May 2017.

ASIA/MIDDLE EAST

Iraq: SG reports on UNAMI

Resolution 2299 (2016) of 25 July 2016

Para.6: Requests the Secretary-General to report to the Council every three months on the progress made towards the fulfilment of all UNAMI's responsibilities;

The report of the Secretary-General dated 25 April (S/2017/357) is before the Security Council.

Iraq/Kuwait: missing persons and return of property

Resolution 2107 (2013) of 27 June 2013

Para.4: requests that the Special Representative of the Secretary-General and Head of the United Nations Assistance Mission to Iraq (UNAMI) promote, support and facilitate efforts regarding the repatriation or return of all Kuwaiti and third country nationals or their remains, and the return of Kuwaiti property, including the national archives, seized by Iraq, further requests the Secretary-General to report separately to the Security Council on these matters in his reports on the progress made towards the fulfilment of all UNAMI's responsibilities...;

The report of the Secretary-General dated 28 April 2017 (S/2017/371) is before the Security Council.

Middle East (Lebanon): SG reports on resolution 1559 (2004)

Resolution 1559 (2004) of 2 September 2004

Para.7: Requests that the Secretary-General report to the Security Council within thirty days on the implementation by the parties of this resolution and decides to remain actively seized of the matter.

S/PRST/2004/36 of 19 October 2004

Last para.: The Security Council appreciates the Secretary-General's intention to keep the Council updated. It requests that he continue to report on the implementation of the resolution to the Council every six months.

The report of the Secretary-General dated 28 April 2017 (S/2017/374) is before the Security Council.

Middle East (Syria): OPCW DG to report to SC (through SG) on impl. of resolution 2118 (2013)

Resolution 2118 (2013) of 27 September 2013

Para.12: Decides to review on a regular basis the implementation in the Syrian Arab Republic of the decision of the OPCW Executive Council of 27 September 2013 and this resolution, and requests the Director-General of the OPCW to report to the Security Council, through the Secretary-General, who shall include relevant information on United Nations activities related to the implementation of this resolution, within 30 days and every month thereafter, and requests further the Director-General of the OPCW and the Secretary-General to report in a coordinated manner, as needed, to the Security Council, non-compliance with this resolution or the OPCW Executive Council decision of 27 September 2013.

The report is expected to be presented in May 2017.

Middle East (Syria): SG to report on implementation of resolutions 2139 (2014), 2165 (2014), 2191 (2014), 2258 (2015) and 2332 (2016)

Resolution 2139 (2014) of 22 February 2014

Para.17: Requests the Secretary-General to report to the Council on the implementation of this resolution by all parties in Syria, in particular paragraphs 2 through 12, in 30 days of its adoption and every 30 days thereafter, and upon receipt of the Secretary-General's report, expresses its intent to take further steps in the case of non-compliance with this resolution;

Resolution 2191 (2014) of 17 December 2014

Para.5: Requests the Secretary-General to report to the Council on the implementation of this resolution, and on compliance by all parties to the Syrian domestic conflict, within the framework of its reporting on resolutions 2139 (2014) and 2165 (2014);

Resolution 2258 (2015) of 22 December 2015

Para.5: Requests the Secretary-General to report to the Council on the implementation of this resolution, and on compliance by all relevant parties in Syria, within the framework of its reporting on resolutions 2139 (2014), 2165 (2014) and 2191 (2014), and further requests the Secretary-General to include in his reports overall trends in humanitarian access;

Resolution 2332 (2016) of 21 December 2016

Para.5: Requests the Secretary-General to report to the Council on the implementation of this resolution, and on compliance by all relevant parties in Syria, within the framework of its reporting on resolutions 2139 (2014), 2165 (2014), 2191 (2014) and 2258 (2015), and further requests the Secretary-General to include in his reports overall trends in humanitarian access;

The report of the Secretary-General is expected to be issued in May 2017.

Middle East (Syria): SG report on the implementation of resolution 2268 (2016)

Resolution 2268 (2016) of 26 February 2016

Para.10: Requests the Secretary-General to report to the Council on the implementation of this resolution, including by drawing on information provided by the ISSG ceasefire taskforce, and on resolution 2254 (2015), within 15 days of the adoption of this resolution and every 30 days thereafter;

The Secretary-General is expected to report in May 2017.

Middle East: The situation in the Middle East, including the Palestinian question

Resolution 1322 (2000) of 7 October 2000

Para.7: Invites the Secretary-General to continue to follow the situation and to keep the Security Council informed.

Middle East (Yemen): SG to report on the implementation of resolution 2201 (2015) and on developments in Yemen

Resolution 2201 (2015) of 15 February 2015

Para.13: Requests the Secretary-General to report on the implementation of this resolution, and to continue to report on developments in Yemen, including on the implementation of the Gulf Cooperation Council Initiative and its Implementation Mechanism, the outcomes of the comprehensive National Dialogue conference, and the Peace and National Partnership Agreement and its security annex within 15 days after the date of adoption of this resolution and every 60 days thereafter;

The Secretary-General is expected to report in May 2017.

EUROPE

BiH: Reports of High Representative to SC thru SG

Resolution 2183 (2014) of 11 November 2014

Para.20: Also requests the Secretary-General to continue to submit to the Council reports from the High Representative, in accordance with annex 10 of the Peace Agreement and the conclusions of the Peace Implementation Conference held in London on 4 and 5 December 1996 (S/1996/1012), and later Peace Implementation Conferences, on the implementation of the Peace Agreement and in particular on compliance by the parties with their commitments under that Agreement;

The letter from the Secretary-General dated 28 April 2017 (S/2017/379) is before the Security Council.

BiH: EUFOR ALTHEA/NATO reports to SC

Resolution 2183 (2014) of 11 November 2014

Para.18: Requests the Member States acting through or in cooperation with the EU and the Member States acting through or in cooperation with NATO to report to the Council on the activity of EUFOR ALTHEA and NATO Headquarters presence respectively, through the appropriate channels and at least at six-monthly intervals;

The letter from the Secretary–General dated 28 April 2017 (S/2017/378) is before the Security Council.

UNMIK: SG report

Resolution 1244 (1999) of 10 June 1999

Para.20: Requests the Secretary-General to report to the Council at regular intervals on the implementation of this resolution, including reports from the leaderships of the international civil and security presences, the first reports to be submitted within 30 days of the adoption of this resolution;

The report of the Secretary–General is expected to be issued in May 2017.

OTHER

Cooperation between UN and regional/subregional organizations: Invites AU to update SC on AU peace support operations

Resolution 2320 (2016) of 18 November 2016

Para.7: Expresses its readiness to consider the proposals of the AU, for future authorization and support by the Security Council for AU peace support operations authorized by the Security Council and under the Security Council's authority under Chapter VIII of the Charter, including on financing and accountability, and in this regard, invites the AU to update the Security Council within six months of the adoption of this resolution, regarding the details of the proposed scope of peace operations to be considered; the progress, benchmarks, and timelines for implementation of the AU Peace Fund, consistent with applicable international obligations, as well as accountability, transparency, and compliance frameworks for AU peace support operations;

Cooperation between UN and regional/subregional organizations: SG to continue working closely with the AU to refine options for further cooperation on the relevant AU proposals for support for AU peace support operations and provide the SC with a detailed report

Resolution 2320 (2016) of 18 November 2016

Para.8: Requests the Secretary-General to continue working closely with the AU to refine options for further cooperation on the relevant AU proposals, including joint planning and the process for mandating AU peace support operations, subject to authorization by the Security Council and to provide the Security Council with a detailed report within six months of the adoption of this resolution;

The report of the Secretary-General is expected to be issued in May 2017.

Cooperation between UN and regional/subregional organizations: SG to include in regular reporting assessments of progress on the cooperation between the UN and relevant regional organizations

Resolution 1809 (2008) of 16 April 2008

Para.17: Requests the Secretary-General to include in his regular reporting to the Security Council, assessments of progress on the cooperation between the United Nations and relevant regional organizations;

The report of the Secretary–General dated 15 July 2016 (S/2016/621) is before the Security Council.

Counter-Terrorism Committee: CTC to present proposal to SC for a comprehensive international framework to counter narratives to encourage, motivate and recruit to commit terrorist acts

S/PRST/2016/6 of 11 May 2016

Last para.: The Security Council, accordingly, requests the Counter-Terrorism Committee, in close consultations with the CTED and other relevant United Nations bodies and international and regional organizations in particular the CTITF office, as well as interested Member States, to present a proposal to the Security Council by 30 April 2017 for a “comprehensive international framework”, with recommended guidelines and good practices to effectively counter, in compliance with international law, the ways that ISIL (Da’esh), Al - Qaida and associated individuals, groups, undertakings and entities use their narratives to encourage, motivate, and recruit others to commit terrorist acts, including with a counter narrative campaign, consistent with any similar campaign undertaken by the United Nations, as well as options for coordinating the implementation of the framework and mobilizing resources as necessary, emphasizing, in that regard, the primary role of Member States with regard to activities and arrangements consistent with such framework and welcoming their continuing efforts to enhance inter agency cooperation and coordination and establish relevant partnerships with private sector, civil society, religious, educational and cultural institutions with a view to countering the narratives of terrorist groups and incitement to commit terrorist acts.

The letter from the Chair of the 1373 Committee dated 26 April is before the Security Council.

ISIL (Da’esh) and Al-Qaeda: SG strategic-level reports

Resolution 2253 (2015) of 17 December 2015

Para.97: Recalling the threat posed to international peace and security by ISIL and associated individuals, groups, undertakings, and entities, requests the Secretary-General to provide an initial strategic-level report that demonstrates and reflects the gravity of the aforementioned threat, including foreign terrorist fighters joining ISIL and associated groups and entities, and the sources of financing of these groups including through illicit trade in oil, antiquities, and other natural resources, as well as their planning and facilitation of attacks, and reflects the range of United Nations efforts in support of Member States in countering this threat, in 45 days and provide updates every four months thereafter, with the input of CTED, in close collaboration with the Monitoring Team, as well as other relevant United Nations actors;

The report of the Secretary-General is expected to be issued in May 2017.

ICTY: Assessments by President/Prosecutor

Resolution 1534 (2004) of 26 March 2004

Para.6: Requests each Tribunal to provide to the Council, by 31 May 2004 and every six months thereafter, assessments by its President and Prosecutor, setting out in detail the progress made towards implementation of the Completion Strategy of the Tribunal, explaining what measures have been taken to implement the Completion Strategy and what measures remain to be taken, including the transfer of cases involving intermediate and lower rank accused to competent national jurisdictions; and expresses the intention of the Council to meet with the President and Prosecutor of each Tribunal to discuss these assessments.

The assessments by the ICTY President and Prosecutor are expected to be provided in May 2017.

Joint briefings by 3 Committees (CTC, 1267 & 1540)

Resolution 2325 (2016) of 15 December 2016

Para. 27: Reiterates the need to continue to enhance ongoing cooperation among the 1540 Committee, the Security Council Committee established pursuant to resolutions 1267 (1999) 1989 (2001) and 2253 (2015) concerning ISIL (Da'esh), Al-Qaida, and associated individuals, groups, undertakings and entities, and the Security Council Committee established pursuant to resolution 1373 (2001), concerning counter-terrorism, including through, as appropriate, enhanced information sharing, coordination on visits to States, within their respective mandates, technical assistance and other issues of relevance to all three committees, and again expresses its intention to provide guidance to the committees on areas of common interest in order to better coordinate their efforts, and decides the three Committees will jointly brief once per year the Security Council on their cooperation;

The Chairs of the CTC, 1267 & 1540 Committees are expected to brief in May 2017.

Non-proliferation/DPRK: Sanctions: 1718 Committee reports

Resolution 1718 (2006) of 14 October 2006

Para.12: Decides to establish, in accordance with rule 28 of its provisional rules of procedure, a Committee of the Security Council consisting of all the members of the Council, to undertake the following tasks:

(g) To report at least every 90 days to the Security Council on its work, with its observations and recommendations, in particular on ways to strengthen the effectiveness of the measures imposed by paragraph 8 above.

The Chair of the 1718 Committee is expected to brief in May 2017.

Peacekeeping operations: SG report on the role of policing

Resolution 2185 (2014) of 20 November 2014

Para.33: Requests the Secretary-General to submit a report by the end of 2016 on the role of policing as an integral part of peacekeeping and post-conflict peacebuilding, with particular focus on the challenges faced by Police Components of United Nations peacekeeping operations and special political missions, and making recommendations on how best to strengthen their contribution to the achievement of mission mandates.

The report of the Secretary-General dated 10 November 2016 (S/2016/952) is before the Security Council.

Peacekeeping operations: Report and recommendations on the progress of partnerships between the UN and relevant regional organizations in peacekeeping operations

Resolution 2167 (2014) of 28 July 2014

Para.28: Requests the Secretary-General, in close consultation with the AU Commission and EU to produce, not later than 31 March 2015, an assessment report and recommendations on the progress of the partnerships between the UN and relevant regional organizations in peacekeeping operations;

The report of the Secretary-General dated 1 April 2015 (S/2015/229) is before the Security Council.

Protection of civilians in armed conflict: SG reports to SC

S/PRST/2015/23 of 25 November 2015

Last para.: The Security Council takes note of with appreciation the report of the Secretary-General on the protection of civilians in armed conflict of 18 June 2015 (S/2015/453) and the recommendations contained therein, and reiterates the need for systematic monitoring and reporting on the protection of civilians in armed conflict, and the challenges and progress made in this regard. The Security Council requests the Secretary-General to submit his next report on the protection of civilians in armed conflict by 15 May 2016 and to submit future reports every 12 months thereafter, to be formally considered by the Security Council each year within the same General Assembly session.

The report of the Secretary-General is expected to be issued in May 2017.

Protection of civilians in armed conflict: (Health care in armed conflict): SG briefing on the implementation of resolution 2286

Resolution 2286 (2016) of 3 May 2016

Para. 14: Further requests the Secretary-General to brief the Security Council every twelve months on the implementation of this resolution.

The Secretary-General is expected to brief the Security Council in May 2017.

Terrorism/Cross-border crime: SG report on UN efforts to address the threat of terrorists benefitting from transnational organized crime in affected regions

Resolution 2195 (2014) of 19 December 2014

Para.20: Requests the Secretary-General to submit to the Council a report on the efforts of the United Nations entities to address the threat of terrorists benefitting from transnational organized crime in affected regions, including Africa, with respect to matters with which the Council is seized, with input from the relevant entities of the United Nations system including the UNODC, CTED, the Analytical Support and Sanctions Monitoring Team, and other relevant CTITF entities;

Para.21: Further requests that the report include recommendations of concrete options for strengthening Member States' capabilities, including financing such proposed UN projects and activities to build capacity with existing resources and contributions in the UN system, as well as UN activities to reduce the negative impacts of terrorists benefitting from transnational organized crime including those relevant to its conflict resolution efforts with a focus on border security, counter-terrorist financing, and anti-money-laundering, and that the report be submitted to the Council no later than six months from the adoption of this resolution;

The report of the Secretary-General dated 21 May 2015 (S/2015/366) is before the Security Council.

Women and peace and security: Annual reports on the implementation of resolutions on WPS and resolution 2106 (2013) (SVC)

Resolution 2106 (2013) of 24 June 2013

Para.22: Requests that the Secretary-General continue to submit annual reports to the Council on the implementation of women and peace and security resolutions and the present resolution, and to submit his next report by March 2014;

The report of the Secretary-General dated 23 March 2017 (S/2017/249) is before the Security Council.
