**AFRICA**

**Central African region- SG report on situation in Central Africa and UNOCA's activities**

S/PRST/2015/12 of 11 June 2015

Last para.: Requests that the Secretary-General keep it informed through a report on the situation in Central Africa and UNOCA's activities to be submitted before 30 November 2015 and every six months thereafter, on the activities of UNOCA, progress made in conducting assessments of the LRA's evolving area of operations and logistical and support networks, and the efforts being undertaken respectively by missions in the region and relevant United Nations agencies to implement the UN's Regional Strategy.

The report of the Secretary-General is expected to be submitted before 30 November 2015.

**Libya – Sanctions: Panel of Experts interim report to SC**

Resolution 2213 (2015) of 27 March 2015

Para.24: (d) provide to the Council an interim report on its work no later than 180 days after the Panel's appointment, and a final report to the Council, after discussion with the Committee, no later than 15 March 2016 with its findings and recommendations;

The interim report of the Panel of Experts dated 2September 2015 is before the Security Council.

**Libya - UNSMIL: SG reports on the implementation of resolution 2238 (2015)**

Resolution 2238 (2015) of 10 September 2015.

Para.15: Requests the Secretary-General to report to the Security Council on the implementation of this resolution at least every 60 days;

The Secretary-General is expected to report to the Security Council in November 2015.

**Libya – ICC Prosecutor**

Resolution 1970 (2011) of 26 February 2011

Para.7: Invites the Prosecutor to address the Security Council within two months of the adoption of this resolution and every six months thereafter on actions taken pursuant to this resolution;

The ICC Prosecutor is expected to address the Security Council in November.

**Peace & Security in Africa – SG report and briefing on UN Integrated Strategy for the Sahel**  
S/PRST/2014/17 of 27 August 2014

Last para.: Requests the Secretary-General to inform it of the progress toward the implementation of the United Nations Integrated Strategy for the Sahel through an oral briefing by 15 December 2014, and through a report and a briefing no later than 30 November 2015;

A briefing and report of the Secretary-General are expected to be provided no later than 30 November 2015.

**Somalia – Sanctions: Somali Government reports to SC**

Resolution 2182 (2014) of 24 October 2014

Para.9: Urges the FGS to implement fully all its requirements as set out in this and other relevant Security Council resolutions, and requests the FGS to report to the Security Council by 30 March 2015, and then by 30 September 2015 on:

- (a) The current structure of the Security Forces of the Federal Government of Somalia;
- (b) The infrastructure in place to ensure the safe storage, registration, maintenance and distribution of military equipment by the Security Forces of the Federal Government of Somalia;
- (c) The procedures and codes of conduct in place for the registration, distribution, use and storage of weapons by the Security Forces of the Federal Government of Somalia, and on training needs in this regard;

The letter from the Permanent Representative of Somalia to the United Nations dated 29 September 2015 is before the Security Council.

**Somalia – Emergency Relief Coordinator reports**

Resolution 2182 (2014) of 24 October 2014

Para.42: Requests the Emergency Relief Coordinator to report to the Security Council by 1 October 2015 on the delivery of humanitarian assistance in Somalia and on any impediments to the delivery of humanitarian assistance in Somalia, and requests relevant United Nations agencies and humanitarian organizations having observer status with the United Nations General Assembly and their implementing partners that provide humanitarian assistance in Somalia to increase their cooperation and willingness to share information with the United Nations Humanitarian Aid Coordinator for Somalia in the preparation of such reports and in the interests of increasing transparency and accountability;

The letter from the Chair of the Security Council Committee pursuant to resolutions 751 (1992) and 1907 (2009) concerning Somalia and Eritrea dated 18 September 2015 (S/2015/731) is before the Security Council.

**Somalia – Piracy: SG report on piracy**

Resolution 2184 (2014) of 12 November 2014

Para.31: Requests the Secretary-General to report to the Security Council within eleven months of the adoption of this resolution on the implementation of this resolution and on the situation with respect to piracy and armed robbery at sea off the coast of Somalia;

The report from the Secretary-General dated 12 October 2015 (S/2015/776) is before the Security Council.

**Somalia - Piracy: Authorizations for states and regional organizations in the fight against piracy and armed robbery at sea**

Resolution 2184 (2014) of 12 November 2014

Para.13: Encourages Member States to continue to cooperate with Somali authorities in the fight against piracy and armed robbery at sea, notes the primary role of Somali authorities in the fight against piracy and armed robbery at sea off the coast of Somalia, and decides that, for a further period of twelve months from the date of this resolution to renew the authorizations as set out in paragraph 10 of resolution 1846 (2008) and paragraph 6 of resolution 1851 (2008), as renewed by paragraph 7 of resolution 1897 (2009), paragraph 7 of resolution 1950 (2010), paragraph 9 of resolution 2020 (2011), paragraph 12 of resolution 2077 (2012), and paragraph 12 of resolution 2125 (2013) granted to States and regional organizations cooperating with Somali authorities in the fight against piracy and armed robbery at sea off the coast of Somalia, for which advance notification has been provided by Somali authorities to the Secretary-General;

The authorizations will expire on 12 November 2015.

**Somalia – Sanctions: 751/1907 Committee (Somalia/Eritrea) briefings to SC**

Resolution 1844 (2008) of 20 November 2008

Para.11: Decides further to expand the mandate of the Committee as set out in resolution 751(1992) to include the following tasks:

(g) to report at least every 120 days to the Security Council on its work and on the implementation of this resolution, with its observations and recommendations, in particular on ways to strengthen the effectiveness of the measures imposed by paragraphs 1, 3 and 7 above.

The Chair of the Committee is expected to report to the Security Council in November 2015.

**South Sudan: SG reports on UNMISS**

Resolution 2241 (2015) of 9 October 2015

Para.35: Requests that the Secretary-General report to the Security Council on the implementation of the UNMISS mandate, as well as information on violations of the Status of Forces Agreement, including on UNMISS responses to any such violations, in a written report to be submitted no later than 45 days from adoption of this resolution;

The report of the Secretary-General is expected to be submitted no later than 23 November 2015.

**South Sudan: SG to review UNMISS mandate and provide an assessment and recommendations**

Resolution 2241 (2015) of 9 October 2015

Para.13: Requests the Secretary-General to conduct a review of the mandate, in light of the political and security situation in South Sudan, within 45 days from the adoption of this resolution, and to provide an assessment and recommendations, including resource requirements, for necessary civilian and force structure capabilities for UNMISS deployment and requirements in the context of implementation of the Agreement and to fulfil the mandate;

The assessment and recommendations of the Secretary- General are expected to be provided no later than 23 November 2015.

**South Sudan: SG assessment of security planning in Juba, and the appropriate role for the UN and report to SC with recommendations**

Resolution 2241 (2015) of 9 October 2015

Para.14: Recognizing the importance of security in Juba for successful implementation of the Agreement, requests the Secretary-General, in consultation with the Government of South Sudan and respective Troop- and Police-Contributing Countries, to conduct an assessment of security planning in Juba, and the appropriate role for the United Nations in providing support for security to key infrastructure in order to protect freedom of movement in Juba and report back to the Security Council with his recommendations in 45 days;

The report of the Secretary- General is expected to be provided no later than 23 November 2015.

**South Sudan: SG to assess actions undertaken in support of the SSNPS and submit recommendations to SC**

Resolution 2241 (2015) of 9 October 2015

Para.15: Requests the Secretary-General to assess actions already undertaken by UNMISS and other countries in support of the SSNPS and submit to the Security Council within 45 days of the date of adoption of this resolution recommendations on possible further support to the SSNPS as well as the Joint Integrated Police in support of implementation of the Agreement and consistent with the HRDDP;

The recommendations of the Secretary- General are expected to be provided no later than 23 November 2015.

**South Sudan – Sanctions: Panel of Experts updates**

Resolution 2206 (2015) of 3 March 2015

Para.18: (d) Provide to the Council, after discussion with the Committee, an interim report by September 1 2015, a final report by February 1 2016, and except in the months when these reports are due, updates each month;

A letter from the Chair of Security Council Committee established pursuant to resolution 2206 (2015) is expected to be provided in November 2015.

**Sudan/South Sudan – SG report on UNISFA**

Resolution 2230 (2015) of 14 July 2015

Para.27: Requests the Secretary-General to continue to inform the Council of progress in implementing UNISFA's mandate in two written reports, no later than 15 September 2015 and 15 November 2015 respectively, and continue to bring to the Council's immediate attention any serious violations of the above referenced Agreements, including on fulfilment of the conditions set out in paragraph 7 of this resolution regarding the JBVMM;

The report of the Secretary-General is expected to be issued no later 15 November 2015.

## **Sudan/South Sudan – SG to inform SC on status of compliance with resolution 2046 (2012)**

### Resolution 2046 (2012) of 2 May 2012

Para.6: Requests the Secretary-General to consult with the African Union on the implementation of this resolution and the decisions of the AU PSC, to work closely with the AUHIP in support of its facilitation efforts, and to inform the Security Council within 15 days and in two week intervals thereafter on the status of compliance by Sudan, South Sudan, and the SPLM-N with the decisions set forth in this resolution, and expresses its intention, in the event that any or all of the parties have not complied with the decisions set forth in this resolution, to take appropriate additional measures under Article 41 of the Charter as necessary.

### Note by the PSC of 11 November 2013 (S/2013/657)

Following consultations among the members of the Security Council, it has been agreed that issues pertaining to the Sudan and South Sudan, including the African Union/United Nations Hybrid Operation in Darfur (UNAMID), the United Nations Interim Security Force for Abyei (UNISFA), the United Nations Mission in South Sudan (UNMISS) and Council resolution 2046 (2012), will, as from 11 November 2013, be considered under the agenda item entitled “Reports of the Secretary-General on the Sudan and South Sudan”. In addition, members of the Security Council agreed to amend the reporting period established in paragraph 6 of resolution 2046 (2012) to one-month intervals.

### Note by the PSC of 21 August 2014 (S/2014/613)

Following consultations among the members of the Security Council, it has been agreed to amend the reporting period established in paragraph 6 of resolution 2046 (2012) and subsequently amended in a note by the President of the Security Council (S/2013/657) to three-month intervals.

The Secretary-General is expected to report to the Security Council in November 2015.

## **Sudan – Sanctions: 1591 Committee reports**

### Resolution 1591 (2005) of 29 March 2005

Para.3: Decides, in light of the failure of all parties to the conflict in Darfur to fulfil their commitments; (a) to establish, in accordance with rule 28 of its provisional rules of procedure, a Committee of the Security Council consisting of all the members of the Council (herein “the Committee”), to undertake to following tasks: iv. to report at least every 90 days to the Security Council on its work;

The Chair of the Committee is expected to report to the Security Council in November 2015.

## **ASIA/MIDDLE EAST**

## **Iraq – SG reports on UNAMI and on recommendation to revise and prioritize the tasks of UNAMI**

### Resolution 2233 (2015) of 29 July 2015

Para.7: Requests the Secretary-General to report to the Council every three months on the progress made towards the fulfilment of all UNAMI’s responsibilities;

The report of the Secretary-General dated 26 October 2015 (S/2015/819) is before the Security Council.

Para.3: Welcomes the recommendation of the Secretary-General in his latest report ([S/2015/530](#)) to revise and prioritize the tasks of UNAMI, requests the Secretary-General, in full consultations with the Government of Iraq, to report back in further detail about such recommendation to the Security Council within the next 90 days;

The Secretary-General is expected to report to the Security Council in November 2015.

**Middle East (Lebanon/UNIFIL) – SG reports on implementation of resolution 1701 (2006)**

Resolution 2236 (2015) of 21 August 2015

Para 12: Requests the Secretary-General to continue to report to the Council on the implementation of resolution 1701 (2006), every four months, or at any time as he deems appropriate;

The report of the Secretary-General is expected to be issued in November 2015.

**The situation in the Middle East, including the Palestinian question**

Resolution 1322 (2000) of 7 October 2000

Para.7: Invites the Secretary-General to continue to follow the situation and to keep the Security Council informed.

**Middle East (Syria) – OPCW to report (through SG) on implementation of resolution 2118 (2013)**

Resolution 2118 (2013) of 27 September 2013

Para.12: “Decides to review on a regular basis the implementation in the Syrian Arab Republic of the decision of the OPCW Executive Council of 27 September 2013 and this resolution, and requests the Director-General of the OPCW to report to the Security Council, through the Secretary-General, who shall include relevant information on United Nations activities related to the implementation of this resolution, within 30 days and every month thereafter, and requests further the Director-General of the OPCW and the Secretary-General to report in a coordinated manner, as needed, to the Security Council, non-compliance with this resolution or the OPCW Executive Council decision of 27 September 2013.”

The letter from the Secretary-General dated 26 October 2015 (S/2015/820) is before the Security Council.

**Middle East (Syria) – SG report on implementation of resolutions 2139 (2014), 2165 (2014) and 2191 (2014)**

Resolution 2139 (2014) of 22 February 2014

Para.17: Requests the Secretary-General to report to the Council on the implementation of this resolution by all parties in Syria, in particular paragraphs 2 through 12, in 30 days of its adoption and every 30 days thereafter, and upon receipt of the Secretary-General’s report, expresses its intent to take further steps in the case of non-compliance with this resolution;

Resolution 2191 (2014) of 17 December 2014

Para.5: Requests the Secretary-General to report to the Council on the implementation of this resolution, and on compliance by all parties to the Syrian domestic conflict, within the framework of its reporting on resolutions 2139 (2014) and 2165 (2014);

The report of the Secretary-General dated 22 October 2015 (S/2015/813) is before the Security Council.

**Middle East (Syria): SG report on consultations**

S/PRST/2015/15 of 17 August 2015

Last para.: The Security Council requests that the Secretary-General report back to the Security Council on the results of the next phase of consultations within 90 days.

The Secretary-General is expected to report to the Security Council in November 2015.

**Middle East (Syria): SG reports on Joint Investigative Mechanism**

Resolution 2235 (2015) of 7 August 2015

Para.10: Requests the United Nations Secretary-General, in coordination with the OPCW Director-General, to present a report to the United Nations Security Council and inform the OPCW Executive Council as of the date the Joint Investigative Mechanism begins its full operations and every 30 days thereafter on the progress made;

**EUROPE**

**Bosnia and Herzegovina – EUFOR ALTHEA mandate**

Resolution 2183 (2014) of 11 November 2014

Para.10: Authorizes the Member States acting through or in cooperation with the EU to establish for a further period of twelve months, starting from the date of the adoption of this resolution, a multinational stabilization force (EUFOR ALTHEA) as a legal successor to SFOR under unified command and control, which will fulfil its missions in relation to the implementation of annex 1-A and annex 2 of the Peace Agreement in cooperation with the NATO Headquarters presence in accordance with the arrangements agreed between NATO and the EU as communicated to the Security Council in their letters of 19 November 2004, which recognize that EUFOR ALTHEA will have the main peace stabilization role under the military aspects of the Peace Agreement;

The mandate of EUFOR ALTHEA will expire on 11 November 2015.

**Bosnia and Herzegovina: EUFOR ALTHEA/NATO reports to SC**

Resolution 2183 (2014) of 11 November 2014

Para.18: Requests the Member States acting through or in cooperation with the EU and the Member States acting through or in cooperation with NATO to report to the Council on the activity of EUFOR ALTHEA and NATO Headquarters presence respectively, through the appropriate channels and at least at six-monthly intervals

**Bosnia and Herzegovina: Reports of High Representative to SC through SG**

Resolution 2183 (2014) of 11 November 2014

Para.20: Also requests the Secretary-General to continue to submit to the Council reports from the High Representative, in accordance with annex 10 of the Peace Agreement and the conclusions of the Peace Implementation Conference held in London on 4 and 5 December 1996 (S/1996/1012), and later

Peace Implementation Conferences, on the implementation of the Peace Agreement and in particular on compliance by the parties with their commitments under that Agreement;

The letter from the Secretary-General is expected in November 2015.

### **UNMIK – SG reports**

Resolution 1244 (1999) of 10 June 1999

Para.20: Requests the Secretary-General to report to the Council at regular intervals on the implementation of this resolution, including reports from the leaderships of the international civil and security presences, the first reports to be submitted within 30 days of the adoption of this resolution.

The report of the Secretary-General is expected in November 2015.

## **OTHER**

### **Conflict prevention: SG report on actions taken to promote and strengthen conflict prevention tools**

Resolution 2171 (2014) of 21 August 2014

Para.25: Requests the Secretary-General to submit a report to the Council on actions taken by him to promote and strengthen conflict prevention tools within the United Nations system, including through co-operation with regional and sub regional organizations, by August 31, 2015;

PSC letter of 30 July 2015 (S/2015/581)

Second para.: The members of the Council have taken note of the request contained in your letter that the time frame for the issuance of the report be extended, and they look forward to the submission of the report by 30 September 2015.

The report of the Secretary-General dated 21 September 2015 (S/2015/730) is before the Security Council.

### **Cooperation between UN and regional / sub regional organizations – Recommendations on enhancing cooperation between the UN and OIC**

Resolution 1809 (2008) of 16 April 2008

Para.17: Requests the Secretary-General to include in his regular reporting to the Security Council, assessments of progress on the cooperation between the United Nations and relevant regional organizations;

S/PRST/2013/12 of 6 August 2013

Last para.: The Council further requests that the Secretary-General includes in his next biannual report to the Security Council and the General Assembly on Cooperation between the United Nations and regional and other organizations, recommendations on ways to enhance cooperation between the United Nations and relevant regional and sub regional organizations and arrangements.

S/PRST/2013/16 of 28 October 2013

Last para: "The Security Council requests the Secretary-General to include in his next biannual report to the Security Council and the General Assembly on Cooperation between the United Nations and

regional and other organizations, recommendations on ways to enhance cooperation between the United Nations and the Organization of Islamic Cooperation.”

The report of the Secretary-General dated 4 August 2014 (S/2014/560) is before the Security Council.

### **ICTR – Annual report**

#### Resolution 955 (1994) of 8 November 1994

Para.1: Decides hereby, having received the request of the Government of Rwanda (S/1994/1115), to establish an international tribunal for the sole purpose of prosecuting persons responsible for genocide and other serious violations of international humanitarian law committed in the territory of Rwanda and Rwandan citizens responsible for genocide and other such violations committed in the territory of neighbouring States, between 1 January 1994 and 31 December 1994 and to this end to adopt the Statute of the International Criminal Tribunal for Rwanda annexed hereto;

#### Article 32

#### Annual report

The President of the International Tribunal for Rwanda shall submit an annual report of the International Tribunal for Rwanda to the Security Council and to the General Assembly.

### **ICTY – Annual report**

#### SG report of 3 May 1993 (S/25704)

#### E. Annual report

Para.37: The International Tribunal should submit an annual report on its activities to the Security Council and the General Assembly.

Para.138: The corresponding article of the statute would read:

#### Article 34

#### Annual Report

The President of the International Tribunal shall submit an annual report of the International Tribunal to the Security Council and to the General Assembly.

#### Resolution 827 (1993) of 25 May 1993

Para.2: Decides hereby to establish an international tribunal for the sole purpose of prosecuting persons responsible for serious violations of international humanitarian law committed in the territory of the former Yugoslavia between 1 January 1991 and a date to be determined by the Security Council upon the restoration of peace and to this end to adopt the Statute of the International Tribunal annexed to the above-mentioned report;

The letter from the President of the ICTY dated 31 July 2015 (S/2015/585) is before the Security Council.

### **ICTY/ICTR – Assessments by Presidents/Prosecutors**

#### Resolution 1534 (2004) of 26 March 2004

Para.6: Requests each Tribunal to provide to the Council, by 31 May 2004 and every six months thereafter, assessments by its President and Prosecutor, setting out in detail the progress made

towards implementation of the Completion Strategy of the Tribunal, explaining what measures have been taken to implement the Completion Strategy and what measures remain to be taken, including the transfer of cases involving intermediate and lower rank accused to competent national jurisdictions; and expresses the intention of the Council to meet with the President and Prosecutor of each Tribunal to discuss these assessments.

The assessments of the ICTY and the ICTR are expected to be issued in November 2015

### **Non-proliferation/DPRK: Sanctions: 1718 Committee reports**

Resolution 1718 (2006) of 14 October 2006

Para.12: Decides to establish, in accordance with rule 28 of its provisional rules of procedure, a Committee of the Security Council consisting of all the members of the Council, to undertake the following tasks:

(g) To report at least every 90 days to the Security Council on its work, with its observations and recommendations, in particular on ways to strengthen the effectiveness of the measures imposed by paragraph 8 above;

The Chair of the 1718 Committee is expected to report to the Security Council in November 2015.

### **Peacebuilding Commission – GA and SC review**

Resolution 1947 (2010) of 29 October 2010

Para.5: Calls for a further comprehensive review five years after the adoption of the present resolution following the procedure as set out in paragraph 27 of resolution 1645 (2005).

Letter from PSC and PGA of 15 December 2014 (S/2014/911)

Fifth para.: In terms of indicative timeline, and taking into account the need to ensure an inclusive and consultative process, the first stage as described in the terms of reference should be completed by the end of June 2015.

The letter from the Chair of the Advisory Group of Experts dated 29 June 2015 (S/2015/490) is before the Security Council.

### **Peacekeeping operations – Report and recommendations on the progress of partnerships between the UN and relevant regional organizations in peacekeeping operations**

Resolution 2167 (2014) of 28 July 2014

Para.28: Requests the Secretary-General, in close consultation with the AU Commission and EU to produce, not later than 31 March 2015, an assessment report and recommendations on the progress of the partnerships between the UN and relevant regional organizations in peacekeeping operations;

The report of the Secretary-General dated 1 April 2015 (S/2015/229) is before the Security Council.

### **Protection of civilians in armed conflict – SG report**

S/PRST/2013/2 of 12 February 2013

Last para.: “The Security Council notes the report of the Secretary-General on protection of civilians in armed conflict of 22 May 2012 S/2012/376 and the recommendations made therein, and requests the Secretary-General to submit his next report, to include an assessment of concrete measures taken by

peacekeeping missions to implement their mandates to protect civilians and the impact of those measures, by 15 November 2013 and for reports to be submitted every 18 months thereafter.”

### **Residual Mechanism – Annual report**

#### Resolution 1966 (2010) of 22 December 2010

Para.16: Requests the President of the Mechanism to submit an annual report to the Security Council and to the General Assembly, and the President and the Prosecutor of the Mechanism to submit six-monthly reports to the Security Council on the progress of the work of the Mechanism;

The letter from the President of the Mechanism for International Criminal Tribunals dated 31 July 2015 (S/2015/586) is before the Security Council.

### **Terrorism/Cross-border crime: SG report on UN efforts to address the threat of terrorists benefitting from transnational organized crime in affected regions**

#### Resolution 2195 (2014) of 19 December 2014

Para.20: Requests the Secretary-General to submit to the Council a report on the efforts of the United Nations entities to address the threat of terrorists benefitting from transnational organized crime in affected regions, including Africa, with respect to matters with which the Council is seized, with input from the relevant entities of the United Nations system including the UNODC, CTED, the Analytical Support and Sanctions Monitoring Team, and other relevant CTITF entities;

Para.21: Further requests that the report include recommendations of concrete options for strengthening Member States’ capabilities, including financing such proposed UN projects and activities to build capacity with existing resources and contributions in the UN system, as well as UN activities to reduce the negative impacts of terrorists benefitting from transnational organized crime including those relevant to its conflict resolution efforts with a focus on border security, counter-terrorist financing, and anti-money-laundering, and that the report be submitted to the Council no later than six months from the adoption of this resolution;

The report of the Secretary-General dated 21 May 2015 (S/2015/366) is before the Security Council.
