

# **FACT SHEET ON THE 1591 SUDAN SANCTIONS COMMITTEE (2005)**

Chair (as of 1 Jan 2022)	Ambassador Harold Adlai Agyeman (Ghana)
Mandate	Oversee the implementation of the sanctions measures; consider and decide upon requests for exemptions from the sanctions measures; designate individuals and entities who meet the listing criteria as contained in the relevant resolution; assess member states' reports submitted pursuant to relevant resolutions; assess the reports submitted by the Panel of Experts assisting the committee; through the committee chair, report every 90 days to the Security Council on its work; establish and update its guidelines; and conduct outreach activities, including with member states and particularly states in the region.
Types of Sanctions	Arms embargo on all belligerents, travel ban and asset freeze. Sanctions measures do not expire (open-ended).
Number of Listed Individuals/ Entities	Four individuals, no entities Most recent listings: 25 April 2006 in resolution 1672
Travel Ban/Asset Freeze Listing Criteria	Those who impede the peace process; constitute a threat to stability in Darfur and the region; commit violations of international humanitarian or human rights law or other atrocities; violate measures implemented by member states to prevent the sale or supply of arms to Sudanese parties operating in Darfur; or are responsible for offensive military overflights in and over Darfur.
Exemptions	Arms embargo: supplies and related technical training and assistance to monitoring, verification or peace support operations authorised by the UN or operating with the consent of the relevant parties; non-lethal military equipment intended solely for humanitarian, human rights monitoring or protective use; and protective clothing for the personal use of UN personnel, human rights monitors, representatives of the media and humanitarian and development workers and associated personnel.
	Travel ban: on the grounds of humanitarian need, including religious obligations, or when the committee concludes that an exemption would further the objectives of the Council's resolutions.
	Assets freeze: for basic expenses; for extraordinary expenses; and expenses subject to judicial, administrative or arbitration lien or judgement.
Delisting Procedures	Member states may at any time submit to the committee requests for delisting. Listed individuals seeking to submit a request for delisting can do so either directly to the Focal Point for Delisting or through his/her state of residence or citizenship.

Monitoring Mechanism/Panel of Experts	The Committee is assisted by a Panel of Experts with five members, last appointed on 13 March 2022: Laura Victoria Bernal Moncada, armed groups and coordinator (Colombia) Nikolai Dobronravin, regional issues (Russian Federation) Rania El Rajji, international humanitarian law (Lebanon) Patrick Loots, arms (South Africa) Rajeev Yadav, finance (India)
	Mandate was last renewed on 15 February 2022 in resolution 2620 until 12 March 2023. Most recent publicly available Panel report is the final report of the Panel of Experts submitted on 24 January 2022 (S/2022/48).
Decision-Making	Decisions are made by consensus. A written "no-objection procedure" can be used by which decisions are deemed adopted if no objection is raised within five working days, or in exceptional situations, a shorter period. Members can place a hold on a proposed decision, but normally not for more than six months. An extension of up to three months can be requested based on "extraordinary circumstances."
Committee Reporting to the Council	Every 90 days by the chair of the committee pursuant to resolution 1591; according to established practice the briefing is held in closed consultations.

Open Briefings for Wider UN Membership	None
Summary of Committee Activities (1 Jan-31 Dec 2021)	In the light of the challenges posed to the Committee's usual procedures by the COVID-19 pandemic, including the limitations on holding inperson meetings, and in order to ensure the continuity of its work, the members of thebCommittee agreed, on an exceptional basis, to hold virtual meetings in the form of closed videoconferences on 11 January, 23 February, 30 March and 17 May 2021. The Committee di informal consultations on 16 August 2021. The Chair of the Committee gave a briefing to the Security Council on the activities of the Committee on 25 March (S/2021/308), 14 June (S/PV.8795), 14 September (S/PV.8856) and 10 December (S/PV.8924).
Member States Reporting Obligations	Resolution 2340 urges all states, in particular those in the region, to report to the committee on the actions they have taken to implement the sanctions measures.
