The forecast covers in particular those matters that may be taken up during the month pursuant to earlier decisions of the Council. The fact that a matter is or is not included in the forecast carries no implication that it will or will not be taken up during the month: the actual programme of work will be determined by developments and the views of members of the Council.

AFRICA

Central African Republic – SG update reports on situation and BINUCA

Resolution 2088 (2013) of 24 January 2013

Para.3: further requests the Secretary-General to provide an update report of the situation on the ground by 30 June 2013 and every six months thereafter.

The report of the Secretary-General is expected to be issued by 30 June 2013.

Côte d'Ivoire – SG final report on UNOCI

Resolution 2062 (2012) of 26 July 2012

Para.23: requests the Secretary-General to provide to it a midterm report no later than 31 December 2012 and a final report no later than 30 June 2013 on the situation on the ground and the implementation of this resolution.

The report of the Secretary-General is expected to be issued by 30 June 2013.

Democratic Republic of the Congo – SG reports on MONUSCO

Resolution 2098 (2013) of 28 March 2013

Para.17: requests the Secretary-General, to produce a detailed report and accompanying matrix reflecting the current division of labour between MONUSCO and the UNCT on tasks shared by the Mission, the UNCT and the Government of the DRC and setting out a clear roadmap, with accompanying timeline, to transfer to the UNCT to the fullest extent possible tasks where the UNCT has a comparative advantage or which take place in non-conflict areas, or to the Government of the DRC, in order to streamline the tasks assigned to MONUSCO's military and civilian components, and expresses its intention to keep the mandate of MONUSCO under review on the basis of this report;

Para.34: requests the Secretary-General to report to the Council every three months:

(a) in coordination with his Special Envoy for the Great Lakes region and his Special Representative for the DRC on the implementation of the commitments under the PSC Framework and on any breaches of the commitments contained therein, including on the basis of the benchmarks and appropriate follow-up measures referred to in paragraph 4 and paragraph 5;

(b) in coordination with his Special Representative for the DRC on: (i) the situation on the ground, including sexual violence and the impact of conflict on women and children, and including in the light of the objectives outlined in paragraph 11 and on the basis of the joint assessment process allowed by the ongoing strategic partnership between the Congolese Government and MONUSCO; (ii) progress made by the DRC in the implementation of its commitments under the PSC Framework, including through the establishment and implementation of a national security sector reform roadmap and the creation of a Congolese

“Rapid Reaction Force”, and on the design and implementation of the overarching DDR and DDRRR plan;

(iii) the implementation by MONUSCO of its mandate, including on the deployment, readiness and activities of the Intervention Brigade and all other MONUSCO forces, on any violations of international human rights law and international humanitarian law that may occur and on efforts undertaken to mitigate civilian harm; (iv) the reconfiguration of MONUSCO to conduct the tasks set out in paragraphs 12 and 13, to contribute to the tasks set out in paragraphs 14 and 15 and to transfer activities from MONUSCO to the UN country team as set out in paragraph 18, including on the basis of the matrix of division of labour referred to in paragraph 17 which should be presented within three months and updated regularly thereafter, and on the reinforcement of MONUSCO presence in eastern DRC; (v) the review and subsequent updating of the mission concept, concept of operations, rules of engagement and all other relevant UN planning documents; (vi) the risks and their implications for the safety and the security for the UN personnel and facilities as a result of the possible operations of the Intervention Brigade as well as measures taken to strengthen their security and mitigate risks.

The reports of the Secretary-General are expected to be issued in June 2013.

Democratic Republic of the Congo – Group of Experts mid-term report

Resolution 2078 (2012) of 28 November 2012

Para.5: requests the Secretary-General to extend, for a period expiring on 1 February 2014, the Group of Experts established pursuant to resolution 1533 (2004) and renewed by subsequent resolutions and requests the Group of Experts to fulfil its mandate as set out in paragraph 18 of resolution 1807 (2008) and expanded by paragraphs 9 and 10 of resolution 1857 (2008), and to present to the Council, through the Committee, a written mid-term report by 28 June 2013, and a written final report before 13 December 2013, welcomes the practice of receiving additional updates of the Group of Experts as appropriate, and further requests that, after a discussion with the Committee, the Group of Experts submit to the Council its final report upon termination of the Group’s mandate.

The mid-term report of the Group of Experts is expected to be issued by 28 June 2013.

Liberia – Panel of Experts midterm report

Resolution 2079 (2012) of 12 December 2012

Para.5: decides to extend the mandate of the Panel of Experts appointed pursuant to paragraph 9 of resolution 1903 (2009) for a period of 12 months from the date of adoption of this resolution to undertake the following tasks in close collaboration with the Government of Liberia and the Côte d’Ivoire Group of Experts: (f) To provide a midterm report to the Council through the Committee by 1 June 2013 and a final report to the Council through the Committee by 1 December 2013 on all the issues listed in this paragraph, and to provide informal updates to the Committee as appropriate before those dates, especially on progress in the forest sector since the lifting of paragraph 10 of resolution 1521 (2003) in June 2006, and in the diamond sector since the lifting of paragraph 6 of resolution 1521 (2003) in April 2007;

The mid-term report of the Panel of Experts is expected to be submitted by 1 June 2013.

Libya – UNSMIL SG reporting

Resolution 2095 (2013) of 14 March 2013

Para.18: requests the Secretary-General to report to the Security Council on the implementation of this resolution, including all elements of UNSMIL's mandate, every 90 days.

Libya – Panel of Experts interim report

Resolution 2095 (2013) of 14 March 2013

Para.14: decides to extend the mandate of the Panel of Experts, established by paragraph 24 of resolution 1973 (2011) and modified by resolution 2040 (2012), for a period of thirteen months, expresses its intent to review the mandate and take appropriate action regarding further extension no later than twelve months from the adoption of this resolution, and decides that the Panel shall carry out the following tasks:

(d) provide to the Council an interim report on its work no later than 90 days after the Panel's appointment, and a final report to the Council no later than 60 days prior to the termination of its mandate with its findings and recommendations.

The interim report of the Panel is expected to be submitted in June 2013.

The situation in Mali – SC to review MINUSMA deployment

Resolution 2100 (2013) of 25 April 2013

Para.8: decides that the date referred to in paragraph 7 above and MINUSMA's phased deployment shall be subject to a further review by the Council within 60 days of the adoption of this resolution of the security situation in MINUSMA's area of responsibility, specifically with respect to the cessation of major combat operations by international military forces in the immediate vicinity of and/or within MINUSMA's envisaged area of responsibility and a significant reduction in the capacity of terrorist forces to pose a major threat to the civilian population and international personnel in the immediate vicinity of and/or within MINUSMA's envisaged area of responsibility, further decides, should the Council consider that these criteria are not met before 1 July 2013, it shall concurrently adjust the timeline for MINUSMA's deployment against these criteria.

The review of MINUSMA deployment is expected to take place in June 2013.

Mali – SG reports on MINUSMA

Resolution 2100 (2013) of 25 April 2013

Para.34: requests the Secretary-General to keep the Council regularly informed of the situation in Mali and the implementation of the mandate of MINUSMA, to report to the Council within 45 days of the adoption of this resolution, specifically with regards to paragraph 8 and 9 above, and then every three months from 1 July 2013 and to include in his reports to the Council updates on the security situation, the priority political elements as defined in paragraphs 1, 2, 3 and 4 above on the implementation of the transitional road map, relevant information on the progress, promotion and protection of human rights and international humanitarian law as well as a review of the troop level, force generation and deployment of all MINUSMA's constituent elements;

The report of the Secretary-General is expected to be issued in June 2013.

Somalia – AU reports on AMISOM

Resolution 2093 (2013) of 6 March 2013

Para.8: requests the AU to keep the Security Council regularly informed on the implementation of AMISOM's mandate through the provision of written reports to the Secretary-General every 90 days after the adoption of this resolution.

Sudan (Sudan/South Sudan)

Resolution 2046 (2012) of 2 May 2012

Para. 6: requests the Secretary-General to consult with the African Union on the implementation of this resolution and the decisions of the AU PSC, to work closely with the AUHIP in support of its facilitation efforts, and to inform the Security Council within 15 days and in two week intervals thereafter on the status of compliance by Sudan, South Sudan, and the SPLM-N with the decisions set forth in this resolution, and expresses its intention, in the event that any or all of the parties have not complied with the decisions set forth in this resolution, to take appropriate additional measures under Article 41 of the Charter as necessary.

S/PRST/2012/19 (2012) of 31 August 2012

Penultimate para.: recalls its Resolution 2046 and reiterates its request to the Secretary-General, in consultation with the AUHIP, the Chair of IGAD, and the Chairman of the AU Commission, to report to the Council by September 2 on the status of negotiations. The Security Council also looks forward to reviewing the AU's determinations as indicated in paragraph 18 of the AUPSC Communiqué of August 3 and requests in this regard the Secretary General to report to the Council thereafter on the status of negotiations, including detailed proposals on all outstanding issues.

The Secretary-General is expected to report to the Security Council in June 2013.

Sudan – SG reports on UNMISS

Resolution 2057 (2012) of 5 July 2012

Para.19: calls upon UNMISS to coordinate with the Government of the Republic of South Sudan and participate in regional coordination and information mechanisms to improve protection of civilians and support disarmament, demobilization and reintegration efforts in light of the attacks by the Lord's Resistance Army (LRA) in the Republic of South Sudan and requests the Secretary-General to include in his UNMISS trimesterly reports a summary of cooperation and information sharing between UNMISS, the African Union/United Nations Hybrid Operation in Darfur (UNAMID), the United Nations Organization Stabilization Mission in the Democratic Republic of Congo (MONUSCO), and regional and international partners in addressing the LRA threats;

Para.22: requests the Secretary-General to continue to report to the Council on the expected timeline of the deployment of all mission elements, including the status of consultations with Troop and Police-Contributing Countries and of the deployment of key enablers, and, stressing the importance of timely recruitment of appropriate specialists to fill vacancies in the civilian component, further requests the Secretary-General to report to the Council on the expected timeline of the fulfilment of civilian staffing;

Para.24: notes with concern the critical need for military helicopters for UNMISS, calls on Member States to redouble their efforts to provide aviation units to the mission, and requests the Secretary-General to include information on force generation efforts in his regular reports.

The report of the Secretary-General is expected to be issued in June 2013.

Sudan – Briefing by ICC Prosecutor

Resolution 1593 (2005) of 31 March 2005

Para.8. invites the Prosecutor to address the Council within three months of the date of adoption of this resolution and every six months thereafter on actions taken pursuant to this resolution.

The ICC Prosecutor is expected to brief the Security Council in June 2013.

United Nations Office for West Africa (UNOWA) – SG reporting

Letter from the President of the Security Council dated 20 December 2010 (S/2010/661)

Requests that the Secretary-General report to the Security Council every six months on the fulfilment by the United Nations Office for West Africa (UNOWA) of its revised mandate.

The report of the Secretary-General is expected to be issued in June 2013.

ASIA

Afghanistan – SG reports on UNAMA

Resolution 2096 (2013) of 19 March 2013

Para.44: ...and requests the Secretary-General to continue to include in its reports to the Security Council relevant information on the process of integration of women into the political, economic and social life of Afghanistan;

Para.48: requests that the Secretary-General reports to the Council every three months on developments in Afghanistan, and to include in his reports an evaluation of progress made against the benchmarks for measuring and tracking progress in the implementation of UNAMA's mandate and priorities as set out in this resolution.

The report of the Secretary-General is expected to be issued in June 2013.

Afghanistan – ISAF reports

Resolution 2069 (2012) of 9 October 2012

Para.8: requests the leadership of ISAF to keep the Security Council regularly informed, through the United Nations Secretary-General, on the implementation of its mandate, including through the timely provision of quarterly reports.

Iraq – SG reports on UN compensation fund

Resolution 1956 (2010) of 15 December 2010

Para.6: requests the Secretary-General to provide written reports on an ongoing basis to the council every six months, with the first report due no later than 1 January 2012, about the United Nations compensation fund, evaluating the continued compliance with the provisions of paragraph 21 of resolution 1483 (2003).

The letter dated 21 May 2013 (S/2013/305) is before the Security Council.

Iraq/Kuwait – missing persons and return of property

Resolution 1284 (1999) of 17 December 1999

Para. 14. requests the Secretary-General to report to the Council every four months on compliance by Iraq with its obligations regarding the repatriation or return of all Kuwaiti and third country nationals or their remains, to report every six months on the return of all Kuwaiti property, including archives, seized by Iraq, and to appoint a high-level coordinator for these issues;

Letter from the Council President to the Secretary-General of 30 June 2006 (S/2006/469)

Takes note of the intention of the Secretary-General in his letter dated 28 June 2006 (S/2006/468) to report, pursuant to resolution 1284 (1999), on compliance by Iraq with its obligations regarding the repatriation or return of all Kuwaiti and third-country nationals or their remains and on the return of all Kuwaiti property every six months.

Letter from the Secretary-General to the Council President of 10 January 2013 (S/2013/13)

Informs that pending a decision by the Council on the mandate of the High-level Coordinator on missing Kuwaiti persons and property, the activities to fulfil the mandate in paragraph 14 of resolution 1284 (1999) will be undertaken in an ad hoc manner, by drawing on existing staff and resources.

The report of the Secretary-General is expected to be issued in June 2013.

The situation in the Middle East, including the Palestinian question

Resolution 1322 (2000) of 7 October 2000

Para. 7: invites the Secretary-General to continue to follow the situation and to keep the Security Council informed.

The situation in the Middle East – UNDOF mandate

Resolution 2084 (2012) of 19 December 2012

Para.5: decides to renew the mandate of the United Nations Disengagement Observer Force for a period of six months, that is, until 30 June 2013, and requests the Secretary-General to ensure the Force has the capacity necessary to fulfil the mandate.

The mandate of UNDOF will expire on 30 June 2013.

A meeting between the Security Council and the troop-contributing countries will take place before the expiry of the UNDOF mandate.

Para.6: requests the Secretary-General to report every 90 days on developments in the situation and the measures taken to implement resolution 338 (1973).

The report of the Secretary-General is expected to be issued in June 2013.

Middle East – SG reporting on Lebanon/UNIFIL (Resolution 1701)

Resolution 2064 (2012) of 30 August 2012

Para.10: requests the Secretary-General to continue to report to the Council on the implementation of resolution 1701 (2006), every four months, or at any time as he deems appropriate.

The report of the Secretary-General is expected to be issued in June 2013.

Middle East – Yemen

Resolution 2051 (2012) of 12 June 2012

Para. 18: requests the Secretary-General to continue to report on developments in Yemen every 60 days;

The Secretary-General is expected to report to the Security Council in June 2013.

EUROPE

Resolutions 1160 (1998), 1199 (1998), 1203 (1998), 1239 (1999) and 1244 (1999) – UNMIK

Resolution 1244 (1999) of 10 June 1999

Para. 20: requests the Secretary-General to report to the Security Council at regular intervals on the implementation of the resolution.

The report of the Secretary-General dated 30 April (S/2013/254) is before the Council.

OTHER

Children and armed conflict – SG reporting

Resolution 2068 (2012) of 19 September 2011

Para.5: reiterates its call upon the Working Group on Children and Armed Conflict to consider, with the support of the Special Representative for Children and Armed Conflict, within one year, a broad range of options for increasing pressure on persistent perpetrators of violations and abuses committed against children in situations of armed conflict;

Para.6: requests the Secretary-General to continue to submit annual reports to the Council on the implementation of its resolutions and Presidential statements on children and armed conflict, and to submit his next report by June 2013.

The report of the Secretary-General is expected to be issued in June 2013.

ICTY – SC to examine plan on completion strategy

Resolution 2081 (2012) of 17 December 2012

Para. 2: requests the International Tribunal to present by 15 April 2013 a consolidated comprehensive plan on the completion strategy, closure and transition to the Mechanism, as recommended by the Board of Auditors, and updated and detailed schedules for each of the individual cases with a timeline for each procedural part of the case;

Para.3: decides to examine the consolidated comprehensive plan referred to in paragraph 2 of this resolution before 30 June 2013 with a view to considering what further recommendations should be made to facilitate the International Tribunal's progress toward completion, closure and transition to the Mechanism as soon as possible as requested in resolution 1966 (2010), which could include recommendations on all possible measures to scrutinize the operation and

functioning of the Tribunal with the objective of ensuring the most efficient use of the Tribunal's resources and the completion of the Tribunal's mandate.

The consolidated comprehensive plan of the ICTY dated 15 April 2013 is before the Security Council.

ICTY – terms of office of ad litem judges

Resolution 2081 (2012) of 17 December 2012

Para.7: decides to extend the term of office of the following ad litem judges at the International Tribunal, who are members of the Trial Chambers, until 1 June 2013 or until the completion of the cases to which they are assigned, if sooner:

Árpád Prandler (Hungary)

The Security Council is expected to take action on the terms of office of the specified ICTY ad litem judges by 1 June 2013.

ICTY/ICTR – Assessments by Presidents / Prosecutors

Resolution 1534 (2004) of 26 March 2004

Para.6: requests each Tribunal to provide to the Council, by 31 May 2004 and every six months thereafter, assessments by its President and Prosecutor, setting out in detail the progress made towards implementation of the Completion Strategy of the Tribunal, explaining what measures have been taken to implement the Completion Strategy and what measures remain to be taken, including the transfer of cases involving intermediate and lower rank accused to competent national jurisdictions; and expresses the intention of the Council to meet with the President and Prosecutor of each Tribunal to discuss these assessments.

Non-proliferation / Iran – 1737 Committee reports

Resolution 1737 (2006) of 27 December 2006

Para.18: decides to establish, in accordance with rule 28 of its provisional rules of procedure, a Committee of the Security Council consisting of all the members of the Council, to undertake the following tasks: (h) to report at least every 90 days to the Security Council on its work and on the implementation of this resolution, with its observations and recommendations, in particular on ways to strengthen the effectiveness of the measures imposed by paragraphs 3, 4, 5, 6, 7, 8, 10 and 12 above;

The Chairman of the 1737 Committee is expected to brief the Security Council in June 2013.

Non-proliferation (Iran) – Panel of Experts mandate reviews and reports

Resolution 2049 (2012) of 7 June 2012

Para. 1: decides to extend until 9 July 2013 the mandate of the Panel of Experts, as specified in paragraph 29 of resolution 1929 (2010), expresses its intent to review the mandate and take

appropriate action regarding further extension no later than 9 June 2013, and requests the Secretary General to take the necessary administrative measures to this effect.

The review of the Panel of Experts mandate will take place by 9 June 2013

Para. 2: requests the Panel of Experts to provide to the Committee no later than 9 November 2012 a midterm report on its work, and further requests that, after a discussion with the Committee, the Panel of Experts submit to the Council its midterm report by 9 December 2012, and requests also a final report to the Committee no later than thirty days prior to the termination of its mandate with its findings and recommendations, and further requests that, after a discussion with the Committee, the Panel of Experts submit to the Council its final report upon termination of the Panel's mandate;

The final report of the Panel of Experts is expected to be submitted by 9 June 2013.

Protection of civilians in armed conflict

S/PRST/2002/41 of 20 December 2002

Last para.: the Security Council recognizes the importance of a comprehensive, coherent and action-oriented approach to the protection of civilians in armed conflict. It encourages further cooperation between Member States, OCHA, DPA, DPKO, UNHCR, UNRWA, OHCHR, UNDP and other relevant United Nations agencies and offices, bearing also in mind the contents of resolutions 1325 on women, peace and security and 1379 on children in armed conflict; welcomes the regional workshops and encourages Member States to give them their operational and financial support. The Security Council requests the Secretary-General to submit by June 2004 his next report on the protection of civilians in armed conflict, including information on the implementation of Security Council resolutions previously adopted on this subject and any other matter he wishes to bring to the attention of the Council. It also welcomes the oral briefings to be given to the Council every six months, including progress made to further develop the road map concept, as set out in the most recent report by the Secretary-General (S/2002/1300)."

United Nations Integrated Strategy on Sahel

Resolution 2056 (2012) of 5 July 2012

Para. 28: requests the Secretary-General to develop and implement, in consultation with regional organizations, a United Nations integrated strategy for the Sahel region encompassing security, governance, development, human rights and humanitarian issues, including through the involvement of the United Nations Office for West Africa, and requests the Secretary-General to inform the Council on progress made by 15 September 2012;

Letter from the President of the Security Council dated 9 May 2013 (S/2013/277)

Last para.: The members of the Council have taken note of the request contained in your [Secretary-General] letter that the time frame for the issuance of the report be extended, and they look forward to the submission of the report by 14 June 2013.

The report of the Secretary-General is expected to be issued by 14 June 2013.
