AFRICA

Central African Republic – BINUCA

S/PRST/2001/25 of 26 September 2001

Last para.: requests the Secretary-General to continue to keep the Security Council regularly informed on the situation in the Central African Republic.

S/PRST/2009/5 of 7 April 2009

Penult. para.: requests the Secretary-General to inform the Security Council in his next report on the structure and strength of the United Nations Integrated Peacebuilding Office in the Central African Republic (BINUCA).

The report of the Secretary-General is expected to be issued in early June 2010.

Côte d'Ivoire – UNOCI and French forces

Resolution 1911 (2010) of 28 January 2010

Para. 22: requests the Secretary-General to provide to the Security Council a full report by the end of April 2010, including detailed recommendations and options for the future of the United Nations Operation in Côte d'Ivoire (UNOCI), as well as revised benchmarks based on the results of a technical assessment mission.

Letter from the President of the Security Council dated 29 April 2010 (S/2010/221)

Requests that the Secretary-General provide a report by 21 May 2010 on UNOCI based on the results of a technical assessment mission.

The report of the Secretary-General dated 20 May 2010 (S/2010/245) is before the Security Council.

Resolution 1924 (2010) of 27 May 2010

Para. 1: decides to renew the mandate of UNOCI until 30 June 2010.

The mandate of UNOCI will expire on 30 June 2010.

Para. 2: decides to extend until 30 June 2010 the authorization provided by the Security Council to the French forces supporting UNOCI.

The authorization to the French forces supporting UNOCI will expire on 30 June 2010.

Democratic Republic of the Congo – MONUC

Resolution 1925 (2010) of 28 May 2010

Para. 1: decides to extend the mandate of the United Nations Organization Mission in the Democratic Republic of the Congo (MONUC) until 30 June 2010.

The mandate of MONUC will expire on 30 June 2010.

Para. 3: authorizes the withdrawal of up to 2000 United Nations military personnel by 30 June 2010 from areas where the security situation permits.

Guinea-Bissau – UNIOGBIS

Resolution 1876 (2009) of 26 June 2009

Para. 6: requests the Secretary-General to develop a strategic workplan with appropriate benchmarks to measure and track progress on the implementation of the mandate of the United Nations Integrated Peacebuilding Office in Guinea-Bissau (UNIOGBIS), and to report on its implementation in accordance with paragraph 14 of the resolution.

Para. 14: requests the Secretary-General to keep the Security Council regularly informed every 4 months on the implementation of this resolution.

The report of the Secretary-General is expected to be issued by 30 June 2010.

Peace and security in Africa – Eritrea sanctions

Resolution 1907 (2009) of 23 December 2009

Para. 22: requests the Secretary-General to report within 180 days on Eritrea's compliance with the provisions of this resolution.

The report of the Secretary-General is expected to be issued by 23 June 2010.

The Sudan – International Criminal Court

Resolution 1593 (2005) of 31 March 2005

Para. 8: invites the Prosecutor of the International Criminal Court to address the Security Council every 6 months on actions taken pursuant to the resolution.

The ICC Prosecutor is expected to brief the Security Council in early June 2010.

The Sudan – 1591 Sanctions Committee

Resolution 1591 (2005) of 29 March 2005

Para. 3(a)(iv): decides that the Security Council Committee established pursuant to resolution 1591 (2005) shall report at least every 90 days to the Council on its work.

The Chairman of the 1591 Committee is expected to brief the Security Council in early June 2010.

United Nations Office for West Africa (UNOWA)

Letter from the President of the Security Council dated 21 December 2007 (S/2007/754)

Requests that the Secretary-General report to the Security Council every 6 months on the fulfilment by the United Nations Office for West Africa (UNOWA) of its revised mandate.

The report of the Secretary-General is expected to be issued by 30 June 2010.

AMERICAS

Haiti – MINUSTAH

Resolution 1908 (2010) of 19 January 2010

Para. 2: decides that it will keep the new levels of troops and police in the United Nations Stabilization Mission in Haiti (MINUSTAH) under review as necessary.

ASIA

Afghanistan – UNAMA

Resolution 1917 (2010) of 22 March 2010

Para. 40: requests the Secretary-General to report to the Security Council every 3 months on developments in Afghanistan and to include in his next report an evaluation of progress made against the benchmarks for measuring and tracking progress in the implementation of the mandate and priorities of the United Nations Assistance Mission in Afghanistan (UNAMA) as set out in this resolution.

The report of the Secretary-General is expected to be issued during June 2010.

Iraq – DFI / IAMB and immunity provisions

Resolution 1905 (2009) of 21 December 2009

Para. 2: decides that the provisions in paragraph 1 of the resolution for the deposit of proceeds into the Development Fund for Iraq (DFI) and for the role of the International Advisory and Monitoring Board (IAMB), as well as the provisions of paragraph 22 of resolution 1483 (2003), to the effect that petroleum, petroleum products and natural gas originating in Iraq shall be immune, until title passes to the initial purchaser, from legal proceedings against them, shall be reviewed at the request of the Government of Iraq or no later than 15 June 2010.

The review of the DFI/IAMB arrangements and the immunity provisions is expected to take place by 15 June 2010.

Iraq/Kuwait – missing persons and return of property

Resolution 1284 (1999) dated 17 December 1999

Para. 14: requests the Secretary-General to report to the Security Council every 4 months on compliance by Iraq with its obligations regarding the repatriation or return of all Kuwaiti and third country nationals or their remains, and requests the Secretary-General to report to the Council every 6 months on the return of all Kuwaiti property.

Letter from the President of the Security Council dated 30 June 2006 (S/2006/469)

Takes note of the intention of the Secretary-General in his letter dated 28 June 2006 (S/2006/468) to report on compliance by Iraq with its obligations regarding the repatriation or return of all Kuwaiti and third-country nationals or their remains and on the return of all Kuwaiti property every 6 months.

Letter from the President of the Security Council dated 4 February 2010 (S/2010/72)

Informs the Secretary-General that the Security Council requests a comprehensive report on progress during the period of the present mandate of the High-level Coordinator by 30 June 2010.

The report of the Secretary-General is expected to be submitted by mid-June 2010.

Letter from the President of the Security Council dated 4 February 2010 (S/2010/72)

Informs the Secretary-General that the Security Council has decided to earmark funds from the 2.2 per cent part of the escrow account intended for administration and operational costs to finance the continuation of the activities of the High-level Coordinator and his support staff until 30 June 2010.

The financial arrangements for the activities of the High-level Coordinator will expire on 30 June 2010.

The situation in the Middle East, including the Palestinian question

Resolution 1322 (2000) of 7 October 2000

Para. 7: invites the Secretary-General to continue to follow the situation and to keep the Security Council informed.

Middle East – Lebanon (resolution 1701 (2006))

Resolution 1884 (2009) of 27 August 2009

Para. 6: requests the Secretary-General to continue to report to the Security Council on the implementation of resolution 1701 (2006) every 4 months, or at any time as he deems appropriate.

The report of the Secretary-General is expected to be issued by 30 June 2010.

Middle East – UNDOF

Resolution 1899 (2009) of 16 December 2009

Para. 3: decides to renew the mandate of the United Nations Disengagement Observer Force (UNDOF) until 30 June 2010.

The UNDOF mandate will expire on 30 June 2010.

Para. 4: requests the Secretary-General to submit at the end of this period a report on developments in the situation and the measures taken to implement resolution 338 (1973).

The report of the Secretary-General report is expected to be issued by mid-June 2010.

A meeting between the Security Council and the troop-contributing countries will take place after the issuance of the report of the Secretary-General.

Timor-Leste – UNMIT

Resolution 1912 (2010) of 26 February 2010

Para. 8: underscores the need for the concept of operations and rules of engagement of the United Nations Integrated Mission in Timor-Leste (UNMIT) to be regularly updated as necessary and to be fully in line with the provisions of this resolution, and requests the Secretary-General to report on them to the Security Council and troop- and police-contributing countries within 90 days after the adoption of this resolution.

The letter from the Secretary-General addressed to the President of the Security Council dated 26 May 2010 (S/2010/254) is before the Security Council.

A meeting of the Security Council and the troop- and police-contributing countries is expected to take place in early June 2010.

EUROPE

Cyprus – UNFICYP

Resolution 1898 (2009) of 14 December 2009

Para. 9: requests the Secretary-General to submit a report on implementation of the resolution, including on contingency planning in relation to the settlement, by 1 June 2010.

The report of the Secretary-General (S/2010/264) is expected to be issued by 1 June 2010.

S/PRST/2008/34 of 4 September 2008

Last para.: welcomes the appointment of Alexander Downer as the Secretary-General's Special Advisor and looks forward to being briefed on the progress of the Good Offices process.

The report of the Secretary-General dated 11 May 2010 (S/2010/238) is before the Security Council.

Resolution 1898 (2009) of 14 December 2009

Para. 6: decides to extend the mandate of the United Nations Peacekeeping Force in Cyprus (UNFICYP) for a further period ending 15 June 2010.

The UNFICYP mandate will expire on 15 June 2010.

A meeting between the Security Council and the troop- and police-contributing countries will take place before the expiry of the UNFICYP mandate.

OTHER

Children and armed conflict

Resolution 1882 (2009) of 4 August 2009

Para. 19: requests the Secretary-General to submit a report by May 2010 on the implementation of the resolutions and presidential statements by the Security Council on children and armed conflict, including the present resolution, which would include: (a) annexed lists of parties in situations of armed conflict on the agenda of the Security Council or in other situations of concern, in accordance with paragraph 3 of the present resolution; (b) information on measures undertaken by parties listed in the annexes to end all violations and abuses committed against children in armed conflict; (c) information on progress made in the implementation of the monitoring and reporting mechanism established in resolution 1612 (2005); and (d) information on the criteria and procedures used for listing and de-listing parties to armed conflict in the annexes to the periodic reports of the Secretary-General, bearing in mind the views expressed by all the members of the Security Council Working Group on Children and Armed Conflict during informal briefings held before the end of 2009.

Para. 9: requests the Secretary-General to include more systematically in his reports on children and armed conflict specific information regarding the implementation of the recommendations of the Working Group on Children and Armed Conflict.

The report of the Secretary-General dated 13 April 2010 (S/2010/181) is before the Security Council.

Non-proliferation (Iran)

Resolution 1737 (2006) of 23 December 2006

Para. 18(h): decides that the Security Council Committee established pursuant to resolution 1737 (2006) shall report at least every 90 days to the Council on its work and on the implementation of this resolution.

The Chairman of the 1737 Committee is expected to report to the Security Council during June 2010.

Non-proliferation / DPRK

Resolution 1874 (2009) of 12 June 2009

Para. 26: requests the Secretary-General to create for an initial period of one year, in consultation with the Committee established pursuant to resolution 1718 (2006), a group of up to seven experts ("Panel of Experts"), acting under the direction of the Committee, to carry out the tasks specified in paragraphs 26 (a), (b), (c) and (d) of this resolution

The mandate of the Panel of Experts will expire on 12 June 2010.

ICTY / ICTR – completion strategies

Resolution 1534 (2004) of 26 March 2004

Para. 6: requests the International Tribunal for the Former Yugoslavia (ICTY) and the International Criminal Tribunal for Rwanda (ICTR) to provide to the Security Council every 6 months assessments by each President and Prosecutor with respect to implementation of the Completion Strategy of the Tribunals, and expresses the intention of the Security Council to meet with the President and Prosecutor of each Tribunal to discuss these assessments.

The completion strategy assessments of the ICTY (S/2010/270) and of the ICTR (S/2010/259) are expected to be issued in early June 2010.

ICTY – terms of trial judges

Resolution 1900 (2009) of 16 December 2009

Para. 1: underlines the intention of the Security Council to extend, by 30 June 2010, the terms of office of all trial judges at the International Tribunal for the Former Yugoslavia (ICTY) based on the Tribunal's projected trial schedule and the terms of office of all appeals judges until 31 December 2012, or until the completion of the cases to which they are assigned if sooner, and requests the President of the Tribunal to submit to the Council an updated trial and appeals schedule, including information on the judges whose extension of the terms of office or redeployment to the Appeals Chamber will be sought.

The Security Council is expected to take action on the terms of office of the specified ICTY trial judges during June 2010.

ICTR – terms of trial judges

Resolution 1901 (2009) of 16 December 2009

Para. 1: underlines the intention of the Security Council to extend, by 30 June 2010, the terms of office of all trial judges at the International Criminal Tribunal for Rwanda (ICTR) based on the Tribunal's projected trial schedule and the terms of office of all appeals judges until 31 December 2012, or until the completion of the cases to which they are assigned if sooner, and requests the President of the Tribunal to submit to the Council an updated trial and appeals schedule, including information on the judges whose extension of the terms of office or redeployment to the Appeals Chamber will be sought.

The Security Council is expected to take action on the terms of office of the specified ICTR trial judges during June 2010.

Elections to fill vacancies on the International Court of Justice

Note by the Secretary-General concerning the date of an election to fill a vacancy in the International Court of Justice (S/2010/255)

Para. 5: states that in view of the fact that the date of the election to fill the vacancy in the International Court of Justice (ICJ) for the remainder of the term of office of Judge Thomas Buergenthal (United States) is to be fixed by the Security Council, the Council may wish to consider this question at an early meeting.

A resolution fixing the date of the election to fill a vacancy in the ICJ for the remainder of the term of office of Judge Thomas Buergenthal is expected to be adopted in early June 2010.

Resolution 1914 (2010) of 18 March 2010

Decides that the election to fill a vacancy in the ICJ for the remainder of the term of office of Judge Shi Jiuyong (China) shall take place on 29 June 2010 at a meeting of the Security Council and at a meeting of the General Assembly at its 64th session.

The election to fill a vacancy in the ICJ for the remainder of the term of office of Judge Shi Jiuyong is scheduled to take place on 29 June 2010.

Justice and rule of law

S/PRST/2006/28 of 22 June 2006

Para. 1: underscores the conviction of the Security Council that international law plays a critical role in fostering stability and order in international relations and in providing a framework for cooperation among States in addressing common challenges, thus contributing to the maintenance of international peace and security.

Para. 3: states that the Security Council attaches vital importance to promoting justice and the rule of law, including respect for human rights, as an indispensable element for lasting peace and that the Council considers enhancement of the rule of law activities as crucial in the peacebuilding strategies in post-conflict societies and emphasizes the role of the Peacebuilding Commission in this regard.
