**AFRICA**

**Central African region: SG reports on UNOCA**

S/PRST/2015/12 of 11 June 2015

Last para.: The Security Council requests that the Secretary-General keep it informed through a report on the situation in Central Africa and UNOCA's activities to be submitted before 30 November 2015 and every six months thereafter, on the activities of UNOCA, progress made in conducting assessments of the LRA's evolving area of operations and logistical and support networks, and the efforts being undertaken respectively by missions in the region and relevant United Nations agencies to implement the UN's Regional Strategy.

The report of the Secretary-General is expected to be issued in November 2016.

**DRC: SG strategic review of the mandate of his Special Envoy for the Great Lakes Region**

Resolution 2277 (2016) of 30 March 2016

Para.51: Requests the Secretary-General to report to the Security Council every six months, in coordination with the Secretary-General's Special Envoy for the Great Lakes Region and the Special Representative of the Secretary-General for the DRC on the implementation of the commitments under the PSC Framework, and requests the Secretary-General to conduct a strategic review of the mandate of his Special Envoy for the Great Lakes Region by 30 September 2016 in order to present recommendations for the Special Envoy to better support Member States in the full implementation of their commitments under the PSC Framework, in full complementarity with MONUSCO, and taking into consideration the evolving challenges facing the region;

PSC letter of 21 October 2016 (S/2016/892)

I have the honour to inform you that your letter dated 4 October 2016 concerning the strategic review of the mandate of the Special Envoy for the Great Lakes Region has been brought to the attention of the Security Council. The Council looks forward to further discussions about these recommendations in the coming weeks.

**Liberia: SG to conduct assessment mission and provide recommendations to SC**

Resolution 2239 (2015) of 17 September 2015

Para.18: Affirms its intention, based on the Security Council's review by 15 December 2016 of Liberia's overall capacity to ensure security and stability after the conclusion of the security transition on 30 June 2016 and security conditions on the ground, to consider the possible withdrawal of UNMIL and transition to a future United Nations presence to continue to assist the Government of Liberia to

consolidate peace and, in this regard, requests the Secretary-General to conduct an assessment mission to Liberia in order to provide recommendations to the Security Council by 15 November 2016;

The report of the Secretary-General is expected to be issued in November 2016.

**Libya: UNSMIL: SG to report to SC on the implementation of resolution 2291 (2016)**

Resolution 2291 (2016) of 13 June 2016

Para.3: Requests the Secretary-General to continue to report to the Security Council on the implementation of this resolution at least every 60 days;

The report of the Secretary-General is expected to be issued in November 2016.

**Libya: Panel of Experts interim report to SC**

Resolution 2278 (2016) of 31 March 2016

Para.13: Decides that the Panel shall provide to the Council an interim report on its work no later than 180 days after the Panel's appointment, and a final report to the Council, after discussion with the Committee, no later than 15 June 2017 with its findings and recommendations;

The interim report of the PoE dated 28 September 2016 is before the Security Council.

**Libya: ICC Prosecutor briefing**

Resolution 1970 (2011) of 26 February 2011

Para.7: Invites the Prosecutor to address the Security Council within two months of the adoption of this resolution and every six months thereafter on actions taken pursuant to this resolution.

The ICC Prosecutor is expected to brief the Security Council in November 2016.

**Somalia: Piracy: SG report on piracy**

Resolution 2246 (2015) of 10 November 2015

Para.33: Requests the Secretary-General to report to the Security Council within eleven months of the adoption of this resolution on the implementation of this resolution and on the situation with respect to piracy and armed robbery at sea off the coast of Somalia;

The report of the Secretary-General dated 7 October (S/2016/843) is before the Security Council.

**Somalia: Sanctions: Somalia/Eritrea Monitoring Group mandate review**

Resolution 2244 (2015) of 23 October 2015

Para.31: Decides to extend until 15 December 2016 the mandate of the Somalia and Eritrea Monitoring Group as set out in paragraph 13 of resolution 2060 (2012) and updated in paragraph 41 of resolution 2093 (2013), expresses its intention to review the mandate and take appropriate action regarding the further extension no later than 15 November 2016, and requests the Secretary-General to take the necessary administrative measures as expeditiously as possible to re-establish the Monitoring Group, in consultation with the Committee, until 15 December 2016, drawing, as appropriate, on the expertise of the members of the Monitoring Group established pursuant to previous resolutions;

The Monitoring Group's mandate is expected to be reviewed no later than 15 November 2016.

### **Somalia: Sanctions: Somalia/Eritrea Monitoring Group reports**

#### Resolution 2244 (2015) of 23 October 2015

Para.32: Requests the Monitoring Group to provide monthly updates to the Committee, and a comprehensive midterm update, as well as to submit, for the Security Council's consideration, through the Committee, two final reports; one focusing on Somalia, the other on Eritrea by 15 October 2016, covering all the tasks set out in paragraph 13 of resolution 2060 (2012) and updated in paragraph 41 of resolution 2093 (2013) and paragraph 15 of resolution 2182 (2014);

The letters from the Chair of the 751/1907 Committee dated 7 October (S/2016/919 and S/2016/920) is before the Security Council.

### **Somalia: Sanctions: 751/1907 Committee (Somalia/Eritrea) briefings to SC**

#### Resolution 1844 (2008) of 20 November 2008

Para.11: Decides further to expand the mandate of the Committee as set out in resolution 751(1992) to include the following tasks:

(g) to report at least every 120 days to the Security Council on its work and on the implementation of this resolution, with its observations and recommendations, in particular on ways to strengthen the effectiveness of the measures imposed by paragraphs 1, 3 and 7 above.

The Chair of the 751/1907 Committee is expected to brief the Security Council in November 2016.

### **Somalia: Sanctions: Emergency Relief Coordinator report**

#### Resolution 2244 (2015) of 23 October 2015

Para.24: Requests the Emergency Relief Coordinator to report to the Security Council by 15 October 2016 on the delivery of humanitarian assistance in Somalia and on any impediments to the delivery of humanitarian assistance in Somalia, and requests relevant United Nations agencies and humanitarian organizations having observer status with the United Nations General Assembly and their implementing partners that provide humanitarian assistance in Somalia to increase their cooperation and willingness to share information with the United Nations;

The letter from the Chair of the 751/1907 Committee dated 29 September 2016 (S/2016/827) is before the Security Council.

### **Somalia: Piracy: Authorizations for states and regional organizations in the fight against piracy and armed robbery at sea**

#### Resolution 2246 (2015) of 10 November 2015

Para.14: Encourages Member States to continue to cooperate with Somali authorities in the fight against piracy and armed robbery at sea, notes the primary role of Somali authorities in the fight against piracy and armed robbery at sea off the coast of Somalia, and decides that, for a further period of twelve months from the date of this resolution to renew the authorizations as set out in paragraph 10 of resolution 1846 (2008) and paragraph 6 of resolution 1851 (2008), as renewed by paragraph 7 of resolution 1897 (2009), paragraph 7 of resolution 1950 (2010), paragraph 9 of resolution 2020 (2011), paragraph 12 of resolution 2077 (2012), paragraph 12 of resolution 2125 (2013), and paragraph 13 of resolution 2184 (2014) granted to States and regional organizations cooperating with Somali authorities in the fight against piracy and armed robbery at sea off the coast of Somalia, for which advance notification has been provided by Somali authorities to the Secretary-General;

The authorisations will expire on 10 November 2016.

**Somalia: Sanctions: Partial lifting of arms embargo**

Resolution 2244 (2015) of 23 October 2015

Para.2: Decides to renew the provisions set out in paragraph 2 of resolution 2142 (2014) until 15 November 2016, and in that context reiterates that the arms embargo on Somalia shall not apply to deliveries of weapons, ammunition or military equipment or the provision of advice, assistance or training, intended solely for the development of the Security Forces of the FGS, to provide security for the Somali people, except in relation to deliveries of the items set out in the annex of resolution 2111 (2013);

The provisions set out in paragraph 2 of resolution 2142 (2014) will expire on 15 November 2016.

**Somalia: Authorization to inspect vessels bound to and from Somalia**

Resolution 2244 (2015) of 23 October 2014

Para.20: Expresses concern that the charcoal trade provides funding for Al-Shabaab, and in that context reiterates paragraphs 11 to 21 of resolution 2182 (2014), and further decides to renew the provisions set out in paragraph 15 of resolution 2182 (2014) until 15 November 2016;

The provisions set out in paragraph 15 of resolution 2182 (2014) will expire on 15 November 2016.

**South Sudan: Sanctions: Panel of Experts updates**

Resolution 2290 (2016) of 31 May 2016

Para.12: (d) Provide to the Council, after discussion with the Committee, an interim report by 1 December 2016, a final report by 1 May 2017, and except in the months when these reports are due, updates each month;

The update from the Panel of Experts is expected to be provided in November 2016.

**South Sudan: Sanctions: Panel of Experts report to SC on security threats facing the TGNU and the role of transfers of arms and related materiel**

Resolution 2290 (2016) of 31 May 2016

Para.12: (e) Also to provide to the Council a report within 120 days providing analysis of the current security threats facing the TGNU, and its needs to maintain law and order in South Sudan, as well as further analysis on the role of transfers of arms and related materiel coming into South Sudan since the formation of the TGNU with respect to implementation of the Agreement and threats to UNMISS and other UN and international humanitarian personnel;

The letter from the PoE Coordinator dated 19 September (S/2016/793) is before the Security Council.

**South Sudan: Sanctions: SC to monitor and review situation**

Resolution 2290 (2016) of 31 May 2016

Para.15: Expresses its intent to monitor and review the situation at 90-day intervals from the adoption of this resolution or more frequently, as needed, and invites the JMEC to share relevant information with the Council, as appropriate, on its assessment of the parties' implementation of the Agreement, adherence to the permanent ceasefire, and facilitation of humanitarian access, also expresses its intent to impose any sanctions that may be appropriate to respond to the situation, which may include an

arms embargo and the designation of senior individuals responsible for actions or policies that threaten the peace, security or stability of South Sudan, including by impeding the implementation of the Agreement, or by failing to take effective and comprehensive steps to cause forces under direct or indirect control to cease military operations, acts of violence, as well as human rights violations or abuses or violations of international humanitarian law, and to enable full access for humanitarian assistance;

The Security Council is expected to review the situation in November 2016.

**South Sudan: SG to provide detailed information on UNMISS force, impediments and obstructions**

Resolution 2304 (2016) of 12 August 2016

Para.16: Requests that the Secretary-General provide detailed information within 30 days on force generation, restructuring of the UNMISS force, logistical support and enablers, and civilian personnel to implement the mandate, as well as whether the Transitional Government of National Unity has maintained its consent in principle to deployment of the Regional Protection Force and not imposed any political or operational impediments to operationalizing the Regional Protection Force or obstructed UNMISS in the performance of its mandate, and requests the Secretary-General to review needs on the ground, and provide an updated assessment of the Regional Protection Force's operations, deployment, and future requirements, as well as any political or operational impediments to operationalizing the Regional Protection Force and obstructions to UNMISS in performance of its mandate, within 30 days after the adoption of this resolution, and every 30 days thereafter;

The report of the Secretary-General is expected to be issued in November 2016.

**South Sudan: SG report on implementation of the UNMISS mandate**

Resolution 2304 (2016) of 12 August 2016

Para.18: Requests the Secretary-General to report to the Council on implementation of the UNMISS mandate including UNMISS' Regional Protection Force, and to present the recommendations on the steps to adapt UNMISS to the situation on the ground and to increase efficiency of the implementation of its mandate in a comprehensive written report covering issues including strengthening safety and security of United Nations personnel and facilities to be submitted within 90 days of the date of adoption of this resolution, and further expresses its intention to consider the Secretary-General's recommendations within the context of the next UNMISS mandate extension;

The report of the Secretary-General is expected to be issued in November 2016.

**Sudan/South Sudan: SG to inform SC on status of compliance with resolution 2046 (2012)**

Resolution 2046 (2012) of 2 May 2012

Para.6: Requests the Secretary-General to consult with the African Union on the implementation of this resolution and the decisions of the AU PSC, to work closely with the AUHIP in support of its facilitation efforts, and to inform the Security Council within 15 days and in two week intervals thereafter on the status of compliance by Sudan, South Sudan, and the SPLM-N with the decisions set forth in this resolution, and expresses its intention, in the event that any or all of the parties have not complied with the decisions set forth in this resolution, to take appropriate additional measures under Article 41 of the Charter as necessary.

Note by the PSC of 11 November 2013 (S/2013/657)

Following consultations among the members of the Security Council, it has been agreed that issues pertaining to the Sudan and South Sudan, including the African Union/United Nations Hybrid Operation in Darfur (UNAMID), the United Nations Interim Security Force for Abyei (UNISFA), the United Nations Mission in South Sudan (UNMISS) and Council resolution 2046 (2012), will, as from 11 November 2013, be considered under the agenda item entitled "Reports of the Secretary-General on the Sudan and South Sudan". In addition, members of the Security Council agreed to amend the reporting period established in paragraph 6 of resolution 2046 (2012) to one-month intervals.

Note by the PSC of 21 August 2014 (S/2014/613)

Following consultations among the members of the Security Council, it has been agreed to amend the reporting period established in paragraph 6 of resolution 2046 (2012) and subsequently amended in a note by the President of the Security Council (S/2013/657) to three-month intervals.

The Secretary-General is expected to report to the Security Council in November 2016.

**Sudan/South Sudan: SG report on UNISFA**

Resolution 2287 (2016) of 12 May 2016

Para.27: Requests the Secretary-General to continue to inform the Council of progress in implementing UNISFA's mandate in one written report, no later than 15 October 2016, and continue to bring to the Council's immediate attention any serious violations of the above referenced Agreements;

The report of the Secretary-General dated 12 October (S/2016/864) is before the Security Council.

**Sudan: SG recommendations on what practical steps need to be taken by Sudanese parties with support of UNAMID to make tangible progress towards achieving benchmarks**

Resolution 2296 (2016) of 29 June 2016

Para.33: Takes note of ongoing consultations between the United Nations, the African Union and the Government of Sudan, notably in the frameworks of the Tripartite mechanism and the Joint Working Group, including discussion of operational and logistical issues pertaining to the mission's operation as well as the development of an exit strategy in accordance with the mission's benchmarks; requests the Secretary-General to make recommendations, within 120 days of the adoption of this resolution, including by building on any agreed recommendations of the Joint Working Group and undertakes to consider the Secretary-General's recommendations in due course, on what practical steps need to be taken by all Sudanese parties with the support of UNAMID in order to make tangible progress towards achieving the benchmarks;

The letter from the Secretary-General dated 28 October (S/2016/915) is before the Security Council.

**Sudan/South Sudan: UNISFA mandate**

Resolution 2287 (2016) of 12 May 2016

Para.1: Decides to extend until 15 November 2016 the mandate of the United Nations Interim Security Force for Abyei (UNISFA) as set out in paragraph 2 of resolution 1990 (2011) and modified by resolution 2024 (2011) and paragraph 1 of resolution 2075 (2012), and acting under Chapter VII of the Charter of the United Nations, further decides to extend until 15 November 2016 the tasks of UNISFA as set out in paragraph 3 of resolution 1990 (2011), and determines that for the purposes of paragraph 1 of resolution 2024 (2011), support to the operational activities of the JBVMM shall include support to the Ad Hoc Committees, as appropriate when so requested by consensual decisions of these mechanisms, within UNISFA's operational area and existing capabilities;

The mandate will expire on 15 November 2016.

## ASIA/MIDDLE EAST

### **Iraq: SG reports on UNAMI**

Resolution 2299 (2016) of 25 July 2016

Para.6: Requests the Secretary-General to report to the Council every three months on the progress made towards the fulfilment of all UNAMI's responsibilities;

The report of the Secretary-General dated 25 October (S/2016/897) is before the Security Council.

### **Iraq/Kuwait: missing persons and return of property**

Resolution 2107 (2013) of 27 June 2013

Para.4: requests that the Special Representative of the Secretary-General and Head of the United Nations Assistance Mission to Iraq (UNAMI) promote, support and facilitate efforts regarding the repatriation or return of all Kuwaiti and third country nationals or their remains, and the return of Kuwaiti property, including the national archives, seized by Iraq, further requests the Secretary-General to report separately to the Security Council on these matters in his reports on the progress made towards the fulfilment of all UNAMI's responsibilities...;

The report of the Secretary-General dated 21 October (S/2016/885) is before the Security Council.

### **Middle East (Lebanon/UNIFIL): SG reports on implementation of resolution 1701 (2006)**

Resolution 2305 (2016) of 30 August 2016

Para.13: Requests the Secretary-General to continue to report to the Council on the implementation of resolution 1701 (2006), every four months, or at any time as he deems appropriate;

The report of the Secretary-General is expected to be issued in November 2016.

### **Middle East (Syria): OPCW DG to report (through SG) on implementation of resolution 2118 (2013)**

Resolution 2118 (2013) of 27 September 2013

Para.12: "Decides to review on a regular basis the implementation in the Syrian Arab Republic of the decision of the OPCW Executive Council of 27 September 2013 and this resolution, and requests the Director-General of the OPCW to report to the Security Council, through the Secretary-General, who shall include relevant information on United Nations activities related to the implementation of this



resolution, within 30 days and every month thereafter, and requests further the Director-General of the OPCW and the Secretary-General to report in a coordinated manner, as needed, to the Security Council, non-compliance with this resolution or the OPCW Executive Council decision of 27 September 2013.”

The report of the OPCW is expected to be issued in November 2016.

**Middle East (Syria): Joint Investigative Mechanism mandate**

Resolution 2314 (2016) of 31 October 2016

Decides to renew the mandate of the Joint Investigative Mechanism, as set out in Resolution 2235, until 18 November 2016, and expresses its intention to consider a further extension before the expiration of this mandate;

The mandate will expire on 18 November 2016.

**Middle East (Syria): SG to report on implementation of resolutions 2139 (2014), 2165 (2014), 2191 (2014) and 2258 (2015)**

Resolution 2139 (2014) of 22 February 2014

Para.17: Requests the Secretary-General to report to the Council on the implementation of this resolution by all parties in Syria, in particular paragraphs 2 through 12, in 30 days of its adoption and every 30 days thereafter, and upon receipt of the Secretary-General’s report, expresses its intent to take further steps in the case of non-compliance with this resolution;

Resolution 2191 (2014) of 17 December 2014

Para.5: Requests the Secretary-General to report to the Council on the implementation of this resolution, and on compliance by all parties to the Syrian domestic conflict, within the framework of its reporting on resolutions 2139 (2014) and 2165 (2014);

Resolution 2258 (2015) of 22 December 2015

Para.5: Requests the Secretary-General to report to the Council on the implementation of this resolution, and on compliance by all relevant parties in Syria, within the framework of its reporting on resolutions 2139 (2014), 2165 (2014) and 2191 (2014), and further requests the Secretary-General to include in his reports overall trends in humanitarian access;

The report of the Secretary-General is expected to be issued in November 2016..

**Middle East (Syria): SG report on the implementation of resolution 2268 (2016)**

Resolution 2268 (2016) of 26 February 2016

Para.10: Requests the Secretary-General to report to the Council on the implementation of this resolution, including by drawing on information provided by the ISSG ceasefire taskforce, and on resolution 2254 (2015), within 15 days of the adoption of this resolution and every 30 days thereafter;

The Secretary-General is expected to report in November 2016.

**Middle East: The situation in the Middle East, including the Palestinian question**

Resolution 1322 (2000) of 7 October 2000

Para.7: Invites the Secretary-General to continue to follow the situation and to keep the Security Council informed.

## EUROPE

### **UNMIK: SG report**

Resolution 1244 (1999) of 10 June 1999

Para.20: Requests the Secretary-General to report to the Council at regular intervals on the implementation of this resolution, including reports from the leaderships of the international civil and security presences, the first reports to be submitted within 30 days of the adoption of this resolution.

The report of the Secretary-General dated 26 October (S/2016/901) is before the Security Council.

### **BiH: EUFOR ALTHEA mandate**

Resolution 2247 (2015) of 10 November 2015

Para.10: Authorizes the Member States acting through or in cooperation with the EU to establish for a further period of twelve months, starting from the date of the adoption of this resolution, a multinational stabilization force (EUFOR ALTHEA) as a legal successor to SFOR under unified command and control, which will fulfil its missions in relation to the implementation of Annex 1-A and Annex 2 of the Peace Agreement in cooperation with the NATO Headquarters presence in accordance with the arrangements agreed between NATO and the EU as communicated to the Security Council in their letters of 19 November 2004, which recognize that EUFOR ALTHEA will have the main peace stabilization role under the military aspects of the Peace Agreement;

The mandate will expire on 10 November 2016.

### **BiH: Reports of High Representative to SC thru SG**

Resolution 2183 (2014) of 11 November 2014

Para.20: Also requests the Secretary-General to continue to submit to the Council reports from the High Representative, in accordance with annex 10 of the Peace Agreement and the conclusions of the Peace Implementation Conference held in London on 4 and 5 December 1996 (S/1996/1012), and later Peace Implementation Conferences, on the implementation of the Peace Agreement and in particular on compliance by the parties with their commitments under that Agreement

The report is expected to be submitted in November 2016.

### **BiH: EUFOR ALTHEA/NATO reports to SC**

Resolution 2183 (2014) of 11 November 2014

Para.18: Requests the Member States acting through or in cooperation with the EU and the Member States acting through or in cooperation with NATO to report to the Council on the activity of EUFOR ALTHEA and NATO Headquarters presence respectively, through the appropriate channels and at least at six-monthly intervals;

### **BiH: Authorization of NATO Headquarters**

Resolution 2183 (2014) of 11 November 2014

Para.11: Welcomes the decision of NATO to continue to maintain a presence in Bosnia and Herzegovina in the form of a NATO Headquarters in order to continue to assist in implementing the Peace Agreement in conjunction with EUFOR ALTHEA and authorizes the Member States acting through or in cooperation with NATO to continue to maintain a NATO Headquarters as a legal successor to SFOR under unified command and control, which will fulfil its missions in relation to the implementation of annex 1-A and annex 2 of the Peace Agreement in cooperation with EUFOR ALTHEA in accordance with the arrangements agreed between NATO and the EU as communicated to the Security Council in their letters of 19 November 2004, which recognize that EUFOR ALTHEA will have the main peace stabilization role under the military aspects of the Peace Agreement;

Resolution 2247 (2015) of 10 November 2015

Para.4: Decides to renew the authorization provided by paragraph 11 of its resolution 2183 (2014) for a further period of twelve months starting from the date of adoption of this resolution;

The authorisation will expire on 10 November 2016.

## OTHER

### **Cooperation between UN and regional/subregional organizations: SG to include in regular reporting assessments of progress on the cooperation between the UN and relevant regional organizations**

Resolution 1809 (2008) of 16 April 2008

Para.17: Requests the Secretary-General to include in his regular reporting to the Security Council, assessments of progress on the cooperation between the United Nations and relevant regional organizations;

The report of the Secretary-General dated 15 July 2016 (S/2016/621) is before the Security Council.

### **Cooperation between UN and regional/subregional organizations: SG to present annual report to SC on ways to strengthen partnership between UN and AU**

S/PRST/2014/27 of 16 December 2014

Last para.: The Security Council requests the Secretary-General to present an annual report to the Security Council on ways to strengthen the partnership between the United Nations and the African Union on issues of peace and security in Africa including the work of the UNOAU.

The report of the Secretary-General dated 13 September 2016 (S/2016/780) is before the Security Council.

### **ICTY: Assessments by President/Prosecutor**

Resolution 1534 (2004) of 26 March 2004

Para.6: Requests each Tribunal to provide to the Council, by 31 May 2004 and every six months thereafter, assessments by its President and Prosecutor, setting out in detail the progress made towards implementation of the Completion Strategy of the Tribunal, explaining what measures have been taken to implement the Completion Strategy and what measures remain to be taken, including the transfer of cases involving intermediate and lower rank accused to competent national jurisdictions; and expresses the intention of the Council to meet with the President and Prosecutor of each Tribunal to discuss these assessments.

The assessments by the ICTY President/Prosecutor are expected to be issued in November 2016.

**Non-proliferation/DPRK: Sanctions: 1718 Committee reports**

Resolution 1718 (2006) of 14 October 2006

Para.12: Decides to establish, in accordance with rule 28 of its provisional rules of procedure, a Committee of the Security Council consisting of all the members of the Council, to undertake the following tasks:

(g) To report at least every 90 days to the Security Council on its work, with its observations and recommendations, in particular on ways to strengthen the effectiveness of the measures imposed by paragraph 8 above.

The Chair of the 1718 Committee is expected to report in November 2016.

**Peacekeeping operations: Report and recommendations on the progress of partnerships between the UN and relevant regional organizations in peacekeeping operations**

Resolution 2167 (2014) of 28 July 2014

Para.28: Requests the Secretary-General, in close consultation with the AU Commission and EU to produce, not later than 31 March 2015, an assessment report and recommendations on the progress of the partnerships between the UN and relevant regional organizations in peacekeeping operations;

The report of the Secretary-General dated 1 April 2015 (S/2015/229) is before the Security Council.

**Terrorism/Cross-border crime: SG report on UN efforts to address the threat of terrorists benefitting from transnational organized crime in affected regions**

Resolution 2195 (2014) of 19 December 2014

Para.20: Requests the Secretary-General to submit to the Council a report on the efforts of the United Nations entities to address the threat of terrorists benefitting from transnational organized crime in affected regions, including Africa, with respect to matters with which the Council is seized, with input from the relevant entities of the United Nations system including the UNODC, CTED, the Analytical Support and Sanctions Monitoring Team, and other relevant CTITF entities;

Para.21: Further requests that the report include recommendations of concrete options for strengthening Member States' capabilities, including financing such proposed UN projects and activities to build capacity with existing resources and contributions in the UN system, as well as UN activities to reduce the negative impacts of terrorists benefitting from transnational organized crime including those relevant to its conflict resolution efforts with a focus on border security, counter-terrorist financing, and anti-money-laundering, and that the report be submitted to the Council no later than six months from the adoption of this resolution;
