Developments concerning legislative measures taken by Iraq

1. The permanent Constitution was ratified by popular referendum on 15 October 2005 and published in the Iraqi Gazette, issue no. 4012 of 28 December A.D. 2005, corresponding to 27 Dhu'lqa'dah A.H. 1426. Article 9, paragraph 1 (e), provides that "the Iraqi Government shall respect and implement Iraq's international obligations regarding the non-proliferation, non-development, non-production, and non-use of nuclear, chemical and biological weapons and associated equipment, materiel, technologies and delivery systems for use in the development, manufacture, production and use of such weapons".

2. After approval by the National Assembly, the Presidency Council issued the Counter-Terrorism Law (Law No. 13 of 2005). Article 2 defines terrorist acts, and paragraph 7 addresses "the use for terrorist purposes of explosive or incendiary devices that are designed, or have the capability to cause death, or the propagation of terror among the people by means of an explosion or through the release, dissemination, detonation or planting of devices or objects of any kind or the impact of toxic chemicals, biological agents or similar substances, or radioactive materials or toxins".

Amendments and additions

All references to the Law of Administration for the State of Iraq for the Transitional Period of 8 March 2004, article 27 (e), should be deleted and replaced with references to the Constitution of the Republic of Iraq, article 9, paragraph 1 (e), which reads: "the Iraqi Government shall respect and implement Iraq's international obligations regarding the non-proliferation, non-development, non-production and non-use of nuclear, chemical and biological weapons and associated equipment, materiel, technologies and delivery systems for use in the development, manufacture, production and use of such weapons".
