Mr. Robinson joined the Jamaican Government Service in 1968. He worked as a Crown Counsel in the Office of the Director of Public Prosecutions (DPP) for three years and spent the rest of his career in the Attorney General's Department. While at the Director of Public Prosecutions Office, he prosecuted the first Extradition Case in independent Jamaica; he represented the Attorney General's Department in all extradition cases up to 1991. His work as a Crown Counsel in the DPP's Office included the preparation of Indictments and the prosecution of a wide range of criminal offences, including murder, robbery with aggravation and rape. He also represented the DPP in the Court of Appeal, and appeared in Jamaica's highest Court, the (UK) Privy Council. Mr. Robinson also prosecuted a court martial.

### Leader of Jamaican treaty-making negotiations

Mr. Robinson chaired Jamaican treaty-making negotiations in several areas of international law, including bilateral investment treaties, mutual legal assistance in criminal matters, extradition, maritime delimitation, arms trafficking and privileges and immunities.

### Other international law functions in Government service

From 1972 to 1998, Mr. Robinson worked as Adviser to the Ministry of Foreign Affairs and other Ministries on International Law and International Affairs. An

expert in the law of treaties, he was the leader of several Jamaican delegations in the negotiation of treaties in many areas of international law, including extradition, investment protection, environment, intellectual property, maritime delimitation, privileges and immunities and mutual assistance in criminal matters.

Mr. Robinson was very active in the Sixth (Legal) Committee of the United Nations General Assembly, where he was Jamaica's representative for 26 years. He played a leadership role on several items in the Committee, including Succession of States in relation to Treaties; the Definition of Aggression, Jurisdictional Immunity of States and their Property; the Status of the Diplomatic Courier; the Code of Crimes against the Peace and Security of Mankind and the United Nations Statute for an International Criminal Court.

Mr. Robinson was accredited as an Ambassador to the United Nations General Assembly in 1982, and served as Jamaica's representative on several United Nations bodies, including the United Nations Commission on International Trade Law (UNCITRAL) and the United Nations Commission on Transnational Corporations, of which he was the Chairman at the Commission's twelfth session in 1986. In 1985 Mr. Robinson, at the request of the United Nations Centre on Transnational Corporations (the Centre), prepared a paper on the position of developing countries in relation to a reference to international law in the Draft Code of Conduct for Transnational Corporations. He also, at the request of the Centre, prepared Guidelines for the Organization of Eastern Caribbean States in the negotiation of Bilateral Investment Treaties. In 1997, he chaired the UNCTAD Expert Meeting on Existing Agreements on Investment and Their Development Dimensions, and from 1999 to 2008, was a principal adviser to UNCTAD in the Review of Papers for its Series on International Investment Agreements.

As a member of the International Law Commission, Mr. Robinson made a substantial contribution to the codification and progressive development of international law in all areas of the Commission's work. As a member of the Commission's Working Group on the Statute of an International Criminal Court, Mr. Robinson was active in the successful and expeditious elaboration of a Statute which was adopted by the Commission in 1994 for presentation to the forty-ninth session of the United Nations General Assembly, and was the basis for the work of the United Nations Preparatory Committee in respect of the Statute of the International Criminal Court.

As a member of the Inter-American Commission from 1987 to 1995, and its Chairman in 1991, Mr. Robinson contributed to the development of a corpus of human rights law for the Inter-American System at a critical time in Latin America's history that witnessed the transition of many countries from military rule to democratic regimes; in particular, he worked to ensure a meaningful Caribbean contribution to the Commission's work. He also worked to ensure that the Inter-American Human Rights System benefited, as appropriate, from relevant features of civil and common law. Mr. Robinson represented the Commission in cases heard by the Inter-American Court of Human Rights.

In the course of a professional career of 26 years in international law while in the Jamaican Government service, Mr. Robinson represented Jamaica at many plenipotentiary conferences, including the Third United Nations Conference on the Law of the Sea, in which he made a significant contribution to the elaboration of the

provisions in the United Nations Convention on the Law of the Sea relating to Limits to National Jurisdiction.

Mr. Robinson worked extensively at the regional (OAS) and subregional (Caribbean) level in the field of international law. He participated in many conferences leading to the adoption of several OAS conventions, including those on Extradition, Mutual Legal Assistance in Criminal Matters, the Forced Disappearance of Persons, Corruption, and Illicit Traffic in Arms. He was Vice-President of the OAS Specialized Conference on the Inter-American Convention against Corruption. At the Caribbean level, he was involved in the negotiation that led to the adoption of the Treaty establishing the Caribbean Community and Common Market.

He was Jamaica's Legal Adviser in the negotiations that led to the Convention establishing the Association of Caribbean States.

Mr. Robinson contributed in a personal capacity to workshops and symposiums in several areas of international law, including the environment, maritime pollution, foreign investment, an international criminal court and the rights of indigenous peoples. He was a member of the UNEP Expert Group on International Environmental Law aiming at Sustainable Development.
