Recommendations of the Analytical Support and Sanctions Monitoring Team contained in its twenty-sixth report

1. On 26 June 2020, the twenty-sixth report of the Analytical Support and Sanctions Monitoring Team was submitted to the Committee pursuant to paragraph (a) of annex I to Security Council resolution [2368 \(2017\) \(S/2020/717\)](#). A table of recommendations based on the report was also circulated to the Committee on 30 June 2020, and the Committee deliberated on the table of recommendations on 15 July 2020. The Committee would like to express its gratitude to the Monitoring Team for the exemplary work undertaken in the fulfilment of its mandate.

2. Since December 2005, the Committee has established the practice of responding to each of the reports submitted to it by the Monitoring Team and bringing the Committee's position on the recommendations contained in these reports to the attention of the Security Council and the public.
