The President: Under rule 37 of the Council's provisional rules of procedure, I invite the representatives of Italy and Spain to participate in this meeting.

The Security Council will now begin its consideration of the item on its agenda.

Members of the Council have before them document S/2011/713, which contains the text of a draft resolution submitted by France, Germany, Italy, Nigeria, Portugal, the Russian Federation, Spain, the United Kingdom of Great Britain and Northern Ireland and the United States of America.

I wish to draw the attention of Council members to document S/2011/682, which contains the text of a letter dated 3 November 2011 from the Secretary-

General addressed to the President of the Security Council, transmitting the fortieth report of the High Representative for Bosnia and Herzegovina. I also wish to draw the attention of Council members to document S/2011/717, which contains the text of a letter dated 15 November 2011 from the Secretary-General addressed to the President of the Security Council, transmitting the twenty-sixth quarterly report on the activities of the European Union military mission in Bosnia and Herzegovina.

It is my understanding that the Council is ready to proceed to the vote on the draft resolution before it. I shall put the draft resolution to the vote now.
