Letter dated 11 March 2008 from the Secretary-General addressed to the President of the Security Council

I refer to the letter dated 29 February 2008 (S/2008/140) from the President of the Security Council requesting a comprehensive status report on the processing of letters of credit pertaining to the oil-for-food programme.

The Council will recall that at the meeting of the Working Group of representatives of the Government of Iraq, the Central Bank of Iraq and the Secretariat, held in Amman from 7 to 17 January 2008, it was reported that there were 210 outstanding letters of credit, as at 31 December 2007 (see S/2008/41). As shown in the attached note, I am pleased to report that the number of outstanding letters of credit has since decreased to 167. This number, however, still remains high. Moreover, I wish to inform the Council that since I last reported to the Council in January, the processing of the authentication documents by the Government of Iraq has remained slow. Given the uncertainty as to what progress will have been made by the end of March, I would recommend that the situation be reviewed by the Working Group early in May on the basis of results achieved as at 30 April 2008. If the Council agrees, I shall provide a further progress report in May, after a follow-up meeting of the Working Group.

In the light of the recent developments, an initial amount of \$100 million of the \$225 million held pending resolution of certain issues could be released and transferred to the Development Fund for Iraq pursuant to Security Council resolution 1483 (2003), subject to no objection by the Council. With respect to the unencumbered funds in the United Nations Iraq Account, I would recommend that the \$187 million held as a financial reserve continue to be held.

Note by the Secretary-General on the arrangements for the termination of operations relating to the letters of credit issued against the United Nations Iraq Account in the framework of the oil-for-food programme pursuant to Security Council resolution 1483 (2003)

I. Status of the United Nations Iraq Account

As at 29 February 2008, the United Nations Iraq Account contained the United States dollar equivalent amount of approximately \$1.023 billion, which is composed of €36 million in the euro sub-account with United States dollar equivalent of 799 million (at a rate of 1.5128) and \$228 million in the United States dollar account of the United Nations Iraq Account. Of this total amount, approximately \$605 million is held in the cash collateral portion of the account to cover expired letters of credit for which claims of delivery have been made. The remaining amount of approximately \$418 million is currently held in the non-collateral portion of the account and corresponds to the following amounts: (a) \$187 million which is being held in the account as a reserve for any unanticipated claims until such issues are resolved pursuant to paragraph 16 of the note attached to my letter to the President of the Security Council dated 10 July 2006 (S/2006/510); (b) \$225 million originally held in the account as collateral in respect of expired letters of credit, which funds have not been transferred to the Development Fund for Iraq pending the resolution of claims of delivery from suppliers in those cases where the Government of Iraq has not issued authentication documents pursuant to the notes attached to my letters to the President of the Security Council dated 25 July 2007 (S/2007/476), 7 December 2007 (S/2007/725) and 23 January 2008 (S/2008/41); and (c) any unrealized gains from the strengthening of the euro against the United States dollar.

II. Status of the letters of credit as at 29 February 2008

- 2. As at 29 February 2008, there were 167 outstanding letters of credit (see table 1 and annexes I, II and III for details) representing an aggregate amount of \$605 million.
- 3. It should be noted that the number of letters of credit decreased from 210 at the end of December 2007 to 167 at the end of February 2008. This decrease is mainly due to the letters of credit that were cancelled in January and February 2008 (see annex IV for details). It should also be noted that the number of letters of credit with claims of delivery has decreased from 164 (with a value of approximately \$175 million of claims of delivery) at the end of December 2007 to 148 (with a value of approximately \$264 million of claims of delivery) at the end of February 2008 (see tables 1.A and 1.B). The increase in the value of the claims is due in part to the new shipments made in December 2007 and the presentation of new documents to BNP Paribas by the beneficiaries of the letters of credit and in part to the strengthening of the euro in relation to the dollar for those letters of credit denominated in euros.
- 4. Despite the decrease in the number of letters of credit the processing of the confirmations of arrival by the Government of Iraq has been slow in January and February 2008. The commitment entered into by the concerned ministries at a

meeting with representatives of the Ministry of Foreign Affairs, the Central Bank of Iraq and the United Nations Secretariat (Working Group) has yet to be fulfilled. It may be recalled that I had informed the Council of the results of the Working Group in my letter of 23 January 2008 (S/2008/41).

- 5. The responsible authorities in Iraq are urged to process confirmations of arrival promptly so that payments can be made in accordance with the terms and conditions of the letters of credit. It should be reiterated that the processing of confirmations of arrival should not be delayed on account of, or be made contingent upon the resolution of, commercial disputes. As consistently noted by the Secretary-General, such disputes should instead be handled in accordance with the dispute resolution mechanism provided for in the underlying contract.
- 6. I urge the concerned ministries of Iraq and the Central Bank of Iraq to fulfil the commitments made by the Government of Iraq at the Working Group meeting in Amman as described in the note attached to my letter dated 23 January 2008 to the President of the Security Council.

III. Claims of delivery by suppliers and status of the Working Group meeting

7. As indicated in the letter dated 8 November 2007 from the President of the Security Council to the Secretary-General, the members of the Council expressed their ongoing concern with respect to the slow and non-provision of confirmations of arrival by the Government of Iraq and were also concerned that there were expired letters of credit for which there were claims of delivery from the suppliers.

- 8. Notwithstanding the continued calls from the Security Council and the Secretariat, the issuance of confirmations of arrival has been very slow and at times not forthcoming. Under existing procedures pursuant to Security Council resolution 986 (1995), payments cannot be made to suppliers who have delivered goods and services in Iraq without the receipt of the corresponding confirmations of arrival from the Central Bank of Iraq.
- 9. As a result of the meeting of the Working Group, the Government of Iraq had undertaken to take certain steps to resolve the claims of delivery for which shipments had been made on or before 31 December 2007. In order to terminate efficiently the operations of the letters of credit under the oil-for-food programme, the Working Group had agreed that the concerned ministries of Iraq will confirm delivery and issue and transmit the necessary confirmations of arrival to the Central Bank of Iraq following the session of the Working Group. If the confirmations of arrival were delivered to the Secretariat before 31 March 2008, payment under the respective letter of credit would be made by BNP Paribas.
- 10. Notwithstanding these efforts, the pace of the delivery of the confirmations of arrival from the Central Bank of Iraq to the United Nations Secretariat has not improved, as a result of which there are currently 148 letters of credit (see table 3) with an approximate value of \$264 million where the letters of credit have expired on or before 31 December 2007 but for which there are claims of delivery from the suppliers based upon documents pending with BNP Paribas.
- 11. The status of the letters of credit as at 29 February 2008 and updated information after the Working Group meeting in January 2008 is shown in tables 3 and 4.

- 12. It should be recalled that 17 letters of credit with claims of delivery were referred to in my letter to the President of the Security Council dated 25 July 2007 (S/2007/476). The Security Council requested the Secretariat to issue all necessary documentation to BNP Paribas for early settlement of the related payments associated with those letters of credit in the letter from the President of the Security Council dated 8 November 2007. As requested, the Secretariat had issued all the necessary documentation to BNP Paribas for the settlement of the 17 letters of credit referred to above. To date, BNP Paribas has paid the beneficiaries of nine letters of credit including those related to communication numbers 600882 (paid on 27 December 2007), 631025 (paid on 13 December 2007), 802679 (paid on 7 January 2008), 900032 (paid on 7 March 2008), 900045 (paid on 8 January 2008), 1000623 (paid on 17 December 2007), 1001817 (paid on 17 December 2007), 1100100 (paid on 8 January 2008) and 1300211 (paid on 28 December 2007). The payments related to eight letters of credit including communication numbers 601441, 601909, 800784, 802945, 901306, 1001636, 1100171 and 1200538 are currently being reviewed by the United Nations Secretariat or BNP Paribas for payment processing.
- 13. In an effort to move towards the termination of the operations relating to the letters of credit under the programme, the Secretariat has continued to regularly cancel letters of credit that have expired on their own terms with no claim of delivery asserted by the supplier. As a result of the activities of the Working Group, there were 57 letters of credit that were targeted for cancellation, of which 39 were cancelled subsequent to the meeting in Amman and one was paid in full (see annex IV). There are 17 letters of credit remaining targeted for cancellation, which are currently being evaluated by BNP and/or the United Nations Secretariat with a view to determining whether they could be cancelled and whether the associated cash collateral could be released from the collateral portion to the non-collateral portion of the United Nations Iraq Account.
- 14. To maximize the number of letters of credit to be cancelled, the Secretariat will continue its existing process of reviewing the expired letters of credit for which no claim of delivery has been made to determine whether a letter of credit could be cancelled and the associated cash collateral released from the collateral portion to the non-collateral portion of the United Nations Iraq Account. Such funds would in principle be available for transfer to the Development Fund for Iraq in accordance with Security Council resolution 1483 (2003).
- 15. With regard to the unresolved issues, the Government of Iraq committed itself to make every effort to settle outstanding issues in cooperation with the United Nations Secretariat in the first quarter of 2008. However, in the past month virtually no progress has been made in the delivery of the confirmations of arrival to the Secretariat. Therefore, I would propose that the situation be reviewed by the Working Group early in May on the basis of results achieved as at 30 April 2008. This would be followed by a meeting of the Working Group early in May and a report to the Council later that month.
- 16. I believe this would give time for the Government of Iraq and an opportunity to make every effort to resolve all issues and to settle outstanding issues in cooperation with the United Nations Secretariat.

17. However, should any issues remain unresolved as at 1 May 2008, the Security Council may wish to pay particular attention to the recommendation I made in paragraph 67 of the note contained in document S/2007/725.

IV. Release of cash collateral from the United Nations Iraq Account

- 18. It should be recalled that in my letter of 10 July 2006 to the President of the Security Council (S/2006/510), I indicated that, unless there was an objection from the Council, funds in the amount of \$187 million would be held in the United Nations Iraq Account as a reserve for any unanticipated claims from suppliers. This \$187 million reserve should continue to be maintained in the account. It is also recalled that in my letters of 25 July 2007 (S/2007/476) and 23 January 2008 (S/2008/41), I indicated that additional funds amounting to \$225 million would be retained pending resolution of the issue of claims of delivery from suppliers. The Council duly took note of this position.
- 19. Given the limited progress made so far in liquidation of the programme through the cancellation of certain letters of credit, the Secretary-General would intend, subject to no objection by the Council, to transfer to the Development Fund an initial tranche of \$100 million of the \$225 million of unencumbered funds held in the account referred to above, consistent with the provisions of Security Council resolution 1483 (2003).
